PG (MEDICAL) SPECIAL STRAY VACANCY ROUND UNDER MANAGEMENT QUOTA (MQ) SEATS - 2024-25

Notification for Online Registration for Admissions into Post Graduate Medical Degree/Diploma Courses against Special Stray Vacancy Round to be conducted by Dr. NTR UHS for the academic year 2024-25 in the State of A.P. under Management Quota Post Graduate Medical Degree / Diploma courses Private Un-aided Non-minority Medical Colleges affiliated to Dr. NTR UHS.

The Medical Counselling Committee (MCC), O/o DGHS, Govt. of India, New Delhi vide Notice No.U-12021/04/2024-MEC, Dated: 05-03-2025 notified the Special Stray Vacancy Round Schedule- 2024 for admissions into PG(Medical) Courses for the academic year 2024-25 duly extending the last date of admission as 20th March 2025.

In view of the above, Dr.NTR UHS invites **Online applications afresh** along with uploading of scanned original certificates from the eligible candidates for Admission into vacant seats of Post Graduate Medical Degree / Diploma Courses under Management Quota in MD/MS/Diploma Courses in Private unaided Non-Minority Medical Colleges in the State of Andhra Pradesh for the academic year 2024-25.

This notification is for online registration for Management Quota seats only. Candidates have to register separately for Competent Authority Quota seats in response to notification issued by NTRUHS for Competent Authority Quota online registration.

Important Note:

- 1. Candidates must join the seat allotted in this special stray round if seat is allotted, failing which candidates shall be debarred for one academic year i.e., 2025-26 for admissions into PG Medical Colleges in the State of Andhra Pradesh.
- 2. All the available vacancies of S1A & S1B seats are treated as S1 seats and all the candidates are eligible for all S1 seats as per Merit.

Number of vacant PG(Medical) seats for special stray vacancy round are as per the Annexure to this notification. Hence, Candidates are informed to check the available seats list before registration.

Security Deposit Amount:

- a) Many candidates were allotted seats under Management Quota, 2024-25 from Phase-III (Mop Up) Round of Counselling onwards but did not report in the allotted colleges which leads to blocking of seats.
- b) To avoid such type of blocking of seats, the Competent Authority has decided to collect a Refundable Security Deposit Amount of Rs.3,00,000/- (Rupees three lakhs only) through online mode from the candidates who are already found in the Consolidated Merit List of Management Quota and who wishes to participate in the ensuing **Special Stray Vacancy Round of Counselling** subject to the conditions that

- i. Refundable Security Deposit of candidates who do not join the seats allotted to them in Special Stray Vacancy Round or subsequent rounds, if any, will be forfeited and such candidates will be debarred from participating A.P. State Counselling for admission to PG (Medical) Courses under both Competent Authority Quota seats & Management Quota seats for the next academic year
- ii. If the candidate joins the allotted seat, the Security Deposit amount will be refunded to the candidate after closure of admissions.
- iii. If the candidate is not allotted seat, the Security Deposit amount will be refunded to the candidate after closure of admissions.
- iv. Also, the Security Deposit will be forfeited if the admission gets cancelled due to any reason. e.g. in case the candidate gives wrong information at the time of registration on the basis of which a seat may be allotted and later cancelled by the Admission Authorities at the time of reporting or fails to produce the required documents at the time of admission (within stipulated time)

Web Options:

Eligible candidates will have to exercise fresh web options for Special Stray Vacancy Round.

Candidates participating in Special Stray Vacancy Round will have to furnish an undertaking with respect to allotment of seats at the time of exercising web options as under:

"I agree to participate in the Special Stray Vacancy Round of Dr. NTRUHS. I affirm that, I am not holding any seat in the previous rounds of NEET PG Counselling, 2024 of All India Quota/State Quota.

I understand that these seats are precious in nature. Hence, if I am allotted a seat during the Special Stray Vacancy Round, I will join the allotted seat. If, due to any reason I do not join the allotted seat my refundable security deposit will be forfeited and any action including legal may be taken by the Competent Authority."

Who are eligible to apply for Special Stray Round Counselling:

> Candidates who are not allotted/holding any PG(Medical) seat either in All India Quota or State Quota are eligible to participate in this special stray round.

Who are not eligible to apply for Special Stray Round Counselling:

- ➤ Candidates who have been allotted any PG (Medical) seat in any Phase including Mop Up rounds and stray vacancy rounds conducted by Dr. NTRUHS for Competent Authority Quota (CQ) and Management Quota (MQ) are not eligible to participate in special stray vacancy round.
- > Candidate joined / holding any PG (Medical) seat under Dr. NTR UHS / All India Quota / Any Other States are not eligible for this special stray vacancy round.
- ➤ Phase-3 CQ & MQ Allotted candidates irrespective of their reporting status are not eligible to participate in the further phases of counselling of Dr NTRUHS.
- ➤ AIQ Stray/Special Stray round allotted candidates and allotted candidates of CQ/MQ stray rounds of Dr. NTRUHS / Stray round of Other States are not eligible for this special stray vacancy round.
- > CQ Special Stray Round allotted candidates will be blocked from participating in MQ Special Stray Round regardless of whether they applied or chose options in that round.

Note:

- 1. Registration fee paid will not be refunded under any circumstances.
- 2. Candidates who have already registered previously under Management Quota are not eligible to register again.

Certain Instruction to the students:

- 1. For complete details refer Prospectus placed in the website on 27-09-2024.
- 2. Mere applying under this notification does not confer any right to claim seat and the candidature is subject to availability of seats. Hence, the candidates are advised to take calculated decision before applying under this notification. Fee once paid shall not be refunded under any circumstances.
- 3. The online application can be filled through any **desktop or laptop** only.
- 4. Online application form without uploading mandatory Certificates, Passport size photo, signature, incomplete information will be automatically rejected and will not be considered for determining the Merit position in respective categories using NEET PG-2024 Rank.
- 5. If the information furnished by the candidate in the application is incorrect or false or found fake and enclosed forged certificates / documents, during the admission process or later, then the University will take action that deems fit as per rules against the candidate including cancellation of seat, in case already admitted, without any notice. Further action against such candidate will be taken by the University.
- 6. Registration along with uploading of Scanned Original certificates and exercising of web options will be permitted only once irrespective of the Number of counsellings. No separate notification will be given for verification of original certificates. Therefore, the candidates should register and upload all the mandatory Certificates without fail.
- 7. The Candidates are hereby informed that if they have secured admission in medical colleges of other States, joined the course and if they are involved in blocking of the seats in Dr. NTR UHS, the University will initiate legal action and same will be informed to the National Medical Commission for further course of action.
- 8. If the information furnished by the candidate in the application is incorrect or false or found fake and enclosed forged certificates / documents, during the admission process or later, then the University will take action that deems fit as per rules against the candidate including cancellation of seat, in case already admitted, without any notice. Further action against such candidate will be taken by the University.
