NOTIFICATION FOR EXERCISING WEB OPTIONS FOR PHASE-II COUNSELLING FOR BOTH IN-SERVICE AND NON-SERVICE CANDIDATES FOR ADMISSIONS INTO THE COMPETENT AUTHORITY QUOTA (CQ) SEATS OF POST-GRADUATE MEDICAL DEGREE/DIPLOMA COURSES AVAILABLE IN THE GOVERNMENT AND PRIVATE NON-MINORITY AND MINORITY MEDICAL COLLEGES AFFILIATED TO Dr. NTRUHS AND SVIMS, TIRUPATI FOR THE ACADEMIC YEAR 2025-26.

In continuation to this Office Notifications, dt.18-09-2025,27-09-2025,29-10-2025 & 29-11-2025 Dr. NTR UHS, Vijayawada hereby notifies the schedule for exercising Web Options for Phase-II of counselling for both **In-Service and Non-service candidates** for admissions into Competent Authority Quota (CQ) PG Medical Degree/Diploma courses available in the Government and Private Non-Minority and Minority Medical Colleges under Dr. NTR UHS and SVIMS, Tirupati for the academic year 2025-26.

- **Competent Authority (Self-financing) seats and Competent Authority (NRI Category) seats in new five (5) Government Medical Colleges permitted from the academic Year 2023-24 onwards**

P.G seats in the Government Medical Colleges established/permitted from the Academic Year 2023-24 onwards as follows:

- I. 50% of seats in each New Government Medical College shall be allocated to All India Quota.
- II. Out of the remaining 50% seats of State Quota, 50% of the seats are categorized as Competent Authority (General Category), 35% of the seats as Competent Authority (Self finance) and 15% of the seats as Competent Authority (NRI Category).

UNIVERSITY FEE: Selected Candidates have to login and to pay the University fee of ₹.23,600/- for downloading the Allotment Order by using Online payment method (Debit Card/Credit Card/Internet Banking). Candidates already paid in Phase-I need not pay again

Instructions to Candidates:

1	Seat Matrix for Enhanced/Newly permitted Seats in Private and New Govt. Medical Colleges of Phase-II is displayed in the University Website https://drntr.uhsap.in for information of the students. All the eligible candidates present in the Final Merit list displayed on 15-11-2025 and subsequent corrigendum if any are eligible to opt for Phase-II.
2	Newly sanctioned/enhanced seats as per NMC Notice, if any will be filled in Phase-III (Mop Up) counselling subject to receipt of Affiliation orders.
3	<p>Candidates are advised to go through the Prospectus (placed in the University website on 18-09-2025) and the Government Orders on Rules of PG admissions available before exercising web options. Candidates are also advised to go through the details about “MRC” concept which is exemplified below:</p> <p>Example:</p> <p>a) In a particular college MD(RD) seat is under “Open Category” in the seat matrix and a SC candidate is allotted that Open Category MD(RD) seat in Open Round Counselling of Phase-I as per his/her web options and NEET Rank merit order of the candidate. Now this candidate is shown as Meritorious Reserved Candidate (MRC).</p> <p>b) The same SC candidate has slid to MD (General Medicine) SC category seat in the same college or another college during the Category Round of Phase-I Counselling conducted on the same day, then that MD(RD) seat vacated by this MRC candidate shall be filled with the SC candidates only by merit amongst them.</p> <p>c) This type of MRC concept is to be followed for all BC/SC/ST categories in order to maintain 50 : 50 ratio of Open : Category Reservation</p> <p>d) G.Os governing MRC and other regulations:</p> <p>1. 4	<p>Filling up of PG (Medical) Seats in Siddhartha Medical College, Vijayawada for the academic year 2025-26:</p> <p>The Government of Andhra Pradesh vide G.O.Rt.No.475, HM&FW (C1) Dept., dt.22-07-2025 ordered “to continue Siddhartha Medical College, Vijayawada as a State wide Educational Institution and admissions to 85% of the available seats (after deducting All India Quota seats) shall be divided between local candidates of Andhra University and Sri Venkateswara University regions in the ratio of 65.62% and 34.38%, with the remaining 15% treated as unreserved.</p> <p>The definition of local candidates and eligibility in respect of 85% local seats and 15% unreserved seats shall be as per respective admission rules of Undergraduate Medical and Postgraduate Medical courses applicable to Government Professional Institutions.”</p>
5	As per the year 2024-25 Notifications for Stray/Special Stray rounds of CQ/MQ counsellings, candidates who participated in Stray/Special Stray rounds of CQ/MQ counsellings conducted for the year 2024-25 and allotted seats but not reported/joined are debarred for admissions into CQ/MQ counsellings for the year 2025-26 (List of debarred candidates displayed on the University website).
6	As per G.O.Ms.No.67. dt.21-04-2017, the candidates who have discontinued the course from the academic year 2022-23 irrespective of their admission batch will be debarred for this academic year i.e., 2025-26 (List of debarred candidates displayed on the University website).
7	Candidates opting for Medical Degree/Diploma courses are informed that, there is no limit of choices (number) for exercising web options. Candidates can exercise any number of options for any number of specialities and colleges available. Mere exercising of web options does not confer any right for allotment of seat, it is subject to availability of seat as per the Seat Matrix.
8	Candidates are instructed to be careful while exercising options on the Web and take the print out of the saved options. Candidates are advised to exercise options in Courses and colleges in which they are genuinely interested. If they are not interested to join any speciality or college then they are advised not exercise options for the same and avoid seat blocking.
9	The Eligible PwBD candidates can exercise web options only for the specialties recommended by the Medical Board, as notified in the PwBD candidates Eligible & Not Eligible list, displayed on University website on 15-11-2025.
10	The selected candidates have to login and to pay the University fee of ₹.23,600/- for downloading the Allotment Order by using Online payment method (Debit Card/Credit Card/Internet Banking) and report to the Principal of the Allotted College on or before the date specified in the allotment letter. University fee once paid is not refundable under any circumstances.
11	The selected candidates shall produce all the Original certificates, pay the Tuition fee, furnish necessary bonds etc., and complete the process of admission. If the candidate does not fulfil the criteria as per regulations to complete the admission process in the specified dates of admission, their admission will be cancelled automatically.
12	The verification of original certificates will be conducted at the time of admission in the respective College and in case of any discrepancy, the Provisional allotment will be cancelled and action will be initiated. If the candidate slides to other college (i.e., affiliated colleges of Dr.NTR UHS) during subsequent Phases of counselling the tuition fee will be sent to the slided college by the concerned college where the amount is held.
13	<p>Eligibility for Exercising web options in Phase-II Counselling:</p> <p>The following candidates are eligible:</p> <ol style="list-style-type: none"> All the candidates who have been allotted a seat in Phase-I and reported. All the candidates who have not been allotted any seat in Phase-I counselling. All candidates who have been allotted a seat in Phase-I but not reported at the allotted colleges and candidates who availed FREE EXIT from Phase-I. However, if a candidate has not joined/resigned in Phase-I then that particular seat allotted in Phase-I shall not be available for that candidate to exercise web options in Phase-II counselling. Phase-I joined/reported seat shall be the default last option The Joined candidates of Phase-I/Phase-II Counselling are eligible for upgradation up to Phase-III (Mop Up) round only.
14	Candidates who have reported the allotted seat of Phase-I and/or Phase-II can opt for free exit as per the schedule which will be notified.

15	<p>Eligibility for Exercising web options in Phase-III (Mop Up) Counselling</p> <p>The following candidates are eligible:</p> <ol style="list-style-type: none"> The Competent Authority has decided to collect a Refundable Security Deposit Amount of ₹.50,000/- (Rupees fifty thousand only) through online mode from the candidates who wishes to participate in Phase-III (Mop Up) and subsequent Phases of Counselling to avoid seat blocking. Other details will be notified in the Web Option notification of that Phase. All the candidates who have been allotted and reported to the Phase-I/Phase-II seat. All the candidates who have not been allotted any seat in Phase-I/Phase-II counselling. All candidates who have been allotted a seat in Phase-I/Phase-II <ol style="list-style-type: none"> but not reported/not joined at the allotted colleges. Joined but resigned from the allotted seat as per University Notifications for free exit. <p>However, if a candidate has not joined/reported in the allotted seat of Phase-I/Phase-II or resigned from the joined seat of Phase-I/Phase-II, then that particular seat shall not be available for that candidate to exercise web options in Phase-III/Mop Up counselling.</p> Phase-I /II joined/reported seat shall be the default last option. Candidates getting upgraded in Phase-III Shall NOT have any claim on Phase-I/Phase-II seat of CQ & MQ The Joined candidates who are holding a seat in Phase-I or Phase-II or Phase-III(Mop Up) Counselling are not eligible for Stray or any further rounds. Candidates allotted a seat in Phase III (Mop-Up) cannot participate in subsequent rounds of State Counselling including Management Quota Counselling, regardless of whether they report to the allotted college. All the joined candidates of AIQ up to Round 3 counselling will be blocked for State Phase-III/Mop UP and Stray counselling of both CQ & MQ even if they have exercised web options. Candidates allotted/upgraded in CQ Phase-III irrespective of their reporting status will be blocked from participating in MQ Phase-III counselling, even though if they have exercised web options. A candidate holding a MQ seat is allotted a seat under CQ in Phase-III, they must compulsorily report. The previously held MQ seat (if any) from Phase-I/Phase-II will automatically be vacated, regardless of whether the candidate reports to the new CQ seat in Phase-III. The vacated MQ seat will be made available for allocation during MQ Phase-III Counselling. If a candidate is allotted a seat in Phase-III, he/she has to compulsorily report & join the allotted seat/college else the Security Deposit amount of ₹.50,000/- will be forfeited and he/she cannot participate in further rounds of counselling. Candidates allotted/upgraded under CQ in Phase-III shall not have any claim on the seat held in Phase-I/Phase-II either in CQ or MQ. PwBD Conversions will be done as per rules in Phase-III Counselling (G.O.Ms.No.44 dated 25.02.2005). General Conversions will be done as per rules. MCC of DGHS will share the data of joined candidates in Round 1, Round 2, Round 3 counselling with all the participating States. Similarly, the participating States will also share the data of joined candidates. Candidates who have joined up to Round 3 of MCC counselling and also the allotted candidates of Stray Vacancy round of MCC counselling will be filtered and weeded out before processing for Stray Vacancy round of counselling of AP State. As per MCC counselling Scheme 2025, the joined candidates up to Round 3 of MCC counselling cannot upgrade or resign after Round 3. If any candidate is allotted seat in Round 3 of AIQ/Deemed/Central Quota such candidates cannot participate in Phase-III (Mop Up) or subsequent phases of State Counselling.

16	As per G.O.Ms.No.67, dt.21-04-2017 in the final phase of final counselling, A candidate who exercised web options and joined in an allotted seat shall not be permitted to withdraw from the seat. In case any candidate withdraws from the allotted seat, the candidate shall be debarred for a period of three years for admission into Post Graduate Dental Degree/Diploma courses at the colleges in the State of Andhra Pradesh besides payment of Rs. 3,00,000/-.
17	All the allotments will be subject to the final orders of pending writ petitions if any.
18	The University fee and other fee once paid shall not be refunded under any circumstances.
