NOTICE TO THE CANDIDATES FOR SPECIAL STRAY VACANCY ROUND OF
WEB-BASED COUNSELING FOR ADMISSION INTO BDS COURSE UNDER
MANAGEMENT QUOTA SEATS FOR THE ACADEMIC YEAR 2024-25

Keeping in view of the NEET-UG Special Round Schedule- 2024 notified on 16.11.2024 by the Medical Counselling Committee (MCC), O/o DGHS, Ministry of Health & Family Welfare Dept., Govt. of India, the Competent Authority for admissions under State Quota has decided **to conduct Special Stray Vacancy Round of web-based Counselling for admission into BDS Course under the Management Quota seats** for the academic year 2024-25 duly implementing the rules as applicable to Stray Vacancy Round.

In view of the above and in exercise of powers conferred under the Regulation of Admissions into Under Graduate Medical & Dental Professional Courses applicable to Un-aided Minority / Non-Minority Professional Institutions in the State of Andhra Pradesh, the Competent Authority hereby notify the following schedule and rules in connection with **Special Stray Vacancy Round of web-based Counselling for the available vacancies due to non-joining of allotted candidates after Phase-III for admission into BDS Course under the Management Quota seats** for the academic year 2024-25:-

Security Deposit Amount:

- a) Many candidates were allotted seats under Management Quota, 2024-25 during Phase-III but did not report in the allotted colleges which lead to blocking of seats.
- b) To avoid such type of blocking of seats, the Competent Authority has decided to collect a **Refundable Security Deposit Amount of Rs.2,00,000/- (Rupees two lakhs only)** through online mode from the candidates who are already found in the Merit List of Management Quota and who wishes to participate in the ensuing with **Special Stray Vacancy Round of Counselling** subject to the conditions that
 - i. Candidates who have already paid Refundable Security Deposit Amount Rs.3.00,000/- for MBBS course under Special Stray Vacancy Round are eligible to opt for BDS course under this Notification without additional **Refundable Security Deposit Payment for BDS Course**.
 - ii. Candidates who are willing to participate in Special Stray Vacancy Round of only BDS Course need to pay Rs.2,00,000/-
 - iii. Refundable Security Deposit of candidates who do not join the seats allotted to them in Special Stray Vacancy Round or subsequent rounds, if any, will be forfeited.
 - iv. If the candidate joins the allotted seat, the Security Deposit amount will be refunded to the candidate after closure of admissions.
 - v. If the candidate is not allotted seat, the Security Deposit amount will be refunded to the candidate after closure of admissions.
 - vi. Also, the Security Deposit will be forfeited if the admission gets cancelled due to any reason. e.g. in case the candidate gives wrong information at the time of registration on the basis of which a seat may be allotted and later cancelled by the Admission Authorities at the time of reporting or fails to produce the required documents at the time of admission (within stipulated time).

Web Options:

Eligible candidates will have to exercise fresh web options for Special Stray Vacancy Round as per the seat matrix displayed in the University website. Web options exercised earlier including for BDS MQ Stray Round will be treated as 'Null & Void'.

Candidates participating in Special Stray Vacancy Round will have to furnish an undertaking with respect to allotment of seats at the time of exercising web options as under:

"I agree to participate in the Special Stray Vacancy Round of Dr. NTRUHS. I affirm that I am not holding any seat in the previous rounds of NEET UG Counselling, 2024 of All India Quota/State Quota.

I understand that these seats are precious in nature. Hence, if I am allotted a seat during the Special Stray Vacancy Round, I will join the allotted seat. If, due to any reason I do not join the allotted seat my refundable security deposit will be forfeited and any action including legal may be taken by the Competent Authority."

GENERAL INSTRUCTIONS:

1. Eligible Candidates

- No Fresh registration will be allowed for Special Stray Vacancy Round.
- Eligible candidates who are already found in the Final Merit Position under Management Quota displayed on 15-09-2024 and 02.11.2024 are eligible to participate in the Special Stray Vacancy Round, provided that the candidates should not hold any seat in the previous phases of Counselling of All India Quota / State Quota / Deemed University.
- Eligible candidates have to exercise web options for Stray Vacancy Round as per the Schedule notified as per their priorities Category-wise (Cat-B / Cat-C(NRI)) and College-wise. The allotments will be as per the prioritized options exercised by the candidates.

2. Not Eligible Candidates:

- a. Candidate who is not found in the Final Merit List of Management Quota of Dr. NTR University of Health Sciences, A.P., Vijayawada
 - b. Candidates already allotted and joined a seat (MBBS / BDS) in All India Quota / State Counselling/ Deemed University.
 - c. Candidates who have been allotted seats (MBBS/BDS) by Dr. NTRUHS in Phase-III of Dr. NTRUHS Counselling (both CQ & MQ)
 - d. Candidates who have been allotted seats (MBBS/BDS) by Dr. NTRUHS in Stray Vacancy Round of Dr. NTRUHS Counselling (both CQ & MQ).
 - e. Candidates who have been allotted seats in MBBS under Special Stray Vacancy Round of Dr. NTRUHS Counselling (both CQ & MQ).
 - f. Candidates found in the list shared by Medical Counselling Committee (MCC) after Special Stray Vacancy Round.
3. Candidates will receive the message regarding allotment of seats, if seat is allotted.
 4. Candidates who are allotted seat under Special Stray Vacancy Round of counselling have to report to the allotted college **COMPULSORILY** with all original certificates, provisional allotment order, copy of final application and pay the tuition fee, college fee, such candidate cannot resign the seat allotted.
 5. The University fee once paid shall not be refunded / adjusted to future date under any circumstances.
 6. Dr. NTR University of Health Sciences does not entertain or support seat blocking / cancellation of BDS seats.
 7. In case any student is involved in seat blocking, legal action will be initiated against such candidate as per rules.
 8. Decision of the Competent Authority is final in all aspects.
