Admissions into PG AYUSH - MD (Homoeo) & MD/MS (Ayurveda) Courses under Competent Authority Quota (CQ) seats for the academic year 2024-2025 in the State of A.P.

Inviting online application forms and Uploading of Original scanned documents for Verification.

Vide letters dated.11th & 12th Nov, 2024, National Commission for Homoeopathy (NCH) & National Commission for Indian System of Medicine (NCISM), Ministry of AYUSH, Govt. of India New Delhi notified that the minimum qualifying percentile criteria of AIAPGET-2024 is reduced by <u>Fifteen percentile across all categories</u> for admission into PG ASU i.e., MD (Homoeo) & MD/MS (Ayurveda) courses for the Academic year 2024-25.

In view of the above reduction in the minimum qualifying cut-off scores in AIAPGET-2024 for admission into PG AYUSH Courses, <u>fresh applications</u> are invited from the candidates who fulfill the eligibility criteria as notified in the Prospectus (displayed on <u>16.10.2024</u>) for admissions into the PG AYUSH i.e., MD (Homoeo) & MD/MS (Ayurveda) Courses under Competent Authority Quota of Dr.NTR UHS for the academic year 2024-25. Other conditions as detailed in Prospectus, dated:16.10.2024 remains same.
