- The Application submitted for Competent Authority (Convenor) Quota seats **WILL NOT BE** considered for Management Quota seats.
- The online application must be filled from a desktop or laptop with internet connection.
- The Application and Processing fee including verification fee including late fees, if any once paid will not be refunded or adjusted to a further date. **The fee is non-refundable. Hence, interested candidates are advised to check their eligibility before applying.**
- Online application form without uploading mandatory Certificates, Passport size photo, signature, incomplete information will be automatically rejected and will not be considered for determining the Merit position in respective categories using NEET-UG-2025 Rank.
- The mere fact that the Merit position issued to the candidate does not imply that the candidature is accepted by the University and it does not mean that the entries made by the candidate in the online application are accepted as true and correct.
- If the information furnished by the candidate in the application is incorrect or false or found fake and enclosed forged certificates / documents, during the admission process or later, then the University will take action that deems fit as per rules against the candidate including cancellation of seat, in case already admitted, without any notice. Further action against such candidate will be taken by the University.
- An in-eligible candidate obtaining Merit position does not make the candidate eligible for admission.
- Candidates will receive the message regarding allotment of seats, if seat is allotted.
- University Fee:** The selected candidates have to download the allotment order by paying the University fee of Rs.65,600/- through Payment Gateway by using online payment method. (Debit Card/Credit Card/Internet Banking) and report to the Principal of allotted college **COMPULSORILY** along with the allotment order and original certificates before the date specified in the allotment order and pay the prescribed tuition fee at college, such candidate cannot resign the seat allotted
