Admissions into Post Graduate Medical Degree/Diploma Courses under **Competent Authority Quota seats** for the academic year **2025-26** in the State of A.P.

Inviting online application forms and Uploading of Original scanned documents for Verification.

Note: The candidates of other States are not eligible for the Competent Authority Quota seats if they do not satisfy Local status/Non-Local status as per G.O.P.NO. 646, Education (W) Department, Dated 10th July, 1979 of Government of Andhra Pradesh (Presidential Order) and as per G.O.Ms.No.83, HM & FW (C1) Dept., dt. 23-07-2025 of Govt. of Andhra Pradesh.

Online Application forms are invited from the eligible candidates for admissions into Post Graduate Medical Degree/Diploma courses in Government and un-aided Private Non-Minority & Minority Medical Colleges under Competent Authority Quota seats for the academic year 2025-26 in the colleges affiliated to Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh and Sri Venkateswara Institute of Medical Sciences (SVIMS), Tirupati.

- 2. Candidates are advised to visit the University website for all further notifications/latest updates/circulars/allotments on PG (Medical) Admissions till the closure of admissions. No individual communications will be sent.
- 3. Online applications are invited from eligible In-service candidates as per G.O.Ms.No.85, HM&FW (C1) Dept., dt.20-07-2024 & G.O.Ms.No.99, HM&FW (C1) Dept., dt.18-08-2025, Govt. of A.P for admission into service quota seats in PG (Medical) Courses from the academic year 2025-26 and subject to any modifications as notified by the Government from time to time and court directions if any,
- 4. Service rendered up to 16-04-2025 shall be considered for considering candidates under In-service Quota seats.
- 5. Service candidates should not have completed 50 years as on 16-04-2025. Candidates born on or before 16-04-1975 are not eligible for In-service quota seats only.
- 6. As per Memo No.2459247/C1/2024, HM&FW (C1) Dept., dt.20-07-2024 of Govt. of A.P., it is hereby clarified that all the 15% of the Unreserved seats in Medical/Dental colleges are now reserved exclusively for the Local candidates from the Andhra and Rayalaseema regions.
- 7. As per G.O.Ms.No.83, dt. 23-07-2025 of HM & FW (C1) Dept., Govt. of A.P the admission to 85% of the seats in each course in non-state wide institutions shall be reserved for the local candidates of Andhra Pradesh and the remaining 15% of the seats shall be un-reserved seats for the candidates of local/non local areas.

8. Filling up of PG (Medical) Seats in Siddhartha Medical College, Vijayawada for the academic year 2025-26:

The Government of Andhra Pradesh vide G.O.Rt.No.475, HM&FW (C1) Dept., dt.22-07-2025 ordered "to continue Siddhartha Medical College, Vijayawada as a State wide Educational Institution and admissions to 85% of the available seats (after deducting All India Quota seats) shall be divided between local candidates of Andhra University and Sri Venkateswara University regions in the ratio of 65.62% and 34.38%, with the remaining 15% treated as unreserved.

The definition of local candidates and eligibility in respect of 85% local seats and 15% unreserved seats shall be as per respective admission rules of Undergraduate Medical and Postgraduate Medical courses applicable to Government Professional Institutions."

- 9. As per Memo No.2832690/C1/2025, dt.15-07-2025 of HM&FW (C1) Dept., Govt. of AP the Caste certificates issued by the Government of A.P will only be considered for admissions.
 - ➤ Latest Permanent caste certificate (issued by Competent Authority of Govt. of Andhra Pradesh only). Caste certificates of other States will not be accepted & in such cases the applied candidate will be considered under General category only.
