Re-Inviting Online applications and Uploading of Original scanned documents for Verification **with Late fee**

In response to the NEET-PG 2024 schedule announced by the Medical Counselling Committee (MCC), New Delhi, on November 1st, 2024, and the upcoming State Counselling phase from November 18th to 27th, 2024, and in compliance with recent judicial directives from the Hon'ble High Court of Andhra Pradesh for candidates who sought legal intervention to be considered for admission after original application deadline, the University is issuing this notification under Management Quota for submission of online application with late fee of ₹.20000/- (inclusive of 18% GST).

- Candidates who could not apply earlier can now apply in response to this notification.
