GENERAL INSTRUCTIONS:

- ❖ All candidates should read the prospectus thoroughly before starting choice filling.
- ❖ Candidates should be careful while choice filling and it is advisable to choose preferred colleges only.
- ❖ Vacancy Position for the Course will be available on the official websites.
- ❖ Selection committee does not take responsibility for any Connectivity error.
- ❖ Registered and choice locked candidates in Mop- Up round are only eligible to participate in Stray vacancy round. The Choices exercised by the candidates during Mop-Up round will be considered as their choices for Mop- Up as well as Stray Vacancy round. Hence candidates who wish to participate in stray vacancy round are advised to register and lock their choices in mop-up round.
- ❖ **Note:** If a candidate is getting a **seat in** MBBS/BDS course in Mop-up of **Government Quota** counselling, he/she **will not be allotted a seat in Mop-up of Management/ Minority/ NRI Lapsed Quota** counselling. Candidates are instructed to be very vigilant before locking their choices, during Mop-up of Govt. Quota Counselling.
- ❖ Once the candidate locks his/her choice(s) during the online counselling, it cannot be changed later.

AVAILABLE SEATS FOR MOP-UP:

- ❖ Non-allotted seats after Round-II of Counselling.
- ❖ Seats vacant due to not joining / discontinuation by candidate(s) allotted after Round-II (incl. Revised Round- II) of Counselling.

ELIGIBLE CANDIDATES FOR MOP-UP:

- ❖ As per the prospectus clause 14 IV-(b), a Candidate **not holding** any MBBS/BDS seats under All India Quota and State Quota (Government / Management/ NRI) will be allowed to participate in State Quota Mop-up counselling.

- ❖ The candidates who participated in Round- I and Round –II (incl. Revised Round- II) but not- allotted any seats are eligible to State Quota Mop-up counselling.
- ❖ The candidates who were allotted a seat in Round- I and Not-joined/ Resigned the seat before 16.11.2022 @ 3:00 P.M. and also Participated in Round- II (incl. Revised Round- II) but not-allotted any seat are eligible to State Quota Mop-up counselling.
- ❖ The candidates who were allotted a seat in Round- I and Not-joined/ Resigned seat before 16.11.2022 @ 3:00 P.M. and also Not Participated in Round- II (incl. Revised Round- II) are eligible to State Quota Mop-up counselling).

NOT ELIGIBLE CANDIDATES FOR MOP-UP:

- ❖ As per DGHS notification Ref. U-12021/ 01/ 2022 -MEC dated 12.07.2022, a candidate joined under All India Quota or State Quota in the previous rounds will not be allowed to State Quota Mop-up counselling.
- ❖ As per the prospectus clause 14 III-(g), if the candidate discontinues/ Not-joined the course after completion of Round-II of online counselling, he/she will not be eligible to attend the subsequent (Mop-Up) round of online counselling.
- ❖ As per the prospectus clause 14 II-(b), a candidate who has not registered in the first round of online counseling will not be permitted to attend the Subsequent (MOP-UP) round of online counselling.
- ❖ Candidates whose names are in the allotted list provided by MCC at the end of Mop-up Round.

INSTRUCTION FOR SELECTED CANDIDATES:

- ❖ If a candidate is allotted during State Mop-Up round, he/she will have to join the allotted college. Allotted candidates during Mop-Up round will not be eligible for Subsequent State (Selection committee) online stray Vacancy round.

- ❖ The candidates who have been allotted but not-joined the course will have to forfeit the Processing Fee / Security Deposit & Tuition Fee and also have to pay the penalty fee as per the prospectus clause 14 IV (f).

INSTRUCTIONS FOR DOWNLOADING ALLOTMENT ORDER:

- ❖ Fee structure is available in the official website www.tnhealth.tn.gov.in and www.tnmedicalselection.org.
- ❖ The Selected candidate has to pay non-refundable amount of Tuition Fee for downloading the allotment order through online via Debit Card / Credit Card/Net Banking or RTGS.
- ❖ All candidates should make sure, sufficient transaction limit is available for their fee payment before remitting their Payment.
- ❖ The allotted candidates should download their provisional allotment order and join the course in the concerned Medical College/Institution on or before the stipulated date and time as mentioned in the Provisional Allotment Order.

REPORTING TO ALLOTTED COLLEGE:

- ❖ The candidates should produce their following **ORIGINAL CERTIFICATES** in person at the time of joining in their selected Colleges along with the scanned copy of original certificates, for certificate verification.

- ❖ If you do not report to the Head of the Institution to which you are allotted on or before the time and date specified in the provisional allotment order, your selection and / or admission will stand cancelled without any further notice.
- ❖ The Candidate selected for admission should give a self-declaration form at the time of the reporting to the concerned College that he/she is liable for forfeiture of selection / admission if suppression of facts, mis-interpretation found at any time during or after the admission to the course.
