#### **AVAILABLE SEATS FOR ROUND-2:**

- Seats not allotted during Round-1
- Seats vacant due to not joining / resignation by candidate(s) allotted in Round-1.
- Seats available due to up-gradation of candidate(s), who have been allotted and joined during Round-1 (Virtual Vacancy).

#### **ELIGIBLE CANDIDATES FOR ROUND-2:**

- Candidates who registered and choice locked in Round-1 but did not get any seat.
- Candidates who have joined at allotted medical/dental College during round-1 of allotment.
- Candidates who have not joined the allotted seats during Round-1.
- Candidates who have joined and resigned their seats in Round-1.

### **NOT ELIGIBLE CANDIDATES FOR ROUND-2:**

- ✤ Candidates, who have not registered in 1<sup>st</sup> round of online counselling.
- Candidates whose names are in the joined list provided by MCC at the end of All India Round -2.

### **CONVERSION OF SEATS**

- Note: SCA/ST Seats will be allotted for Eligible SCA/ST Candidates in the Merit List. If there are any unfilled SCA/ST seats in SF MBBS/BDS and IRT wards, that seats will be filled by the SC CANDIDATES in the Merit List. Kindly note that candidates eligible for SC category, in addition to Open and SC category seats, could also register and choice lock for SCA/ST seats in SF MBBS/BDS and IRT wards.
- **<u>Note</u>**: If a candidate is getting a seat under
  - i. Government Medical/ Dental College (or), IRT wards (or)
  - ii. Govt. Quota seats in SF Medical/ Dental college (or),
  - iii. Govt. Quota seats in Private Medical University

## and

If the candidates holds a seat in Round- I, under Management/ Minority/ NRI quota

## Then

**Above seat under Management/ Minority/ NRI Quota in Round- I** will automatically cancelled and treated as vacant. Thus, all candidates holding a seat in Round- I under Management/ Minority/ NRI quota are instructed to be very vigilant before locking their choices, during Round- II of Govt. Quota Counselling.

Kindly Note that if candidate is not getting a seat in Round-II of Govt. Quota, then seat in Round- I will be retained.

- Note: If a candidate is getting a seat in MBBS/BDS course in Round- II of Government Quota counselling or retaining a seat allotted in Round-I, He/she will not be allotted a seat in Round- II of Management/Minority/NRI Lapsed Quota and NRI Quota counselling. Candidates are instructed to be very vigilant before locking their choices, during Round-II of Govt. Quota Counselling.
- If the candidate who opts out of any Medical/ Dental colleges in Round- I of Counselling, he/ she cannot claim the seats in the medical/ dental colleges which were **opted out** during Round- I of counselling for choice locking in Round- II.
- Candidate could edit their Choice(s) but once the candidate locks his/her choice(s) during the online counselling, it cannot be changed later.

## INSTRUCTIONS FOR DOWNLOADING ALLOTMENT ORDER:

- Fee structure is available in the official website <u>www.tnhealth.tn.gov.in</u> and <u>www.tnmedicalselection.org</u>
- The Selected candidate has to pay non-refundable amount of Tuition Fee for downloading the allotment order through online via Debit Card / Credit Card/Net Banking or RTGS.
- The selected candidates who already paid the tuition fee in the Round –I of online counselling, have to pay the difference (if any) amount only.
- All candidates should make sure, sufficient transaction limit is available for their fee payment before remitting their Payment.
- The allotted candidates should download their provisional allotment order and join the course in the concerned Medical College/Institution on or before the stipulated date and time as mentioned in the Provisional Allotment Order.

  - 10. Eligibility Certificate (Other than Central Board and State Board Candidates)
  - 11. Passport Size Photo (10 Nos.)
- If you do not report to the Head of the Institution to which you are allotted on or before the time and date specified, your selection and / or admission will stand cancelled without any further notice.
- The Candidate selected for admission should give a self-declaration form at the time of the reporting to the concerned College that he/she is liable for forfeiture of selection / admission if suppression of facts, misinterpretation found at any time during or after the admission to the course.
