1st Round of Tripura State NEET UG 2023 Counselling for admission to MBBS/BDS & BASLP Courses in Regional Institute of Medical Science, Imphal, Agartala Government Medical College, Agartala, Tripura Medical College, Hapania, Tripura, Agartala Government Dental College and IGM Hospital, Agartala, Regional Dental College, Guwahati against the Tripura State Quota seats AND

For "All India candidates other than Tripura Domicile" seats at Tripura Medical College for the session 2023-24 will be started from **28**th **July 2023 at 2 pm.**

The schedule of the Counselling (as Annexure-A) and the Seat Matrix of all the seats to be distributed in the Tripura State NEET UG 2023 Counselling (as Annexure B) is published. BHMS and BAMS seats are not yet received by the Directorate of Medical Education and if these seats become unavailable within a reasonable time, the seats will be distributed in Round-2 or MOP UP Round (Round-3). Round-1 will continue with the available seats right now.

Eligibility Criteria for appearing in the Counselling for State Quota Domicile Seats (Annexure-C), Guidelines for Online Counselling (Annexure-D), Flow Chart of Counselling & Allotment process (Annexure-E), Registration Fees (Annexure-F) and Sample Procedure of Distribution of Seats (Annexure-G). Matrix of Round-1 to MOP UP Round (Round-3) (Annexure-H), Steps of Online Counselling (Annexure – I) with the Seat Matrix are annexed herewith (Annexure-B).

Aspirants NEET UG 2023 qualified Candidates are requested to register their names along with Registration Fees as indicated in **Annexure-F.** Candidates are also requested to go through every Annexure minutely before filling up their Application Form and deposit of Registration Fee.

Only registered candidates will be eligible for appearing in the Counselling. Admission on allotment is subject to condition that all the Uploaded documents are found authentic, true and correct during the Online & Physical verification.

The reservation for PwD candidates, EWS and WESM will be applied in the Seat Matrix as per Rules. Candidates belonging to PwD category shall have to produce their respective original Authentic Certificate from the Disability Board of Agartala Government Medical College & GBP Hospital, Agartala or any other Disability Board recognized by National Medical Commission (NMC)/Medical Council of India (MCI) for verification. Candidates belonging to ST/SC/ or **OBC** (for All India other than Tripura Domicile) and candidates belonging to eligibility criteria from 1 to 5 (as Annexure C) shall have also to produce their original authentic certificates during physical verification. Reservation for Ward of Ex Serviceman (WESM) candidates and Economically Weaker Section (EWS) candidates will be applicable as per Rules. Certificate Format of Person with Disability (PwD), & EWS are furnished in Annexure (J & K). All original copies of relevant certificates are mandatory during physical verification.

The Portal of the Online Counselling (https://dmeonline.tripura.gov.in) will be opened on 28-07-2023 at 2 pm. Please see all the Annexures (A to K) as Uploaded for ready reference. Annexure-"A" comprising Schedule of the Counselling including dates of Registration has been attached with this notification. Annexure-"B" comprising seat matrix will be published as per availability of seats in various courses at that point of time. Eligible aspirant candidates are requested to read the Notification and Annexure carefully positively before filling the Online Application Format and Registration for the 1st Round of Counselling and also to visit the said website regularly for the Date of Registration, Counselling Schedule, Notice/Notification and News/Events or any Modification of Schedule/Steps/Guidelines/Seat Matrix from time to time in the website https://dme.tripura.gov.in. All seats will be distributed as per Merit List of Registered eligible candidates only as per Norms, Guidelines of NEET UG 2023, Govt. of Tripura and Govt. of India as applicable.

Merit list of Registered Candidates will be duly published in the Directorate of Medical Education, Govt. of Tripura website (https://dme.tripura.gov.in) after completion of the Registration of candidates for Tripura State NEET UG 2023 Counselling and after verifying the eligibility of a candidate for state quota, from which only the state quota seats will be distributed as per merit and seat matrix.

ELIGIBILITY CRITERIA FOR APPEARING IN THE COUNSELING OF TRIPURA STATE QUOTA/DOMICILE SEATS OF MBBS, BDS, BASLP & AYUSH (UG) COURSES FOR THE ACADEMIC SESSSION 2023-24.

Eligibility Criteria:

Eligibility Criteria for appearing in the Counseling of State Quota/Domicile Seats for NEET UG qualified candidates (NEET UG 2023 for academic session 2023-24) for admission to Medical/Dental/AYUSH/BASLP courses.

Clause - 1.

The applicant must be an Indian Citizen and a Permanent Resident of Tripura. The applicant or his/her parents must have been residing in the State of Tripura continuously for not less than 10 (ten) years immediately prior to the date of making application for appearing at NEET-UG. The applicant should not have applied for domicile (as per NEET Brochure) of any State other than Tripura.

Clause - 2.

Children of All India Services Officers borne in Tripura Cadre and the Children of the Employees of the State Government posted outside Tripura will be eligible to appear at the Counseling irrespective of their prior stay in Tripura.

Clause - 3.

In case a candidate is not permanent resident of Tripura but his / her parent is either on deputation as Officer/**employee** to the Govt. of Tripura or an Officer/**employee** of the Central Govt. working in Tripura and has served in Tripura continuously for a period of 3 (three) years or more prior to appearing in the qualifying examination from any School/Institute of Tripura

Clause - 4.

In case of wards of Ex-servicemen, either the candidate or his/her parents must have been staying in Tripura continuously for not less than 5 (five) years immediately prior to the date of making application for appearing at NEET Examination and the candidate must have passed H.S(+2 stage) Examination in the year of NEET Examination from any School/Institute in India affiliated to Board recognized by Govt. of India/Govt. of Tripura with subjects in which he/she desires to appear in the NEET.

Clause - 5.

Children of serving Defense Personnel (Army/Navy/Air Force) hailing from Tripura are also allowed to appear for Counseling provided that their children should have stayed in Tripura continuously for not less than 5 (five) years immediately prior to the date of making application for appearing at the NEET Examination and that the candidate must have passed the H.S. (+2 stage) Examination from any Institution of Tripura with the subjects in which he/she desires to appear in the NEET.

In case of any doubt that may arise regarding authenticity of domicile/period of domicile, the same may be got verified from the issuing authority.

GUIDELINES OF ONLINE COUNSELLING FOR MBBS, BDS, BASLP & AYUSH (UG) COURSES FOR THE ACADEMIC SESSION 2023-24

The Directorate of Medical Education, Health & Family Welfare Department, Government of Tripura has formulated the following guidelines to be adopted for distribution of seats Professional Degree Colleges for MBBS/BDS/AYUSH/BASLP Courses through Counselling process by the Counselling Committee for distribution of seats in concerned Medical Colleges/Institutions for the academic session 2023-24.

- 1. After official publication of results of NEET UG, Directorate of Medical Education(DME) shall notify the date of schedule for the registration of the eligible candidates in the Tripura Counselling portal https://dmeonline.tripura.gov.in/. Then the Directorate Medical Education will prepare the merit list of the registered candidates and allotment will be done as per Seat Matrix and Merit and Choice filled by a candidate in the Counselling for admission in MBBS/BDS/AYUSH/BASLP Courses.
- The Tripura State NEET UG 2023 Counselling Committee shall supervise the Counselling of the qualified / eligible candidates for admission into the different Professional Degree courses in Colleges/Institutions inside and outside Tripura every year.

3. **SEAT MATRIX:**

- (i) State Quota Seats Reservation as per State Reservation Policy.
- (ii) For 20(twenty) numbers of MBBS seats at Tripura Medical College, the seats reserved for All India Candidates other than Tripura domicile, the Seat Matrix is done by TMC as per Central Reservation Policy.

4. Eligibility:

- (a) Eligibility Criteria for State Quota seats will be as per Eligibility Criteria stated in Annexure- "C"
- (b) Eligibility Criteria for 20(twenty) number of MBBS seat for All India candidate other than Tripura Domicile will as per Central Govt. norms & NMC guidelines as adopted by the state.

5. Steps of Counselling:

- (i) NEET UG 2023 Results of candidates of Tripura is published by DME in the website: https://dme.tripura.gov.in
- (ii) In due Course Tripura State NEET UG 2023 Counselling Committee will publish notification for Registration in the Tripura State Counselling (Registration for 1st round of counselling) for (a) State Domicile/State Quota seats and (b) 20 seats of the TMC for other than Tripura domicile candidate.
- (iii) Registration portal will be kept open for a scheduled period during which candidates have to register their names for (a) State domicile seats/State Quota Seats or (b) 20 (twenty) seats of TMC for All India candidates other than Tripura domicile.
- (iv) After registration process gets completed within the schedule date (i) Tripura State Merit List and (ii) The merit list of All India other than Tripura domicile (for 20(twenty) seats in (TMC) will be published. The Merit List of State domicile candidates will be prepared following primary screening of candidates' documents by the Counselling Committee.
- (v) The Counselling Committee will notify the dates of "choice filling and locking" for the registered candidates. Then the Counselling Committee will proceed for online allotment of seats only for these registered candidates of Tripura State NEET UG 2023 Counselling is eligible to participate in the Counselling.
- (vi) After allotment of seats, Issuance of Nomination will be arranged from DME for the State domicile/State quota seats and for the 20(twenty) seats for All India other than Tripura domicile seats. All admission to concerned Institutions as per allotment & Nomination is subjected to verification of original documents in the Institutions. Any want of original document or any faulty, any tampering, forgery in connection with original documents or any faulty illegible document if found during physical verification or at any point of time will lead to cancellation of Allotment/Nomination or admission in connection with that particular candidate and the said matter may be further processed as per Law (if any).
- (vii) After receiving the Nomination by a candidate himself/herself from the Directorate of Medical Education, the candidate will proceed for admission to the allotted College and have to fulfill the admission criteria of

respective College/Institution after the physical verification in the allotted Institution within the schedule time of admission as notified. No admission shall be allowed beyond last date of admission.

- 6. The seats not availed by the candidate in the 1st Round of Counselling or availability of new seats after notification of 1st Round of counselling (if any), will be carried forward for the 2nd Round of Counselling of Tripura State NEET UG 2023 Counselling.
- 7. Registration for Counselling in the link which will be published shortly in the Notification for Registration is mandatory to get a seat by a candidate through Counselling in the Round 1 and Round-2 of Tripura State NEET UG 2023 Online Counselling.
- 8. A candidate, who surrenders his / her seat offered in the first round of Counselling with an intention to avail better seat in the second and subsequent round of Counselling, shall not claim the college of his / her choice as per his / her original rank in the first round of Counselling. He/she will have to accept the seat in the college which is available during the second Counselling or subsequent Counselling as allotted as per candidates' filling of choice & as per merit. The same method shall be applied in case of a candidate who abstains from first round of Counselling or do not get admitted to a round-1 allotted seat & participate in round-2. For example, if a candidate who may have topped the NEET- UG in the first round Counselling but surrendered his/her seat with the intention of appearing in the subsequent round then he/she cannot claim in the 2nd Counselling that on the basis of rank he/she should be given a college of his / her choice made in Round-1. He / she will now rank with the others who are in the second Counselling and if in the second round of Counselling he / she is eligible as per merit at Round-2 to a college of his/her choice, he / she will get it. To clarify it further, supposing an unreserved category who is number one in the list gets a college of his/her choice in the first round of Counselling, but he/she does not accept the offer or surrenders the seat. In that case, when the second Counselling takes place, if there is no seat left under the unreserved category in the college of his/her choice, then he /she will have to accept the seat in the college which is now offered to him/her in the second round of Counselling as per the availability of seats.
- 9. All Rounds will be held with the availability of seats at that point of time of concerned Notification and will be furnished accordingly.
- 10. A Candidate who got admitted to an allotted seat during first round of Counselling and gets admitted but subsequently intends to resign/surrender the seat shall have to apply in written to the admitting authority and also to the Director of Medical Education regarding such surrender of the seat within 2(two) days from receiving the nomination positively with a surrender certificate to be obtained from the admitting Institutions and such submission to the office of the Directorate of Medical Education shall have to be done within 2(two) days of receiving the nomination or latest by within 2 days of the last date of admission of that Round.
- 11. When admission & surrender gets completed after first round of Counselling, the Directorate of Medical Education shall notify in due course the vacancy status of seats informs about the vacancy status of seats in respect of course/branch and category for holding the for second Counselling with schedule & inviting fresh registration of round-2 counselling.

Registration Fees for round -2 Counselling is exempted for candidates who have deposited registration Fees and already gets registered in round -1. So, a fresh candidate in round-2 he/she will have to deposit the both; registration Fees and security deposit for participating in round-2.

- 12. A candidate if admitted to a Round 2 allotted seat, his/her counselling ends at that point.
- 13. The candidates shall have to be present during the period of the document verification process in the allotted Institution before admission.
- 14. Admission of Candidate to a certain College / University will be subject to the fulfillment of other eligibility/Admission criteria, of the respective admitting College/University/Institution, including the cut-off marks in NEET UG 2023 of the respective category, Age of the candidate, beside other NEET Eligibility.
- 15. There will be no waiting list of the candidates at the time of Counselling. In successive occasions, fresh Counselling will be held as per procedure and Notification will be published in the website of Directorate of Medical Education with available seat at that round.
- 16. No separate call letter will be issued to any candidate.
- 17. If a Candidate got admitted to an allotted a seat in the current year whether in or outside the State on the basis of the result NEET-UG-2023, he/she will not be entitled for allotment of another seat unless he / she has surrendered the earlier allotted seat in writing within the specified time to the admitting authority and produce the Surrender certificate issued by the admitting Institution to Directorate of Medical Education in due time.
- 18. If any seats viz MBBS/BDS/BASLP or any AYUSH UG Medical courses be allotted for Tripura after publication of seat matrix, then those will be placed in the seat matrix of the next round of Counselling i.e. 2nd round / MOP-UP rounds (Round-3)/Stray vacancy round.
- 19. Without production of the original relevant certificates a candidate shall not be allowed for admission to an allotted Institute.

- 20. Tripura State Merit List will be published on the website: https://dme.tripura.gov.in by the Chairman of the Counselling Committee.
- 21. A candidate applying under Clause-1 of Eligibility Criteria should not apply for domicile seat of any State other than Tripura. A self-declaration in this regard will have to be given in the online State Counselling registration form. If the candidate is found to violate these domicile / or other eligibility criteria by supplying wrong/false information, his / her candidature of Counselling/Admission/Allotted/ Nomination is liable to be cancelled at any time.
- 22. A candidate admitted to a Round-1 allotted seat, participates in Round-2 for intention of up gradation of his/her choice of seat or Institution and fails to get an allotment in Round 2 then if he/she at that point of time intend to surrender his/her seat which he/she gets admitted in round 1 now wants to get a chance in the MOP UP Round (Round-3), then he/she can resign/surrender his/her seat by applying to admitting Institution and he/she have to submit the surrender acceptance from the admitting Institution Authority to DME physically within 2 days of publication of Result of Round 2.

A candidate, allotted seat in round-2 can still participate in MOP UP Round (Round-3) after surrendering the round -2 allotted seat with forfeiture of his/her security deposit. But if he/she gets admitted to a round -2 allotted seat, his/her Counselling for this academic session ends at that point.

- 23. Proper authentic certificates shall have to be possessed by a candidate and shall have to be shown at any point of time including during physical verification in support of any particular Reservation Category, State domicile Eligibility, Qualifying marks and Rank other eligibility conditions, Date of Birth etc.
- 24. Candidates are instructed to visit Directorate of Medical Education website. https://dme.tripura.gov.in regularly for any Updates, Notifications, Modifications, Notices issued from time to time regarding the said Counselling.
- 25. All candidates intending to avail State Quota seats of Tripura will have to submit an Undertaking stating that he/she is applying for State Quota Domicile seat of Tripura only and never applied or will apply for any other State Quota seat for this academic session of 2023-24.
- 26. Reservation Criteria of ST/SC for State Quota/ Domicile seats will be as per State of Tripura Reservation Rules.
- 27. Reservations of EWS /PwD for State Quota seat will be as per existing Rules and Guidelines as applicable for Tripura State in accordance with MCI/ NMC Norms.
- 28. Reservation for WESM for State quota seats will be as per existing rules & guidelines as applicable for Tripura State.
- 29. All Certificates of Reservation should be in Prescribed Form signed by the Prescribed authority with validity (wherever applicable) as per Rule.
- 30. In case of any doubt/dispute, the information in respect of the above mentioned subject matters as provided in respective regulations/ notifications of the concerned Regulatory bodies shall be considered as authentic and final.
 - Notwithstanding anything contained in the Information Bulletin, the decision of NTA/MoH&FW/NMC/MCI/DGHS/DCI/MoA/CCIM/BoGCCH/Tripura State NEET UG 2023 Counselling Committee/Health & Family Welfare Department, Govt. of Tripura shall be final and binding.
- 31. All disputes pertaining to the conduct of Tripura State NEET UG 2023 Counselling and allotment of seats shall fall within jurisdiction of Agartala only.
- 32. There will be 3(three) round of Counselling out of which Round-1 & Round-2 & MOP UP Round (Round-3) will be conducted in online mode by the Tripura State NEET UG 2023 Counselling Committee subjecting to the availability of seats.
- 33. There may be need to conduct a Stray Vacancy Offline Round of Counselling in the event of still vacant seats after MOP UP Round (Round-3) and in that case the Stray Vacancy Round may be conducted by the admitting Institutions of Tripura or by Counselling committee in online mode which will be declared in due course.
- 34. There will be NO AIQ Seats reverted to State Quota after completion of the AIQ Round-2.
- 35. The Eligibility, Guidelines, Steps of Counselling, Procedures of distribution of seats will be in accordance with existing Rules & Guidelines as per MCI/ NMC Norms/ Government of Tripura Norms and subject to change as per latest Notification from NMC directives from Ministry of Health & Family Welfare, Govt. of India and directives from Govt. of Tripura or any directives/ verdict from the Court of Law.
- 36. The Counselling Committee of Tripura State NEET UG 2023 reserves the right to withdraw/ cancel any allotment/selection/nomination/admission if any found to be have been granted or allowed in advertently to any candidate at any point of time who is not eligible to appear/of participate in the Counselling or not eligible to be allotted/selected/nominated/admitted against a seat at any point of time.



Tripura State NEET UG 2023 Counselling Committee disclaims any liability that may arise due to incorrect information provided by the candidate during Online Application Form submission or during Online Registration or in uploading relevant documents in this Tripura State NEET UG 2023 Counselling.
- 41. **Certificate of Disability for PWD candidates** shall have to be in prescribed format and signed by Designated Authority.
- 42. **Income and Assets Certificate to be produced by eligible economically Weaker Sections (EWS)** shall have to be in prescribed format and signed by designated issuing authority as belonging to EWS for an eligible EWS candidate (for the financial year April, 2022 to March, 2023).
- 43. **WESM certificate** also shall be issued from the prescribed authority (Department of Sainik Welfare, Tripura) denoting & satisfying the Clause of eligibility.
- 44. Eligibility for qualifying criteria for appearing in NEET UG 2023 and State Eligibility (here for domicile seat only) as well as eligibility criteria of respective Institutions shall determine the ultimate eligibility of candidate to get a seat as per merit and Seat Matrix accordingly for admission to MBBS/BDS/BHMS/BAMS and BASLP.
- 45. Candidates are instructed to visit the Directorate Medical Education, Govt. of Tripura website regularly and go through every Annexure/Notice/Updates/ Notification in connection with Tripura State NEET UG 2023 Counselling.
- 46. In event of any unprecedented circumstance the round-1 and or round-2 of Tripura State NEET UG 2023 Counselling may be performed Offline like this subsequent Offline MOP UP Round (Round-3) Offline Round.
- 47. Educational Notification containing schedule of the Counselling including schedule of Online registration and choice filling by the candidates and the last date of admission for the 1st Round and subsequent round of Tripura State NEET UG 2023 Counselling will be invited shortly in due course.
- 48. Relevant Service Bond and Discontinuation Bond will be applicable to the admitted candidates in respect of their courses and Institution and shall have to be executed by the candidate during nomination/admission.
- 49. Registration Fees for all candidates for Round -1 and fresh candidate of Round -2 to participate to Round -2 is applicable to every candidate intending to Participate in the Counselling which will have to be deposited Net Banking/RTGS/NEFT. - 52. In case of any objection, the burden of proof shall be with the objector and such objection shall have to be submitted within 2(two) days and the decision of the Counselling Committee shall be final and binding upon all.
- 53. Eligibility should be as per domicile eligibility criteria for State UG Counselling for State domicile seats.
- 54. No application for correction in particulars in respect of candidate published in the NEET UG 2023 result/Merit List declared by NTA/MoHFW, Govt. of India, New Delhi will be entertained by Tripura State NEET UG Counselling Committee in the distribution of seats in the Tripura State NEET UG 2023 Counselling.

PROCEDURE OF DISTRIBUTION OF SEATS IN THE COUNSELLING FOR MBBS, BDS, BASLP & AYUSH (UG) COURSES FOR THE ACADEMIC SESSION 2023-24

- 1. Tripura State Merit List (TSML) of registered candidates will be generated. The candidate eligible for UR category seat as per merit can opt as per choice filling any seat from the available seats meant for UR and he / she can opt any seat of a particular course according to his /her choice from any of the available Colleges. Candidates will be allotted seats as per merit if they fulfill other eligibility criteria. The seats of UR category seats will be distributed first as per Merit List followed by EWS, ST, SC, PwD and WESM category seat as per availability.
- 2. If the candidate belongs to ST/SC category with eligible Rank/Marks(as per Merit List) he / she will be selected for a seat of a particular course in any one of the following cases:-
 - (a) A candidate of ST/SC category will be offered to opt any seat from the available seats meant for UR and he / She can opt any seat of a particular course according to his/her choice from any of the available courses meant for UR. In that case the seat which is allotted to him/her as per Merit then the UR seat would be reduced from the seats meant for UR and not from the seat reserved for the ST/SC category.
 - (b) A candidate of ST/SC Category will be offered to opt any seat from the available seats meant for UR and he / she can opt any seat of a particular course according to his / her choice from any of the available courses meant for UR. But if he / she finds that seat meant for UR for a particular course of his choice is available in a particular Institution which he/she does not prefer, but seat reserved for ST/SC category for that course is available in his / her preferred college / Institution, then he / she can opt a seat reserved for ST/SC Category in his /her preferred College. In this case, his/her admission should not be counted against the quota reserved for ST/SC Category, i.e. No seat can be reduced from the quota of concerned reserved category. As the candidate is eligible for UR seat on his/her own merit, one UR seat will be reduced from UR Quota and the reduced seat would be compensated to the seats reserved for the ST/SC category so that the number of seats reserved for ST/SC category for this particular course is not reduced by the aforesaid case.
 - (c) If no seat meant for UR is available for a particular course, say MBBS, then a candidate of ST/SC Category will be offered to opt any seat from the remaining courses meant for UR and including the seats of MBBS which are available for ST/SC Category. The candidate can opt any seat of a particular course according to his / her choice from any of the available courses meant for UR. But if he/she opts a seat of MBBS from the seats reserved for ST/SC, then the seat would be reduced from the seats reserved from ST/SC. Then the Committee shall select the candidate for the respective seat of that course that he/she will opt provided he/she fulfills the other eligibility criteria.
 - (d) If all seats meant for UR are exhausted, then a candidate of EWS ST/SC Category will be allotted any seat from the available seats reserved for EWS ST/SC as per merit and choice filled up by the candidates provided, he/she fulfills the other eligibility criteria.
 - (e) The vacant seats in reserved category will be filled up as per approved roster and rules of distribution of seats.
- 3. Seats reserved for PwD/WESM will be distributed as per norms/Roster and guideline.

4. Two examples cited below to explain some points of the aforesaid procedure:

Example – 1

The candidates shall be **distributed seats as per Tripura State Merit List (TSML)** merit position 1, TSML merit position 2, **TSML** merit position 3, **TSML** merit position 4 and so on. Suppose Ajay Debbarma, a candidate of ST category having **TSML** merit position 4 shall have to be allotted a seat from these following available seats of MBBS course as shown below:

Debasish has filled his first preferred choice as MBBS Seat at RIMS, Imphal. But no seat for UR at RIMS is available but seat for UR is available in AGMC. In that case he will be allotted a seat at RIMS from the seat meant for SC category as a UR candidate. As he is eligible to get a seat from seats meant for UR, a seat reserved for SC Category for this particular course is not reduced by any means for the aforesaid case. Since now 01 (one) of the 02 (two) SC seats in RIMS is filled by an UR candidate who is an SC, so 01 (one) UR seat is decreased from the total UR seats of AGMC making it 37 and 01 (one) SC seat is increased in AGMC making it 14. The available seats after allotment are shown below:-

All candidates irrespective of their categories will be considered for Institutions indicated as per their preferences.

If a candidate belonging to reserved category is allotted a seat as per above-mentioned allotment, then he/she will be considered to have filled the UR category seat and not the reserved category seat.

GENERAL INFORMATION REGARDING STEPS OF ONLINE COUNSELING FOR UNDER GRADUATE COURSES OF MBBS, BDS, BASLP & AYUSH COURSES FOR THE SESSION 2023-24

- 1. Registration is a **must** for a candidate to be eligible for the Online Counseling.
- 2. There will be 2(two) rounds of counselling followed by offline Mop-UP Round (Round-3) or as per any other notification from GOI (Govt. of India) /NMC (National Medical Commission)/ MCI (Medical Council of India) / NTA (National Testing Agency) / Hon'ble Supreme Court of India issued from time to time. The stray vacancy round(offline) will be conducted by admitting Institutions of Tripura subject to the availability of still vacant seat after the Mop-Up Round (Round-3) in accordance with the merit list prepared and sent from Directorate of Medical Education.
- 3. Every round of Round-1 and Round-2 is fresh round. The candidates who did not/could not register their names in the 1st round of counseling must register their names in the 2nd round of counseling and allotment of each round will be against the available seats for that particular counselling only.
- 4. Candidates once registered in the Round I (1st round) of counselling need not register their names again for the 2nd round of counselling. But Security Deposit for participation in the Second Round Counselling is mandatory for all. There will be no fresh registration in Mop-Up Round (Round-3).
- 5. Round 1 and Round 2 Counselling will be online and as per seat category in the following order:-
 - (a) UR (b) ST (c) SC (d) OBC (Applicable for 20 seats at TMC for 'All India other than State Domicile candidates').
- 6. The counseling will be as per procedure of each candidate in the order of preference opted for different courses & colleges by a candidate.
- 7. There will be provision for auto up-gradation for the candidates in the Second Round, the Allotment in Second Round as per candidates choice will automatically cancel his/her earlier seat of allotment/admission in Round-1.
- 8. Any seats after 1st round of counseling if remains vacant or new seats be made available by GOI or any other source will be placed in the seat matrix of 2nd round of counselling with proper Educational Notification.
- 9. There will be a Mop Up round if there is any seat still remaining vacant after 2nd round of counseling or new seats become available from GOI or any other source.
- 10. If any seat remains vacant after MOP UP Round (Round-3), or new seats become available from GOI or any other source, then these seats will be sent back to the respective college with a merit list in the ratio of 1:10 (i.e. 10 names for each seat vacant in that category.
- 11. The final Tripura State Merit List (TSML) will be prepared from the candidates who have registered in the Tripura Counseling Portal (https://dmeonline.tripura.gov.in) Physical Verification of Documents/Certificates etc. will be done by allotted Colleges before admission. Allotment/Nomination will automatically stands cancelled for a candidate, if he/she does not clear Physical Verification process.
- 12. The final Tripura State Merit List will be published on the following website: www.dme.tripura.gov.in by the Chairman of the Counselling Committee.
- 13. The schedule of the whole process of the counseling and registration thereof will be published in the Educational Notification from the Directorate of Medical Education in due course in accordance with the guidelines & directives of NMC/MCI/NTA/GOI/Hon'ble Supreme Court of India.
- 14. In the event of any technical snag or any other unprecedented situation the Round-1 and Round-2 of counselling may have to be taken in offline mode, notification regarding any changes or modification of which shall be published in the website accordingly.
