The number and distribution of seats are subject to change depending upon the periodic directives from Competent Authorities.

Definition of Categories:

i) Unreserved (UR):

Unreserved stands for all Indian citizens.

ii) Institute (INST):

Institute stands for an applicant who has studied and obtained **his** / **her MBBS Degree** from JIPMER Puducherry and Karaikal campuses. The word Institute does not apply to any other Medical Institution for benefit against statutory reservations.

iii) Other Backward Classes (OBC):

Applicants are required to ensure that he/she does not belong to the persons/sections (Creamy Layer) mentioned in Column 3 of the Schedule to the Government of India, Department of Personnel & Training O.M. No. 36012/22/93-Estt. (S.CT) dated 08/09/93, which was modified via OM No. 36033/3/2004 Estt. (Res.) dated 09/03/2004 or the latest notification of the Government of India (Central list) in support of his/her claim. Kindly click following see **OBC:** the link to the central list of http://www.ncbc.nic.in/User Panel/CentralListStateView.aspx.

<u>OBC Certificate</u> must be in the format mentioned in Annexure –II, and the validity (date of issue) of the same should be as per INI-CET notification.

iv) Scheduled Caste / Tribe (SC / ST):

Applicants will be required to produce the necessary certificate in the format provided. The certificate should be as prescribed in M.H.A., O.M., No. 42/21/49-N.G.S. dated 28.1.1952, as revised in Dept. of Per-& A.R. letter No. 36012/6/76-Est. (S.CT), dated 29.10.1977, to be produced by a candidate from a Scheduled Caste or a Scheduled Tribe supporting his/her claim.

<u>SC/ST Certificate</u> must be in the format mentioned in Annexure -III.

v) Economically Weaker Sections (EWSs):

Persons not covered under the reservation scheme for SCs, STs, and OBCs and whose families have gross annual incomes below Rs. 8.00 lakh (Rupees eight lakh only) are to be identified as EWSs for the benefit of reservation. Income shall also include income from all sources, that is, salary, agriculture, business, profession, etc., for the financial year before the year of application.

Also, persons whose family owns or possesses any of the following assets shall be excluded from being identified as EWS, irrespective of the family income: -

- i. 5 acres of agricultural land and above;
- ii. Residential flat of 1000 sq. ft. and above;
- iii. Residential plot of 100 sq. yards and above in notified municipalities;

iv. Residential plot of 200 sq. yards and above in areas other than the notified municipalities.

The property held by a "Family" in different locations or places/cities would be clubbed while applying the land or property holding test to determine EWS status.

The term "Family" for this purpose will include the person who seeks benefit of reservation, his/her parents and siblings below the age of 18 years as also his/her spouse and children below the age of 18 years. (As per the Office Memorandum F.No.36039/1/2019 dt 31st January 2019 by Ministry of Personnel, Public Grievances&

Pension & F. No. A11013/01/2019 dated 28th February 2019 by Ministry of Health & Family Welfare, Government of India) <u>INCOME & ASSET Certificate</u> must be in the format as mentioned in Annexure–IV, and the validity (date of issue) of the same should be as per INI-CET important dates notification.

Candidates from SC / ST / OBC (Central List) are not eligible to apply under the EWS category.

vi) Persons with Benchmark Disability (PwBD/OPH):

5% of the annual sanctioned intake capacity shall be filled up by candidates with benchmark disabilities in accordance with the provisions of the Rights of Persons with Disabilities Act, 2016, based on the merit list.

The minimum degree of disability should be 40% (Benchmark Disability) to be eligible for availing reservation for persons with specified disability. The Percentage of the candidates' disability will be assessed by the JIPMER Medical Board, and the decision of the JIPMER Medical Board will be final in this regard.

The eligibility of candidates to pursue a course in medicine with a specified disability shall be in accordance with **Annexure-VI** (as per the gazette notification by MCI in Amendment Notification No. MCI-34(41)/2018-Med./170045 dated 4th February 2019)

The disability certificate should be uploaded at the time of counselling and produced for verification at admission. It should be certified by a duly constituted and authorized Medical Board of the State or Central Govt. Hospitals/Institutions.

If the seats reserved for persons with disabilities in a particular category remain unfilled on account of the unavailability of candidates, the seats shall be included in the annual sanctioned seats for the respective Category.

Indian Candidates Sponsored by the Government (State/Central Services)

A candidate applying for admission as a sponsored/deputed candidate must fulfil the following conditions duly certified by his/her sponsoring / deputing Authority / Employer for admission to the course in the discipline allotted. The candidate is required to submit the scanned copy of the sponsorship certificate as mentioned in the Prospectus Part- A.

In case the applicant is not able to upload the sponsorship certificate at the time of submission of the online application, he/she is permitted to upload a scanned copy of the sponsorship certificate (.jpg /pdf) using his/her user ID and password **as mentioned in the Prospectus Part-** A in the database. Non-receipt of scanned copy in the database of such candidate will lead to automatic rejection of his/her application, and a hall ticket will not be generated/issued. The sponsored certificate should contain the following declaration from the sponsoring authority:

- a) That the candidate concerned is a permanent or regular employee of the deputing / sponsoring authority and should have been working for at least the last three years (on or before 30th June 2024 for the July 2024 session)
- b) After getting training at JIPMER, Puducherry, the candidate will be suitably employed by the deputing/sponsoring authority to work for at least five years in the specialty in which training is received by the candidate at JIPMER.
- c) No financial implications, in the form of emoluments/stipend, etc., will devolve upon JIPMER, Puducherry, during the entire period of his/her course, and such payment shall be the responsibility of the sponsoring authority.

Deputation/Sponsorship of candidates holding tenure appointments (like house job, Junior or Senior Residency, ad-hoc or contract or honorary appointment against a leave vacancy) shall **NOT** be accepted. Deputation/Sponsorship of any candidate by private hospitals, institutes or nursing homes is not accepted. The sponsoring Institute should not nominate more than one candidate for each of the specialities specified in the distribution of seats in the discipline (Page No: 4).

Sponsorship / Deputation of candidates will be accepted only from the following:

- a. Central or State Government Departments/Institutions
- b. Autonomous Bodies of the Central or State Governments
- c. Public sector colleges affiliated to universities and recognized by the NMC. For candidates deputed/ sponsored by the Medical College affiliated with universities and recognized by the Medical Council of India, a deputation/sponsorship certificate signed by the Principal of the Medical College concerned ONLY shall be accepted.

Selection of Sponsored Candidates:

Sponsored/Deputed candidates are also required to appear in the common entrance examination. Separate merit lists will be drawn for each of the specified discipline for sponsored candidates. If selected for admission to any course of the JIPMER, these candidates are required to make their own arrangement for stay during the period of their course.

The sponsored candidates selected for admission will be <u>granted only one-month time</u> to produce Sponsorship/Relieving/Study leave/NOC certificates from the date of announcement of the results of the respective counselling. No further extension will be allowed under any circumstances.

Foreign National Candidates:

Foreign National candidates must route their application through the Ministry of Health and Family Welfare, Government of India, New Delhi. All Foreign Nationals should register their MBBS Degree in the Medical Council of their respective countries and will have to take prior permission from the National Medical Commission/Medical Council of India before applying for postgraduate courses in the Institute. An advance copy must be submitted as per the INI-CET notification.

However, applications of such candidates will be processed after receipt of the same through diplomatic channels. These candidates are also required to appear in the entrance examination along with other candidates. Preference will be given to the candidates from SAARC countries (Bhutan, Bangladesh, Maldives, Nepal & Sri Lanka). Selection of candidates will be made on merit based on their performance in the entrance examination. Separate merit lists will be drawn for each specified discipline for foreign national candidates. If selected, the candidates should apply for temporary registration with the National Medical Commission/Medical Council of India for the duration of postgraduate study and the same should be submitted on or before 31st August 2024.

Requirements for Admission of Foreign Nationals:

- a) Foreign Nationals are required to fill in the prescribed online application form for ONLY ONE discipline of their choice for admission to Postgraduate courses leading to award of MD/MS degree.
- b) The Foreign Nationals are required to send their Registration Slip of online application through Diplomatic Channel. They are also required to appear in the INI-CET Entrance Examination along with other candidates. An "Advance Copy" to be submitted to INI-CET.

However, the application of all such candidates will be processed only after receipt of the same through Diplomatic Channel.

- c) The Foreign Nationals will be considered against the seats advertised under the "Foreign National" category only for MD/MS courses. They should be registered with NMC/MCI before they will be allowed to join the said course if they are selected for the same through the entrance examination.
- d) Nominations/No objection for the candidate should reach to as per the INI-CET notification. In case of non-receipt of the nominations/clearance/no objection from the concerned Ministry by due date, their candidature will not be considered.
- e) Stipend/emoluments will be paid as per JIPMER rules and regulations.

Overseas Citizen of India (OCI/PIO):

Eligibility of OCI/PIO candidates will be based on the decision of the Hon'ble Supreme Court of India in Writ Petition (Civil) 891 / 2021 dated February 03, 2023.

- 1. Candidates born before 04.03.2021 and who have secured the OCI card before 04.03.2021 shall be considered INDIAN NATIONALS and will be eligible ONLY for open category (unreserved) seats for INDIAN NATIONALS. They will not be eligible for consideration for seats for Foreign Nationals.
- OCI/PIO card holders who are not to be considered as Indian Nationals based on the decision of the Hon'ble Supreme Court of India in Writ Petition (Civil) 891 / 2021 dated February 03, 2023 shall be considered as FOREIGN NATIONALS. They will not be eligible for consideration for seats for Indian Nationals.

OCI candidates are not required to obtain NOC, however must upload the scan copy of OCI card on or before date(s) mentioned in Important Dates Section of Prospectus Part-A. The earliest issued, valid OCI card must be uploaded on the portal. Any attempt at hiding a valid older OCI card or uploading only a newer card will be considered as providing false information and the candidature may be cancelled.

ELIGIBILITY TO APPLY

(a) Nationality:

MD/MS/MDS/6-Year MCh Courses:

Applicant must be an Indian National (IN) or Overseas Citizens of India (OCI) or Foreign Nationals (FN) under the permitted categories.

(b) Educational Qualification:

MD/MS/ 6-Year MCh Courses:

The candidates must possess MBBS degree from a University recognized by the National Medical Commission/Medical Council of India for admission to MD/MS/6-year MCh courses.

MDS Courses:

The candidates must possess a BDS degree from a University recognized by the Dental Council of India for admission to MDS courses.

(c) Internship:

A candidate must have completed the required period of 12 months' compulsory rotatory internship/Practical training on or before 31st July 2024. No condonation of Compulsory Rotating Internship shall be accepted.

(d) Minimum Qualifying Marks: -

- i. For Unreserved (UR), Institute (INST), Economic Weaker Section (EWS) and OBC Category: 55% marks in aggregate
- ii. For candidates belonging to the SC/ST Categories: 50% marks in aggregate.
- iii. For PwBD candidates, the minimum aggregate provided in (i) and (ii) for the category to which the candidate belongs shall apply.
- iv. For Indian Nationals who graduated from foreign Universities, marks obtained in the Foreign Medical Graduate Examination (FMGE) conducted by the National Board of Examination (NBE) shall be considered in lieu of aggregate marks. The eligibility criteria for minimum marks shall remain as mentioned above in points (i), (ii), and (iii) as applicable.

Note: Candidates who have already completed MD/MS/MDS/6-Year MCh course in any subject in any Institution are **NOT** eligible for admission to MD/MS/MDS/6-Year MCh course at JIPMER.

COUNSELLING OVERVIEW

- 1. The list of candidates who qualify for the counselling will be available on the website at the time of declaration of results.
- 2. Counselling (including final counselling) will be done according to the category rank (UR / INST / OBC / SC / ST / EWSs / PwBD) that is as per the Dynamic Roster Point allocation method (Annexure I). For the July 2024 session, the counselling will start from Roster point 182 (OBC-49).
- 3. The Reservation Roster Allocation method will not apply to MDS course seats, integrated 6-year MCh course seats, seats reserved for the Sponsored category and seats reserved for the Foreign National category. These seats will be allotted based on merit only.

Note:

Process of Allotment of Seats through Dynamic Roster Point Allocation System: Other than the use of Dynamic Roster Point for allocation, there is no speciality/course-wise reservation applicable in JIPMER, and all the seats at JIPMER are available for all the candidates subject to their rank and availability of the seats at any Roster point where the candidate gets the chance to opt for the seat.

It may be understood by the 2 examples stated below:

- a. If there are 115 seats available for Indian National candidates (other than sponsored candidates), the candidate who gets a chance on the first Roster Point, i.e. UR-1, as per his/her rank, is eligible to take any of the 115 seats.
- b. Similarly, if a candidate gets the chance on roster point number 18 (UR-7/OPH) as per his/her rank, he/she will be eligible to take any remaining vacant 115-17 = 98 seats.

ADMISSION PROCESS:

- 1. At the time of admission: The candidate's biometric fingerprint/iris scan and image verifications will be done on the day of joining. If there is any mismatch, the candidate will NOT be permitted to attend the counselling apart from proceeding with legal action deemed fit by the Institution.
- 2. The Candidate should submit the following certificates in original along with one set of self-attested copies.
 - i) Hall Ticket.
 - ii) Rank letter.
 - iii) Certificate showing the date of birth (Birth Certificate/SSLC mark List).
 - iv) MBBS Mark Statement for MD/MS/6-year MCh courses and BDS Mark Statement for MDS courses.
 - v) Internship Completion Certificate.
 - vi) Conduct Certificate obtained from the Institute last attended*.
 - vii) Transfer (OR) Migration Certificate obtained from the Institute last studied*.
 - viii) MBBS Degree or Provisional Pass certificate for MD/MS/6-year MCh courses course and BDS Degree or Provisional Pass certificate.
 - ix) MBBS/BDS Permanent/Valid provisional Medical/Dental Registration certificate**.
 - x) The residence certificate issued by the Revenue Authority is not below the rank of Tehsildar, AADHAR card, Voter ID, or Passport copy.
 - xi) COVID-19 Vaccination Certificate.
 - xii) In the case of Other Backward Classes/ Scheduled Caste/ Scheduled Tribe, a Community Certificate recently obtained from the competent authority – a Revenue Officer not below the rank of Tehsildar.

Other Backward Classes (OBC) candidates should produce the required certificate in Annexure II format.

Schedule Caste/Schedule Tribe (SC/ST) candidates should produce the required certificate per Annexure III format.

Economically Weaker Sections (EWSs) candidates should produce the required Income & Asset Certificate as per the format in Annexure –IV.

* A maximum of one-week time will be given from the date of issue of the provisional admission order

** Permanent Medical Registration certificate has to be submitted before the date of Stray Round Counselling. The detection of any discrepancy in the caste certificate shall entail cancellation of registration even after admission to the course. This is as per the provisions made by the Ministry of Personnel, Public Grievances and Pensions vide their order No.36033/4/97-Estt. (RES) dated: 25-7-2003 and No.36011/3/2005-Estt. (RES) dated: 09-9-2005 respectively. The name, designation and the seal of the officer should be legible in the certificate. Certificates from any other person/authority will not be accepted, and no further correspondence in this regard shall be entertained.

- xiii) Certificate from the Institute last studied, stating that the degree obtained by him / her from that Institute is recognized by the Medical Council of India/Dental Council of India.
- xiv) The service candidate should produce a NOC / Relieving Order and a certificate granting study leave with or without pay, as the case may be. (Annexure-V)
- xv) Proof of Registration as OCI (in case of Overseas Citizen of India (OCI)).
- xvi) Medical Certificate in case of Orthopaedic Physically Challenged Candidates.
- xvii) Passport size colour photo 4 Nos.

(The Original Certificates will be retained in the Academic Section and returned only after the candidate completes the course or if relieved mid-way).

- **3.** In addition to other requirements, a candidate's biometric fingerprint or iris scan, photo, and certificates should be required to be eligible for admission.
- 4. If the certificates are in any other language other than English, <u>English Translation attested</u> by a Gazette Officer should be produced.

All candidates must be physically present in person for admission. No request for an authorized representative on behalf of the candidate will be entertained. If a candidate fails to come for admission in person, he/she will be marked absent, and the admission will be cancelled.

IMPORTANT NOTE:

The allotted seat will be cancelled in the following circumstances:

1. Candidates who have been allotted seats under the Non-Creamy Layer OBC Category and whose sub-caste is NOT listed in the current Central OBC List and whose Certificate is NOT submitted in the prescribed format (Annexure – II) from the Competent Authority (OR)

2. Candidates who have applied under SC/ST Categories WITHOUT valid Certificate as in the prescribed format (Annexure – III) from the Competent Authority (OR)

3. The candidates who have applied under the EWSs category WITHOUT valid certificate as in the prescribed format (Annexure-IV) (OR)

4. Non-submission of OCI Registration Certificate issued by the Competent Authority.

Admission to MD/MS/MDS/6-year MCh courses closes on 31st August 2024.

ELIGIBILITY FOR SUBSEQUENT COUNSELLING

Eligibility for the first and the subsequent counselling(s) will be as per the INI-CET notifications.

- 1) Candidates opting for a particular discipline and getting admitted to JIPMER after the First counselling are eligible to be registered for the subsequent counselling as per the instructions given by INI-CET, AIIMS, New Delhi.
- After getting admission in JIPMER either in the first or second round of counselling, if a candidate participates and is allotted a seat in any INI (including JIPMER) in the open round/on-the-spot counselling, he/she must pay mid-stream departure penalty.

ISSUE OF ADMISSION ORDER:

The candidates who have opted for a seat and were selected through counselling shall undergo a medical examination and biometric (Fingerprint/signature / facial) verification. The admission letter will be issued after due verification of the documents, clearance of biometric parameters, and medical fitness certified by a competent authority nominated by the Institute. The academic session will commence from 01^{st} July 2024.

Selected candidates must join the course after the medical examination on or before the stipulated date in the selection letter. The admission will be treated as cancelled if a candidate fails to pay the specified fee by the date intimated by the competent authority of JIPMER or fails to join the course or fails to report for duty to the concerned Head of the Department and has not worked in the Department. Such seats shall be filled through subsequent counselling by following the dynamic reservation roster system. No further correspondence will be made in this regard. **Extension of joining time shall not be granted under any circumstances.** The Junior Resident (P.G.) should send his/her joining Report to the Director and forward it through the concerned Head of the Department.

If a Junior Resident remains continuously absent or unauthorized for more than 30 days after joining, the admission will be cancelled, and the necessary penalty will be levied.

Admission to the course will be provisional, subject to the recognition of the qualifying examination of individual candidates by JIPMER.

In case a candidate is found to have provided false information or certificate, etc., or is found to have withheld or concealed information in his / her Application Form, he/she shall be debarred from admission and if already admitted, the admission will be cancelled without prejudice to other disciplinary action.

In case a candidate is found to have used unfair means/impersonation, the selection/admission will be summarily cancelled.

Hostel Accommodation:

- 1. All Residents, including foreign nationals, may avail of a common hostel accommodation subject to availability. Only a limited number of rooms are available for postgraduate resident doctors.
- 2. Hostel Accommodation is primarily for non-Puducherry candidates.
- 3. Separate Hostels for Male & Female Residents are available.
- 4. Application for accommodation in the hostels should be in the prescribed form along with the assurance by the parent or guardian for the good conduct and behaviour of the candidate during his/her stay in the hostel. Allotment of the hostel will be on a first-come-first-serve basis.
- 5. After the allotment of the Hostel to the students, the candidate should pay the following charges through electronic mode as advised at the time of admission. House rent allowance will not be granted during the period of stay in the hostel.

CONTRACT AGREEMENT

All Postgraduate Degree students will be covered under the Residency Scheme on contract service, and they will be required to enter into a contract as prescribed by the Institute at the time of admission and the beginning of each year. If any candidate leaves the course at any time, he / she will have to abide by all the terms and conditions as per the contract executed by him / her.

- (1) All the candidates, admitted to various courses, will be appointed as "Junior Residents". The total duration of the salary period of Junior Residents shall not exceed 3 years (36 months). For a 6-year MCh course, the candidates will be appointed as "Junior Residents" in the first three-year period and on fulfilment of the requirement, they will be appointed as "Senior Residents" for the next three years.
- (2) The tenure period of MD/MS/MDS Junior Resident is 36 months. The tenure period of 6year MCh residents will be 72 months (36 months of junior residency and 36 months of senior residency).
- (3) The candidates admitted to a MD/MS/MDS course will be paid as per the 7th Pay scale i.e Level 10 (Rs.56,100/-) (Rupees Fifty Six Thousand and One Hundred) and other allowances admissible under rules and as approved by Ministry of Health and Family Welfare, Government of India from time to time. For 6-year MCh course, the candidates will be paid as for junior residents as mentioned above in the first three-year period and as for Senior Residents for the next three years.
- (4) During the period of the Junior and Senior Residency, candidates are not eligible to receive or apply for Scholarship / Financial Assistance / Salary / Railway concessions of any kind, etc., from any other source as they are in a stipendiary post-fixed by the Government. Private medical practice is not permitted during the postgraduate course period.
- (5) If the certificates submitted by him/her at the time of joining the course are found to be not genuine by the Competent Authority at any time during or after the course, his/her Degree is liable to be cancelled by the Director.
- (6) If the Junior or Senior Resident is suspended from duty in connection with any investigation into his / her conduct, he/she shall not be entitled to any emoluments during such a period of suspension. A Junior and Senior Resident may be placed under suspension as per rule 10(1) of CCS (CCA) Rules,1965, in the following circumstances:

where a disciplinary proceeding against him is contemplated or is pending; (OR) where, in the opinion of the competent authority, he has engaged himself in activities prejudicial to the interest of the security of the State; (OR)

where, a case against him in respect of any criminal offence is under investigation, inquiry or trial.

- (7) If any Junior or Senior resident is absent continuously for more than 30 days without any intimation to the office, the residency contract stands automatically cancelled and salary would be withheld, and no course completion certificate will be issued and necessary penalty will be levied.
- (8) If he/she is satisfied on medical evidence that the resident is unfit and is likely to remain so for a considerable period for reasons of ill health and unable to discharge his / her duties, the decision of the Director whether the Resident is unfit and is likely to continue to remain unfit shall be conclusive and binding on him/her.
- (9) If the Resident is found to behave in an unruly manner singly or in a group or cause damage to institute property, bring discredit to the name of the institution in any manner or be guilty of any insubordination, interference or other misconduct or any breach or non-performance of any of the provisions of the agreement signed by him / her at the time of admission, disciplinary proceedings will be taken as per CCS rules from time to time (OR) the resident may be terminated from the service without any prior notice.

DUTIES & RESPONSIBILITIES

Duties and responsibilities of the Postgraduate students will be fixed by the Government from time to time under the residency scheme for which a contract has to be executed at the time of admission. Renewal of this contract annually is subject to a satisfactory performance report from the concerned head of the department. In case of any adverse report, the institute has the right to terminate the residency contract with immediate effect. They will be required to perform such work as may be needed in the legitimate interest of patient care in the hospital/laboratory work/teaching schedule.

ATTENDANCE / LEAVE

The Postgraduate students are eligible for leave as follows: -

First Year Junior Resident: 30 days in a completed academic year

Second and Third-Year Junior Resident: 36 days in a completed academic year

Leave not availed during a year cannot be carried over to the subsequent year. Leave regulations for Junior Residents and Senior Residents is available at <u>https://jipmer.edu.in/sites/default/files/Leave%20Rules%20for%20academic%20Junior%20Residents.pdf</u>.

Dissertation

Candidates who join MD/MS/MDS course must complete a dissertation as partial fulfilment of the course. Candidates of 6-year MCh courses must complete two dissertations, one in Surgery and

Leaving the Course during Residency

(MID – STREAM DEPARTURE)

Any candidate who discontinues the course at any time is relieved on his/her request for any reason; the fees, once paid, will not be refunded.

In addition to the terms and conditions mentioned above, the penalty for discontinuing the Residency scheme contract executed by the candidate will apply to relieve the candidate and the other terms and conditions governed by CCS rules from time to time.

In addition to the penalty amount, the candidate must either give a one-month notice period (or) pay a one-month salary/stipend as detailed below: -

KEY POINTS

- 1. Any attempt by the candidate to influence directly or indirectly by any means will be treated as disqualification.
- 2. The selected candidates will have to undergo a medical examination, and the admission will be subject to medical fitness. An Immunization Certificate for the Hepatitis B vaccine indicating the receipt dates must be submitted at the time of medical examination.
- 3. No individual intimation will be sent to candidates who are not selected, and no correspondence on this subject will be entertained.
- 4. The decision of the Director shall be final in all matters relating to the selection for admission.

All students admitted to the Institute shall maintain good conduct, pay the requisite tuition fees and other charges by the due date, with regular attendance and abide by the rules and regulations of the Institute and Hostels, failing which they will not be permitted to continue the course. - 6. The training period is strictly full-time and continuous 36 months from their date of joining. Private practice in any form during the course is prohibited.
- 7. The rules are subject to change in accordance with the decisions of the Institute from time to time.
