IMPORTANT INSTRUCTIONS

- (1) Admission for first year post-graduate degree courses in MD/MS (Ayurveda) and MD (Homoeopathy) of State Quota (including 10 % management & 15% NRI quota) of Ayurveda/Homoeopathy colleges of Gujarat State for the academic year 2022-23
- (2) Admission for first year post-graduate degree courses in MD/MS (Ayurveda) and MD (Homoeopathy) for 15% All India Quota Seats of Self-Financed colleges of Gujarat state for the academic year 2022-23
 - 1. The online Registration (Application) process, available here on the ACPPGMEC website (www.medadmgujarat.org), which is applicable for:
 - (I) Admission for Government Seats of MD/MS (Ayurveda) and MD (Homeopathy)
 - (II) All India Quota (15%) Seats of Self-financed Ayurveda/Homeopathy Colleges
 - (III) Management (10%) & NRI Quota (15%) of Self-financed Ayurveda/Homeopathy Colleges for the academic year **2022-23** of Gujarat State
 - 2. All the candidates, who are qualified as per AIA-PGET-2022 criteria as well as AYUSH ministry, New Delhi guidelines, passed BAMS/BHMS from the universities of Gujarat state, are eligible for State Quota seats as well as for 15% SFI All India Quota seats and Management Quota seats of SFI Colleges;
 - 3. Candidates, who are qualified as per AIA-PGET-2022 criteria as well as AYUSH ministry, New Delhi guidelines, passed BAMS/BHMS from the universities of any state of India other than Gujarat are eligible only for 15% SFI All India Quota seats
 - 4. To participate in the admission process, the candidates have to purchase PIN through online payment of Rs. 2000/- and do online registration from the website: www.medadmgujarat.org by themselves, thereafter to complete the registration process, they must go to the Help Center with their required original certificates and registration slip within scheduled time. The candidates who fail to register and verify their documents within scheduled time by any means will not be considered for admission in any circumstances.

- b) AIA-PGET-2022 Marksheet
- c) For SEBC, ST and SC Category: Cast certificate issued by Competent Authorities of Gujarat State only
- d) *For SEBC Category:* Non-creamy layer certificate (Parishistha '4' in Gujarati/English) issued by Competent Authorities of Gujarat State only dated on or after 01/04/2020
- e) *For EWS (Economically Weaker Sections) Category:* EWS certificate issued by Competent Authorities of Gujarat State only dated on or after 01/04/2020
- f) *For PwD Candidate:* Disability Certificate issued by Competent Authority subject to verified by Medical Board of ACPUGMEC
- g) School Leaving Certificate
- h) 12 months' internship completion certificate with date i.e., on or before 31.12.2022
- Provisional / Permanent Registration of Gujarat Board of Ayurvedic & Unani System of Medicine OR Central Council of Indian medicine / Council of Homoeopathic System of Medicine Gujarat State OR Central Council of Homoeopathy
- j) Copy of Passport [if Citizenship is Dual/ Foreign]
