- (1) Admission for Vacant seats (after exhaustion of Merit List) of MD/MS (Ayurveda) and MD (Homoeopathy) Post Graduate Courses in Government & Self-financed Ayurveda/Homoeopathy colleges of Gujarat State for the academic year 2023-24
 - 1. The online Registration (Application) process, available here on the ACPPGMEC website (www.medadmgujarat.org), which is applicable for:
 - (I) Admission for Vacant seats (after exhaustion of Merit List) of MD/MS (Ayurveda) and MD (Homeopathy) Post Graduate Courses in Government & Self-financed Ayurveda/Homeopathy Colleges of Gujarat State for the academic year 2023-24 of Gujarat State.
 - 2. To participate in the admission process, the candidates have to purchase PIN through online payment of Rs. 2000/- and do online registration from the website: www.medadmgujarat.org by themselves, thereafter candidate has to upload required documents. No need to do Documents Verification and Submission of photocopies of Documents at Help Center.
