Consequent upon the reduction of NEET PG Merit vide Notice No. U-12021/05/2024-MEC dated 04-01-2025 of MCC, GOI, it is hereby notified for the information of all the concerning NEET PG qualified inservice candidates/Doctors that the Board is inviting the offline applications for admission to Post MBBS DNB Seats, Post Diploma DNB Seats & Post MBBS Diploma Seats (Broad Specialty) in prescribed proforma annexed as **Annexure-A** to this Notification w.e.f. **15-01-2025 to 17-01-2025**.

The candidates who fall within the ambit of revised eligibility and are willing to participate in the subsequent round of counseling against the seats that have remained unfilled during previous round of counseling or the seats that are vacant due to resignations are advised to apply as per **Annexure-A** to this Notification and submit all the requisite documents as mentioned in Notification No. 174–BOPEE of 2024 dated 26-11-2024 physically at BOPEE office Jammu/Srinagar w.e.f. **15-01-2025 to 17-01-2025.** The eligible candidates, who have not registered earlier but want to be considered themselves against the unfilled seat/seats may also submit their documents physically at BOPEE office Jammu/Srinagar for registration within the prescribed time schedule indicated here in above.

Note:

- 1. The candidates who are already registered vide Notification No. 174–BOPEE of 2024 dated 26-11-2024 need not to apply afresh.
- Mere registration of candidates does not confer any right to have a claim on any vacant seat(s) which as of now are to be filled up based on the merit/preference from the eligible/registered candidates.
- 3. The candidates should go through all relevant Notifications/Notices along with the e-Information Brochure notified by the Board from time to time.
- 4. Seat Matrix shall be uploaded a day before the start of counseling.
- 5. The other terms and conditions remain the same as contained in the e-information Brochure, Notifications/ Notices issued by the Board from time to time in this regard.
