- 1. The First meeting of the JIPMER Scientific Advisory Committee (JSAC) will be held tentatively on 4<sup>th</sup> January 2024
- 2. Prior to submission of the proposals to JSAC, all the proposals are required to be discussed in their respective department and a "review certificate" along with the attendance sheet of the review meeting should be attached with the JSAC proposal.
- 3. Please use the <u>combined format</u> comprising Section 1 (for JSAC), Section 2 (for Intramural Research Fund Committee). Please fill both Sections. The <u>combined format (https://jipmer.edu.in/research-proposal-format-jipmer-scientific-advisory-committee-jsac-and-intramural-research-fund ) is available on the JIPMER website under Research.</u>
- 4. An original hard copy of the research proposal and a Xerox copy of same along with covering letter addressed to Dean (Research) have to be submitted. The hard copy should be typed using both sides of A4 size paper, in 11 font size with 1.5 spacing and page numbering.
- 5. Soft copy of the proposal should be mailed to <a href="mailto:jipmerjsac@gmail.com">jipmerjsac@gmail.com</a> with a cc to their respective Head of the Department.
- 6. The last date for submitting proposal is **21.12.2023**
- 7. There can be only one co-investigator from the same department to discourage gift co-investigatorship. It applies to both the department of primary investigator and the department of collaborating investigator.
- 8. Research proposals deviating from the format will not be accepted. No subsequent modification of the proposals will be accepted.
- 9. Only citing and listing of references as per ICMJE (International Committee of Medical Journal Editors) style will be accepted.
