THIS WP IS FILED UNDER ARTICLES 226 AND 227 OF THE CONSTITUTION OF INDIA PRAYING TO ISSUE A WRIT DECLARING THAT THE GUIDELINES FOR UNDER GRADUATE COURSES UNDER ESTABLISHMENT OF NEW MEDICAL STARTING OF NEW MEDICAL COURSES, INSTITUTIONS, INCREASE OF SEATS FOR EXISTING COURSES AND ASSESSMENT AND RATING REGULATIONS, 2023 DATED 16/08/2023 BEARING NO.U.11022/2/2023-UGMEB (PRODUCED AS ANNEXURE-C) IS ULTRA VIRES THE CONSTITUTION OF INDIA AND ETC.

THIS PETITION, COMING ON FOR PRELIMINARY HEARING, THIS DAY, THE COURT MADE THE FOLLOWING:

<u>ORDER</u>

This captioned petition is filed questioning the Medical Institution Regulations, 2023 on an apprehension that the decision will be implemented retrospectively.

2. This Court vide order dated 26.02.2024 has granted stay of the implementation of Guidelines for undergraduates courses under establishment of New Medical Institutions by implementing 2023 Regulations dated 16.08.2023 as per Annexure-C.

3. Learned counsel for respondent No.2 has filed statement of objections and has clarified the apprehension of petitioners indicating that these Regulations will not be implemented retrospectively. Para 6 of the statement of



objections would be relevant and the same is extracted, which reads as under:

"That the Guidelines for Undergraduate Courses under Establishment of New Medical Institutions, Starting of New Medical Courses, Increase of Seats for existing Courses & Assessment and Rating Regulations, 2023, notified on 16.08.2023 are prospective in nature, and applicable from 16.08.2023".

4. In view of the clarification indicated in the statement of objections filed by respondent No.2, the captioned petition does not survive for consideration.

Accordingly, petition stands *disposed of*.

Respondent No.2, to avoid future litigations, shall

publish this clarification in its official website.
