PGET-2025 - Admission to Post Graduate Medical courses for the year 2025-26 in the state of Karnataka & admission to In-Service seats of DNB (Primary and Secondary) and Diploma (NBEMS)

- 1. KEA is inviting applications online for admissions to PG Medical courses from the eligible candidates who have qualified in NEET-PG-2025 for the year 2025-26 for the available PG Medical Degree / Diploma courses in Government Medical colleges, Government Quota seats in Private and Minority Medical Colleges and Private seats in Private Medical colleges (KPCF, KRLMPCA, AMPCK and Private Universities) located in the State of Karnataka for the academic year 2025-26.
- As per Government order No., HFW 882 HSH 2021 Bangalore Dated 10-01-2022, KEA is also inviting
 application online from the eligible Karnataka in-service candidates who have qualified in NEET-PG-2025
 and desirous of applying DNB / Diploma Courses in the State of Karnataka for the academic year 2025-26.
- 3. The candidates who have obtained more than or equal to the prescribed minimum 50th percentile in NEET PG 2025 only are eligible to register and apply online for PG Medical courses for the year 2025-26.
- 4. Non-Karnataka candidates will not be eligible for reservation. Hence, in the NEET-PG 2025 examination, if they have scored the required minimum 50th percentile or above, fixed for 'GENERAL (UR)' category as per the qualifying criteria, then only they are eligible to register for admissions through KEA or for any other seats in the State of Karnataka. Please note that SC/ST/OBC eligibility criteria are applicable to Karnataka SC/ST/OBC candidates only.
- Interested and eligible candidates can register, apply online and pay the fees for admission to Karnataka PG Medical Degree and Diploma courses from <u>11.00 am on 04-10-2025 up to 11.00 am on 09-10-2025</u>.
- 6. Registration fee, details of document verification, original documents to be submitted for document verification, and other details have been published on the KEA Website. Interested and eligible candidates can register by selecting the specified link on the KEA Website apply online and appear for document verification on the specified dates as per their eligibility.
- 7. Information Bulletin-2025 detailing admission eligibility criteria and other details are hosted on the KEA Website https://cetonline.karnataka.gov.in/KEA/pgetmed2025 for the information of the candidates. Before registering through online for admission to PG Medical courses in the state of Karnataka, applicants are hereby informed to read the Information Bulletin PGNEET-2025 and understand the eligibility conditions, educational qualification, classification of seats (different types of category of seats), procedure for conduct of online seat allotment and eligibility to claim such seats.
- 8. Mere qualifying in NEET-PG 2025 does not confer any right on the candidate for admission unless the candidate fulfils eligibility conditions / submits the documents / certificates. Further, only the candidates who complete the registration process including document verification are eligible for PG Medical seats in Government / Private Colleges in Karnataka.

NOTE: As per NMC, New Delhi letter dated 24-07-2023; all the rounds of counselling including Stray Vacancy Round will be conducted only by KEA in online mode, all the PG NEET qualified candidates are hereby advised to register online and complete the document verification process in KEA to become eligible for admission to PG Medical Courses in the State of Karnataka.
