NOTE

Online Registration, Verification of documents and seat allotment – due to lowering of qualifying percentile in NEET PG – 2024 for PG Medical seats.

NBEMS, New Delhi, in its notice dated 06-01-2025 has informed that the qualifying criteria for PG courses (Medical) for NEET PG counselling 2024 has been reduced to "15th Percentile" for General and "10th Percentile" SC/ST/OBC as per MoHFW. Please note that SC/ST/OBC eligibility criteria are applicable to Karnataka SC/ST/OBC candidates only.

In view of the lowering of the qualifying percentile for PG courses (Medical) for NEET PG counselling 2024, KEA online registration portal is enabled.

Hence, all the **PG Medical** candidates who are eligible due to lowering of qualifying percentile can register, submit the application online and pay the fees from 6.00 pm on 15-01-2025 to 18-01-2025 before 11.00 am to become eligible to participate in the Mop-up round seat allotment only for the available PG Medical seats along with other eligible candidates.

The PG Medical candidates who were eligible earlier but did not register can also register and complete the application process. The academic eligibility criteria as laid down in NEET-PG 2024 Information Bulletin and other conditions are hosted on the KEA Website for the information of the candidates.

The above newly registered PG Medical candidates have to appear on any day either on 16-01-2025 or 17-01-2025 or 18-01-2025 for verification and deposition of original documents at KEA, Bangalore to become eligible for seat allotment. Original documents to be produced for verification are detailed in the NEET-PG 2024 Information Bulletin.

All Originals and two set of photocopies to be produced along with final print of the application form, PGNEET-2024 Score Card, Identity card. Documents will not be verified for the candidates who fail to produce the required original documents as per their eligibility and they will not be eligible to participate in the mop-up round. Candidates are advised to ensure that they are carrying all the originals, before coming to KEA, Bangalore for verification.

Physical Disability candidates of PG Medical who got eligibility due to lowering of qualifying criteria should appear for medical examination along with relevant certificates and Identity card, on 20-01-2024 at 11.00 am, at KEA, Bangalore. (for the available seats if any)
