**Online Stray Vacancy Round for PG Dental – 2024**

**Online Registration, Verification cum Deposition of original documents and seat allotment**

*PG Dental candidates who were eligible but did not register, can register submit the application online and pay the fees from 11.00 am on 06-09-2024 to 08-09-2024 - 8.00 am and complete the document verification process to become eligible to participate in the Stray Vacancy Round seat allotment for the available PG Dental seats along with other eligible candidates.*

*Offline Documents verification will be conducted on 08-09-2024 from 11.00 am to 2.00 pm. Please read the PG Information Bulletin for submission of original documents, candidate who fails to submit the original documents will not be eligible for seat allotment.*

Online Stray Vacancy Round will be conducted for eligible candidates for admission to PG Dental courses. As per the directions of the Government, after allotment of seats in the mop-up round, the seats which remained unfilled and seats cancelled by the candidates after mop-up round will be hosted on the KEA Website for the information of the candidates. The seats which may get cancelled before stray vacancy round will also be considered for stray vacancy round. Candidates are advised to keep visiting KEA Website for updates.

The following types of candidates only are eligible to participate in the stray vacancy round.

Candidates who have not joined the college after allotment of seats in the PG Dental first round or second round or in mop-up round or in Stray Vacancy Round of All India Counselling including Counselling for Deemed Universities (subject to conditions if any, stipulated by GOI), and candidates holding the verification slip and who have not been allotted any seat in earlier rounds of state counselling.

**CAUTION DEPOSIT**

- Candidates who are willing to participate in the NEET MDS 2024 Stray Vacancy Round should deposit Rs.2,00,000/- (Two Lakhs only) for PG Dental courses as caution deposit to KEA. All category candidates should pay the caution deposit.
- If any eligible candidate who has paid the Caution deposit paid and did not allotted any seat in mop-up round, can participate with the same caution deposit if interested.
- Caution deposit has to be paid through online by downloading the challan from KEA website using candidate login credentials.
- If a candidate gets the PG Dental seat as the case may be, the caution deposit will be adjusted towards the fee.
- If a candidate gets the PG Dental seat in the stray vacancy round and fails to report to the college, caution deposit will be forfeited and the candidate has to pay the penalty as per rules.
- The candidate who fails to deposit the caution deposit will not be eligible to participate in the mop-up round.

**DEPOSITION OF ORIGINAL DOCUMENTS**

All the eligible candidates who are holding the verification slip and did not submitted the original documents to KEA should deposit the original documents on 08-09-2024 if they are interested in Stray Vacancy round. The candidates who have deposited originals and taken back the originals can also deposit the originals to KEA if they are interested. Any candidate who fails to deposit the originals to KEA will not be eligible to participate in the Stray Vacancy round.

**OPTION ENTRY**

- a. All the eligible candidates who deposit the caution deposit and submitted the original documents will be allowed to enter the options afresh.
- b. All the eligible candidates have to enter the new options for this PG Dental Stray Vacancy round. The options entered by them in the previous rounds will not be considered.
