**PG MEDICAL ADMISSIONS UNDER COMPETENT AUTHORITY QUOTA - 2024-25**

**Notification for exercising web-options for second phase of counselling for admissions into PG Medical degree/diploma courses under Competent Authority Quota in Medical Colleges affiliated to KNRUHS & NIMS**

In continuation to this office notifications dated: 30-10-2024, 29-12-2024, KNRUHS hereby notifies the conduct of 2<sup>nd</sup> phase of web-based counseling for allotment of the Post Graduate Medical Non-service/Service Quota seats under Competent Authority Quota for admission into PG Medical Degree / Diploma courses for 2024-25 in affiliated Medical Colleges and Nizam's Institute of Medical Sciences, Hyderabad.

Candidates (Non-service/Service) whose names are notified in the Provisional Final Merit list of PG Medical Admissions on the KNRUHS website on 29-12-2024 and corrigendum are eligible to exercise web-options online from computer with internet connection.

Eligible candidates (Non-service/Service) whose names are displayed in the Provisional final merit list on KNRUHS website on 29-12-2024 and corrigendum can exercise web options as per eligibility for admission into PG Medical Degree/ Diploma seats, including Service Quota seats from **06.00 A.M. on 07-01-2025 to 06.00 P.M. on 08-01-2025** through website <https://tspgmed.tsche.in> subject to following conditions:

1. The Candidates who were allotted seats in the first phase of counseling and have not reported/discontinued the course after joining at the respective college are not eligible for exercising web-options.
2. Candidates who have not exercised web options in the first phase of counseling are also not eligible to exercise web options.
3. The candidates who were allotted PG Medical seats in the first phase of counseling and joined the course and continuing in the course are eligible to exercise web options and are informed to exercise web options for PG Medical Degree / Diploma seats.

For eligibility criteria and regulations refer to notifications dated: 30-10-2024

**UNIVERSITY FEE:** Allotted Candidates have to pay University fee of Rs.29,600/- by way of online payment gate-way and download the allotment letter. Candidates who have already paid University fee in the 1<sup>st</sup> phase need not pay again.

**TUITION FEE:** Tuition fee is to be paid at respective Medical colleges. The tuition fee payable as notified by Government of Telangana in G.O.Ms. No. 107 HM& FW(C1) Dept. Dated: 28.07.2023 (notified on website).

The allotment of seats will be made in accordance with the existing Government orders and relevant Hon'ble Supreme Court and Hon'ble High Court orders.

**IMPORTANT NOTE: All the candidates are hereby informed that the allotments and admissions are subject to the orders of Hon'ble Supreme Court in pending SLP(c).**

**Instructions to Candidates:**

- 1) The details of vacant seats available (seat matrix) are placed in the website <http://knruhs.telangana.gov.in> . Candidates can exercise web options for PG Medical Degree / Diploma Courses in all Medical Colleges affiliated to KNRUHS through <https://tspgmed.tsche.in> as per eligibility.
- 2) Competent Authority Quota seats in Minority Medical Colleges will be allotted to Muslim Minority Candidates only. Muslim Minority Candidates are also eligible for Competent Authority Quota seats in other Medical Colleges.
- 3) Eligible Non-service Candidates as per provisional final merit list can exercise web options for Post Graduate seats in all affiliated Medical colleges and Nizam's Institute of Medical Sciences as per their eligibility, interest and priority.
- 4) Eligible Service Candidates whose names are displayed in the provisional final merit list of PG Medical Admissions on KNURHS website can exercise web options for PG Degree/ Diploma seats notified under service quota seat matrix for Medical Colleges affiliated to KNRUHS.
- 5) **In view of reduction of NEET-PG cut-off score, eligible service candidates are informed that conversion of vacant Service Quota seats to Non-service Quota**

**shall be done after Mop up Phase of allotments. After Mop UP Phase of allotment for service quota seats the unallotted seats will be added to respective non-service Quota of seats. Notification for registration of candidates as per revised cut-off score shall be issued shortly as per the schedule to be notified by MCC.**

- 6) Candidates are advised to go through the prospectus of KNRUHS and the Government orders on Rules of PG admissions available on website before exercising web options for the regulations.
- 7) Candidates exercising web-options for PG Medical Degree / Diploma courses are informed that there is no limit of choices (number) for exercising web-options. Candidates can exercise web options for any number of subjects and colleges the candidate is interested to join as per candidate's eligibility.
- 8) Candidates are advised to exercise web options for PG seats in all courses and colleges in which they are interested to join irrespective of available seats shown in the seat matrix, as vacancies will arise during counseling process due to sliding of candidates from allotted seats in first phase of counseling to other seats as per their web options in the second phase of counseling. If candidates are not interested to join in any subject or college they should not exercise web options for the same.
- 9) If a PG seat is allotted in this phase of counseling as per web options exercised by the candidate, the seat allotted in 1st phase of counseling will be automatically cancelled and allotted to the other candidate. Therefore, the candidates are informed to exercise web options carefully for sliding with awareness of this fact.
- 10) As notified in MCC PG Information Bulletin, candidates admitted upto 2nd phase shall be permitted for upgradation upto Mop up phase of counseling. The admitted candidates are permitted to exercise web options for mop-up phase of counseling. They will not be allowed to participate in any further phases of Counseling after joining in Mop up Phase of Counselling of State Quota.
- 11) Candidates in the merit list are informed that if they do not exercise web options in the first phase of counseling, they are not eligible to exercise web options in subsequent phases of counseling to prevent seat blocking.
- 12) **IMPORANT NOTE:** Candidates are informed that if they exercise web- options for a seat and allotted a PG seat as per their choice in the web-counseling and if they do

not join the course at the allotted college, they will not be eligible for exercising web-options for subsequent rounds of counseling.

- 13) Candidates can exercise options on the web through a computer either from home / any other place having internet facility.
- 14) One Time Password (OTP) will be sent to the registered mobile at the time of saving web options. The password consists of SIX letter code with English capitals A to Z (for details read instructions to the candidates before giving options).
- 15) Candidates are instructed to take a print out of saved options.
- 16) Candidates will receive SMS message on their registered mobile after allotment of seat, if allotted. Candidates are also directed to check their allotment status on <https://tspgmed.tsche.in> website after each phase of counseling without fail.
- 17) The selected candidates shall download the allotment letter from website after payment of the University fee by payment gateway by using Online payment method. (Debit Card/Credit Card/Internet Banking). Candidates should check their allotment details and report to the Principal of respective Medical College on or before the last date specified on the allotment letter.
- 18) Candidates are hereby informed that final verification of original certificates will be conducted at the allotted college and in case of any discrepancy, the provisional allotment will be cancelled and action may be initiated as per University Regulations.
- 19) Selected candidates have to report at the respective Medical Colleges before the last date for joining as specified on the allotment letter, submit all original certificates, the relevant bonds and pay the tuition fee / college fee to complete the process of admission. If the candidate does not fulfill the above criteria to complete the admission process within the specified date, the admission will be cancelled automatically and the candidate will not be permitted to exercise web options for subsequent rounds to prevent seat blocking.
- 20) If the candidate slides to other college during second phase of counseling, the candidates have to get relieved from first phase joined college, collect all original certificates, fees and report to the Principal of allotted college before last date of joining. Candidates who do not join the course at the allotted college in this phase of counseling are not eligible for further phases of counseling.

21) The University fee and other fees once paid shall not be refunded under any circumstances.
