### **NOTIFICATION FOR ADMISSION INTO MDS COURSES UNDER COMPETENT AUTHORITY QUOTA FOR 2025-26 IN TELANGANA**

Online Applications are invited from NEET-MDS-2025 qualified candidates for admission into the MDS courses for the academic year 2025-26 under Competent Authority Quota (CQ) into Dental Colleges affiliated to KNR University of Health Sciences including Army Dental College in the State of Telangana.

Notification is issued for online registration for web-based counseling to determine State Merit position for admission into **Competent Authority Quota (CQ)** seats only. Provisional Final Merit list will be notified after scrutiny of all certificates uploaded at the time of online registration. Total number of seats available under Competent Authority Quota for the academic year 2025-26 will be notified on KNRUHS website before exercising web options for counseling. Tuition fee payable will be as notified by the Government of Telangana.

#### **Cut-off score in NEET-MDS-2025 Exam for MDS courses:**

Candidates should have secured the following cutoff score or above in NEET-MDS-2025

#### **Schedule of registration of online application and uploading of certificates.**

Candidates can register online and upload scanned certificates on website <https://tsmds.tsche.in> from **8.00AM on 27-06-2025 to 01-07-2025 up to 5.00PM** only

**Provisional Final Merit position of the applied candidates will be prepared based on NEET-MDS–2025 Rank and other eligibility criteria notified hereunder.**

**1. ELIGIBILITY:**

- a) Candidate should have qualified in NEET-MDS-2025 by securing marks of Cut-off score or above as displayed above.
- b) Candidate should have passed BDS/Equivalent Degree examination from a Dental Institution in Telangana recognized by the Dental Council of India.
- c) Candidates who hold recognized Dental Degree should have obtained Permanent Registration from Dental Council of India / State Dental Council after completing compulsory rotating internship.
- d) The Candidate should be Indian National, Person of Indian Origin/Overseas Citizen of India card holder and shall fulfill the following provisions:
  - i. If the candidate has studied in Educational Institutions in such local area for a period of not less than four consecutive academic years ending with the academic year in which he appeared or as the case may be first appeared in the relevant qualifying examination.
  - ii. Local area herein means the State of Telangana.
- e) The rules for admission into MDS courses under Competent Authority Quota have been issued by Government vide G.O.Ms. No. 27, HM&FW, C1, Dept., Dated: 10-04-2017, subsequent amendments and G.O.Ms.No. 62, HM&FW, C1, Dept., dated 27-07-2024 and G.O.Rt. No. 439 HM&FW (C1) dated 03-08-2024, G.O.Ms.No. 10, Scheduled Castes Development (POA.A2) Department, dated 14.04.2025. These rules are strictly applicable for entire admission procedure (eligibility criteria, seat matrix, reservations, selection procedure etc.). Relevant Hon'ble Supreme Court and Hon'ble High Court orders will be followed.
- f) BDS Graduates should have completed internship on or before 31.03.2025.
- g) In case of in-service candidates, Government service rendered shall be calculated as on **31-03-2025**.

**2.** The NEET MDS 2025 qualified and eligible candidates as per concerned regulations who desire to take admission into MDS Courses shall apply online and upload all original certificates for determining the Merit position for Telangana State Competent Authority Quota using NEET-MDS-2025 Ranks in the Website <https://tsmds.tsche.in>

from **8.00AM on 27-06-2025 to 01-07-2025 up to 5.00PM** only. The online application can be filled through any computer with internet connection. **(NOTE: PREFERBLY DESKTOP OR LAPTOP)**

- 3. Registration and Processing Fee:** - The Registration and processing fee of Rs.7,000/- (Bank transaction charges extra) is for OC & BC candidates and Rs.5,500/- (Bank transaction charges extra) for SC/ST candidates. The fee shall be paid online through Debit card / Credit card or Net Banking.

**\*\* Registration and processing fee once paid will not be refunded or adjusted to a further date.**

**Candidates are advised to check their eligibility to apply for determining the Merit position in respective categories by using NEET-MDS-2025 Rank by reading Prospectus /Regulations carefully.**

**4. Procedure for filling online application, scanning / uploading of original certificates and online payment for registration.**

- i. The registration and processing fee can be paid through Debit card / Credit card or Net Banking
- ii. The registration and processing fee paid by the applicants is not refundable under any circumstances.
- iii. **The following documents are required:**
  - (a) Passport size photo
  - (b) Admit Card and Rank Card NEET–MDS 2025
  - (c) Original / Provisional Degree Certificate
  - (d) Aadhaar Card
  - (e) Study Certificate(s) from 1<sup>st</sup> BDS to Final BDS.
  - (f) Latest Category Certificate in case of BC/SC/ST candidates issued by Competent Authority of Government of Telangana (If applicable).
  - (g) Latest Service Certificate issued by the concerned Head of the

Department, if applicable (issued after 31-03-2025 by DME/DH/Director ESI/ Commissioner VVP/ MD Singareni Collieries and other Competent Authority as notified by Government).

- (h) Internship Completion Certificate/ to be completed by 31.03.2025.
  - (i) Permanent Dental Council Registration Certificate.
  - (j) Photo Identity proof (Aadhaar).
- iv. Visit website through Computer with Internet connection to fill the application form.
  - v. Fill in all the details in the online application form and upload all the documents which are mandatory.

**5. Procedure for submission of filled-in online Application form and original certificates for MDS Courses at the time of admission for final verification: -**

The candidate should submit the print-out of the filled-in Online application form and original certificates along with (1) set of self-attested copies to the Principal of allotted college at the time of admission for final verification. In case of any discrepancy, the provisional allotment order will be cancelled.

- 6. a). On-line application form without uploading mandatory Certificates, Passport size photo, without signature at declaration area, incomplete applications will be automatically rejected and will not be considered for determining the Merit position in respective categories using NEET– MDS – 2025 Rank.**
- b).** The mere fact that the Merit position issued to the candidate does not imply that the candidature is accepted by the University and it does not mean that the entries made by the candidate in the online application are accepted as true and correct.
  - c)** Candidates may please note that the University will take up the verification of certificates with regard to eligibility conditions i.e., Educational Qualifications, validity of Registration with DCI/State Dental Council, Internship certificate, Local status, Category status as per uploaded relevant certificates by the concerned department officials.

<p><b>If the information furnished by the candidate in the application is not correct, his/her candidature is liable to be cancelled and further action that deems fit will be taken.</b></p>

- d). Eligibility of candidates for admission into MDS courses for the academic year 2025-26 will be examined by the University only after scrutiny of application along with all copies of required certificates and provisional final merit list will be notified.
- e). **Registration along with uploading of Scanned Original certificates will be done only once irrespective of the number of times of exercising web options / Number of counsellings.** No separate notification will be issued for verification of original certificates. Therefore, the candidates should register and upload all the mandatory certificates without fail.
- f). Scrutiny of uploaded Original Certificates shall be done by the University and concerned departmental officials. After scrutiny of application and certificates final merit list will be released.

**Candidates are advised to refer to KNRUHS website for further details regarding schedule for exercising web options.**

7. Admissions will be in accordance with the Orders issued from time to time by State Government with regard to process of Admissions to MDS Courses and relevant Hon'ble Supreme Court and Hon'ble High Court orders. The procedure for preparation of seat matrix and selection into MDS courses in the Competent Authority Quota and seat allocation will be done as per the procedure given in G.O.Ms.No.27 HM&FW(C1) Dept, Dated:10-4-2017, G.O.Ms.No.62 HM&FW(C1) Dept, Dated: 27-7-2024, G.O.Rt. No. 439 HM&FW (C1) dated 03-08-2024, G.O.Ms.No. 10, Scheduled Castes Development (POA.A2) Department, dated 14.04.2025 and relevant Government orders, subsequent amendments and relevant Hon'ble Supreme Court and Hon'ble High Court orders.
8. This notification is for determining the State Merit position in respective categories using NEET–MDS -2025 Rank only. The dates for exercising web options for admission into MDS courses will be notified separately on university website.

**Candidates are advised to check the University web-site for notifications, schedules and other details from time to time.**

9. An in-eligible candidate obtaining Merit position does not make the candidate eligible for admission
10. Admission will be considered only for candidates, who have secured marks above cutoff score in NEET-MDS-2025 exam and based on the state merit position as the case may be.
