In continuation to this office notifications dated 09-11-2024, 03-01-2025 and in accordance with Letter No. U12021/05/2024-MEC Dated: 04.01.2025 from Ministry of Health and Family Welfare Government of India, KNRUHS hereby notifies online registration from NEET-PG-2024 qualified candidates who have become eligible after revision of NEET-PG-2024 cut-off score detailed below for admission into PG Medical courses for the academic year 2024-25 under **Management Quota** in affiliated Private Medical Colleges in the State of Telangana.

Notification is issued for online registration to determine Merit position for webbased counseling for admission into **Management Quota** seats. Updated Provisional Merit list will be notified after scrutiny of all certificates uploaded at the time of online registration. Tuition fee will be as notified by the Government of Telangana in G.O.Ms.No.107 HM&FW (C1) Department, Dated:28-07-2023.

This notification is for online registration for Management Quota seats only. Candidates have to register separately for Competent Authority Quota seats in response to notification issued by KNRUHS for Competent Authority Quota online registration.

Final verification of original certificates will be conducted at the time of admission at allotted college by Admission Committee.
