MBBS ADMISSIONS UNDER COMPETENT AUTHORITY QUOTA FOR THE ACADEMIC YEAR 2025-26

NOTIFICATION FOR EXERCISING WEB-OPTIONS FOR SECOND PHASE OF COUNSELING

In continuation to this office notifications dated: 15.07.2025, 25.07.2025, 08.09.2025, 12.09.2025 & 15.09.2025, Kaloji Narayana Rao University of Health Sciences hereby notifies to conduct the second phase of web-based counseling for vacant seats and enhanced seats in Nova Institute of Medical Sciences, Hyderabad from 150 seats to 200 seats under Competent Authority Quota (CQ) for admission into MBBS course including EWS, PWD, PMC, CAP categories for the AY 2025-26 in Government, Private Un-aided Non-Minority & Minority Medical Colleges in the State of Telangana.

Candidates whose certificates were uploaded at the time of online registration and provisionally verified by staff of concerned departments and whose names are notified as eligible candidates in the final merit list of UG Admissions on the KNRUHS website on 15.09.2025 are eligible to exercise web - options through online from computer with internet connection.

All the eligible candidates whose names are displayed in the final merit list including EWS, PWD, PMC, CAP categories candidates on KNRUHS website can exercise web options for admission into MBBS course from 01.30 PM on 25.09.2025 up to 02.00 PM on 27.09.2025 through website https://tsmedadm.tsche.in/ subject to following conditions;

- 1. The Candidates who were allotted seats in the first phase of counselling and have not reported/discontinued the course after joining at the respective colleges are not eligible for exercising options.
- 2. Candidates who have not exercised web options in the first phase of counselling are not eligible to exercise web options.
- 3. The candidates who were allotted MBBS seats in the first phase of counselling and joined into the course and continuing the course are eligible to exercise web options.

For eligibility criteria and regulations refer to notifications dated: 15.07.2025.

UNIVERSITY FEE: Allotted Candidates have to pay University fee of Rs. 12,000/- for MBBS Course through payment Gateway by using Online payment method. (Debit Card/Credit Card/Internet Banking) and download the allotment order. Candidates who have paid University fee in the first phase of counselling and if slides in second phase of counselling need not pay the University fee again.

TUITION FEE: Tuition fee is to be paid at respective Medical Colleges.

The tuition fee payable as notified by the Government of Telangana.

 Candidates can exercise web options for MBBS seats
 in all Medical Colleges affiliated to KNRUHS through https://tsmedadm.tsche.in/.
- 2. The allotment of seats will be made in accordance with the selection procedure notified in Government orders G.O.Ms.No. 114, HM&FW(C1) Dept., Dated: 05.07.2017, subsequent amendments, G.O. Ms. No. 125, Health, Medical and Family Welfare (C1) Department Dated: 22.09.2022, G.O. Ms. No. 75, Health, Medical and Family Welfare (C1) Department Dated: 04-07-2023, G.O. Ms. No. 33, Health, Medical and Family Welfare (C1) Department Dated: 19-07-2024, G.O.Ms.No. 10, Scheduled Castes Development (POA.A2) Department, Dated: 14.04.2025, G.O.Ms.No. 150, Health, Medical and Family Welfare (C1) Department Dated: 08.09.2025 and relevant Hon'ble High Court/Supreme court orders and University regulations.
- 3. Candidates are informed that if they exercise web- options for a seat and allotted MBBS seat as per their choice in the web- counseling and if they do not join the course at the allotted college, they will not be eligible for exercising web- options for subsequent rounds of counseling.

IMPORTANT INSTRUCTIONS TO THE CANDIDATES:

- Eligible NEET-UG-2025 qualified candidates as per final merit list for Competent
 Authority Quota and reported candidates in the first phase of counselling can exercise
 web options for MBBS course into the affiliated Medical colleges of KNRUHS as per
 their interest and priority through https://tsmedadm.tsche.in/ from computer with
 internet connection.
- Candidates are advised to go through the Prospectus for the Regulations for admission into MBBS course and Government Orders on Rules of Admission on KNRUHS website before exercising web-options.
- 3. If a candidate is allotted a seat in MBBS course as per his/her options and does not join the course, they shall not be permitted to exercise web options in subsequent phases of counseling to prevent seat blocking.
- 4. Candidates exercising web-options for MBBS course are informed that there is no limit of choices (number) for exercising web-options. Candidates can exercise web options for any number of colleges the candidate is interested to join as per candidate's eligibility.
- 5. Candidates are advised to exercise web options for MBBS seats in all colleges in which they are interested to join irrespective of available vacant seats shown in seat matrix, as vacancies will arise during counseling process due to sliding of candidates from allotted seats in first phase of counseling to other seats as per their web options in the second phase of counselling. If candidates are not interested to join in any college, they should not exercise web options for the same.
- 6. If a seat is allotted in this phase of counseling as per web options exercised by the candidate, the seat allotted in 1st phase of counseling will be automatically cancelled and allotted to the other candidate by order of merit and as per their options. Therefore, candidates are informed to exercise web options carefully for sliding with awareness of this fact and to join the allotted/slided seat in second phase of counselling failing which the seat will be cancelled automatically and the candidate is not eligible for further phases of counselling.
- 7. Competent Authority Quota seats in Minority Medical Colleges will be allotted to Muslim Minority Candidates only. Muslim Minority Candidates are also eligible for Competent Authority Quota seats in other Medical Colleges.
- 8. Candidates are informed that if they do not exercise web options and not reported candidates in the first phase of counseling, they are not eligible to exercise web options in second and subsequent phases of counseling to prevent seat blocking.

- 9. One time pass word will be sent to the registered mobile number at the time of exercising web-options. The pass word consists of SIX letter code with English capital A to Z. (For details read instructions to the candidates before giving options).
- 10. Candidates are instructed to take a print out of saved options.
- 11. Candidates will receive SMS message on their registered mobile after allotment of seat and sliding of the college, if allotted. Candidates are also informed to login to check their allotment status on https://tsmedadm.tsche.in/ website after each phase of counseling.
- 12. The selected candidates shall download the allotment order from the website after payment of the University fee by gateway method by using online payment method. (Debit Card/Credit Card/Internet Banking). Candidates should check their allotment and report to the Principal of respective Medical College on or before the date specified on the allotment order.
- 13. Selected candidates have to report to the Principal of the respective Medical College before the last date for joining as specified on the allotment order, submit all original certificates, relevant bonds and pay the tuition fee/college fee to complete the process of admission. If the candidate does not fulfill the above criteria to complete the admission process within specified date for joining, the admission will be cancelled automatically and the candidate's options shall not be considered for second and subsequent phases of counseling to prevent seat blocking.
- 14. If the candidate slides to other college during second phase of counseling in colleges affiliated to KNRUHS, the candidates have to get relieved from first phase joined college, collect all original certificates and fees and to report before the Principal of slided college before the last date of joining into the slided college. Candidates who do not join the course at the slided/allotted college in this phase of counseling are not eligible for further phases of counseling.
- 15. Candidates are hereby informed that final verification of original certificates will be conducted at the allotted/slided Medical College and in case of any discrepancy, the provisional allotment will be cancelled and action will be initiated against the candidate & parent as per University regulations.
- 16. Original certificates submitted at the time of admissions shall not be returned to candidate, unless the candidate discontinues the course.
- 17. The University fee once paid shall not be refunded under any circumstances.
