NOTICE

Sub: Final opportunity for FMGE qualified candidates to collect their FMGE Pass Certificates

- 1. Candidates who are declared qualified in Foreign Medical Graduate Examinations (FMGE) conducted by the National Board of Examinations in Medical Sciences (NBEMS) are issued FMGE Pass Certificates after in-person verification of identity and documents prescribed towards eligibility for examination.
- 2. All such candidates of FMGE conducted upto June 2023 session and were declared qualified in them but have not collected their FMGE Pass Certificates from NBEMS were given a LAST OPPORTUNITY to collect the same latest by **28th February 2024**, **vide NBEMS notice dated 17.10.2023**.
- 3. It has been observed that some candidates have failed to collect their FMGE Pass Certificates even by 28.02.2024. Candidature of all such candidates was cancelled by NBEMS for respective FMGE qualified. Subsequently, some candidates have represented before NBEMS for being given another opportunity to collect their FMGE Pass Certificates.
- Accordingly, all such FMGE qualified candidates who have failed to collect their FMGE Pass Certificates in response to NBEMS notice dated 17.10.2023 are being given another opportunity to collect the same latest by 30th August 2024.
- Further, the last date for collection of FMGE Pass Certificate for December 2023 session is also extended from 6th August 2024 to 30th August 2024. The clause 10.7 of the information bulletin for FMGE December 2023 and entry slips issued to collect Pass Certificates should be read accordingly.
- Such qualified and eligible candidates shall be required to seek prior appointment from NBEMS to collect their FMGE Pass certificate by sending a request at the Communication Web portal (CWP) of NBEMS.
- 7. Such candidates are required to be present at NBEMS Office, PSP Area, Sector- 9, Dwarka, New Delhi as per their scheduled appointment to collect their Pass certificates. Documents to be brought shall be informed while scheduling the appointment.
- 8. The FMGE Pass certificate will be issued only on production of prescribed documents and on verification of identity, including biometrics/Face ID, as may be applicable.
- 9. The Pass Certificates shall NOT be issued to any authorized representative or any person other than the candidate himself/herself under any circumstances.
- 10. In an event an FMGE qualified candidate who has not collected his/her FMGE Pass Certificate till date fails to collect the same even by 30.08.2024, it will be assumed that he/she does not possess required documents to fulfil eligibility and therefore, his/her candidature for said FMGE qualified would continue to remain cancelled/ stand cancelled. No further opportunity to claim the FMGE Pass Certificate shall be extended.
