❖ **Eligibility of Candidates for CAP online Stray Vacancy round:**

1. NEET UG 2024 qualified candidates who have registered but not been allotted a seat till Round 3.

❖ **Non Eligibility for CAP online Stray Vacancy round :**

1. Candidates who have joined seat in Round 1, Round 2 and/or allotted a seat in Round 3.
2. Candidates who have joined seat in Round 1, Round 2 and/or allotted a seat in Round 3. of All India Quota seats
3. Candidates who were allotted a seat in Round 3 but failed to join the allotted seat.

**Note :**

1. No new registration will be done for this CAP online Stray Vacancy Round.
2. Candidate will have to fill fresh choices for CAP Online Stray Vacancy. ***Choice filled during Round 3 will be null and void.***
3. ***It is mandatory to join the seat allotted during Online Stray Vacancy Round(s) hence candidates are advised to be vigilant and fill only those choices where they intend to take admission.***
