The Reporting will start from **4th July, 2025** as per schedule.

Candidates/ Institutes are advised to note the following important points:

- 1. All admissions must be carried out strictly through the MCC's INTRAMCC portal.**
 - Institutes are required to log in to the INTRAMCC portal to complete the admission formalities of candidates allotted to them in the counselling rounds conducted by MCC.
- 2. Generation of Admission Letter via the INTRAMCC portal is mandatory.**
 - Once the admission is confirmed, the Admission Letter must be generated online through the INTRAMCC portal only.

- This letter serves as the official proof of admission.

3. Offline admissions will not be recognized.

- Any admission taken through offline mode, or for which the Admission Letter is not generated through the INTRAMCC portal, will be treated as null and void.
- Such admissions will not be considered valid under any circumstances.

3. Candidate Responsibility:
