Those candidates who have been found Eligible so far (as per list attached) need not send their documents again. Candidates are advised to send all documents enclosed in single mail only, within stipulated time.

The eligibility of candidates for seats reserved for NRI is 'Provisional' based on the documents submitted by the candidates which will be verified by the allotted college authorities at the time of reporting and the Embassy Certificate will be sent to the Ministry of External Affairs/ respective High Commissions for verification. If found 'FAKE' at any point of time, the Provisional Allotment of candidate will be cancelled and action will be initiated by the competent authority against the candidate and the allotted college.
