1. The following are the regulations for admission into M.D. (Homoeo) courses available at the colleges affiliated to Dr. YSR University of Health Sciences, A.P., Vijayawada for the academic year 2023-24.

2. NUMBER OF SEATS:

- a. The admission procedure as per G.O.Ms. No.13 is subject to orders and other Govt. from time to time.
- b. 15% of seats from each specialty and each college are surrendered to All India Quota from the above intake

3. ELIGIBILITY FOR ADMISSION:

3.1 As per the guidelines issued by the Ministry of AYUSH, Govt. of India the students who secured the below noted minimum marks or above in All India AYUSH Post Graduates Test (AIAPGET) 2023 and applied to the University are only eligible for admission into MD (Homoeo) courses 2023-24.

- 3.2Those who have passed the BHMS Degree Examination after undergoing a course of study in Homoeopathy of not less than 5 $\frac{1}{2}$ years duration including the period of compulsory internship; or
- 3.3 Those who passed equivalent Degree Examination included in the 2nd schedule of Homoeopathy Central Council Act 1973.

- 3.4 The candidates should have completed internship by **31.10.2023** and they shall submit a Certificate to that effect.
- 3.5. All candidates/Institutes participating in PG Counselling 2023 are informed inrespect of submission of following mandatory documents at the time of reporting at the allotted institute.

As per the NCISM/NCH letter No.BUSS/Admission Counsel (PG) 2023-24, Dt.19.09.2023 candidate should upload the following documents through online

(i). Twelve months Compulsory Rotatory Internship Completion Certificate:

Candidates who are going to complete their **Twelve months Compulsory Rotatory Internship** by 31.10.2023 as prescribed by the NCH, are instructed to submit an undertaking **(Annexure - iv)** counter-signed by the head of the institution (The institution from where internship is being perused) through online. Further, such candidates must submit their original compulsory rotatory internship certificate at the allotted institute **on or before the last date for reporting as specified in allotment order (if seat is allotted) to the allotted institutes for 1st Round of PG Counseling, otherwise, his/her admission shall stand cancelled. The vacant seats thus arose, if any shall be added to 2nd round counselling and filled as per Rules.**

(ii). BHMS Degree certificate/Provisional Degree Certificate:

If a candidate is not able to produce a valid Original Degree Certificate due to non-completion of internship at the time of applying for PG Counselling, in that case, the candidate shall submit an undertaking stating that he/she will submit the valid Original Degree Certificate to the allotted institute (if seat is allotted) on or before the commencement of date of PG Course (i.e., 01st December, 2023) for the academic session 2023-24 as per NCH/State Homeopathy.

(iii). Permanent Registration certificate issued by NCH.

Candidates who are not going to complete their **Twelve months Compulsory Rotatory Internship** at the time of applying for PG Counselling, are instructed to submit a copy of the **Provisional Registration Certificate** at the time of reporting. Further, such candidates shall submit their Original Permanent Registration certificate at the allotted institute on or before the commencement of date of PG Course (i.e. **Olst December, 2023) for the academic session 2023-24** as already informed by NCH.

(iv). Transfer Certificate/College leaving Certificate:

Candidates who are not going to complete their Twelve months Compulsory Rotatory Internship at the time of applying for PG Counselling, are instructed to upload an undertaking (Annexure-V) stating that he/she will submit the Transfer Certificate/College leaving Certificate on or before the last date for reporting to the allotted college as specified in allotment order, for 1st Round of PG Counseling.

- 3.6 Candidates who are already admitted and studying MD (Homoeo) Courses are not eligible for admission into MD (Homoeo) course unless they discontinue the course by remitting the bond amount and the stipend taken upto that date before submitting application form and such candidates shall submit the discontinuance certificate issued by the Head of the Institution along with the application.
- 3.7 Candidates who are already holding a Post Graduate Degree in Homoeo in a subject shall not be eligible for admission into another PG Homoeo Courses.

4. MERIT LIST:

- 4.1. There shall be a committee appointed by Dr.YSR UHS for selection of candidates against Competent Authority seats as per the merit list of PG HOMOEO.
- 4.2. The merit position of the candidates applied shall be determined basing on AIA-PGET Ranks and as per their eligibility.

5. RESERVATION:

- 5.1 15%, 6% and 29% of the seats available in each course shall be reserved for SC, ST and BC respectively. The 29% of seats for BC shall be distributed as BC-A-7%, BC-B-10%, BC-C-1%, BC-D-7% and BC-E-4% as per the availability of seats.
- 5.2 A candidate claiming reservation under clause 5.1 shall produce a certificate of his/her social status in the form specified and appended in the Annexure I to the application.
- 5.3 As the number of seats in a each specialty in each University area are less, the net Group shall be maintained for equal distribution of seats among the various categories.
- 5.4 The seats reserved for the SCs shall be made available to the STs and vice-versa, if qualified candidates are not available in these categories. The seats reserved for both SCs and STs shall be made available to the candidates in general pool, if qualified candidates belonging to the SCs and STs are not available.

5.5. RESERVATION FOR ECONOMICALLY WEAKER SECTIONS (EWS):

The reservation of 10% in favour of Economically Weaker Section (EWS) candidates who are not covered under existing scheme of reservation for SC/ST & BCs will be made as per the procedure/ guidelines issued by the Government of AP in the Government Medical Colleges where additional seats are permitted by Govt. of India for the purpose. The persons seeking the benefit of reservation under EWS category shall obtain the Income & Asset Certificate for Economically Weaker Section (EWS) valid for the academic year 2023-24 issued by the Tahsildar on or after **01.04.2023**, who is the competent authority in state.

6. Service Weightage:

6.1 The service candidate shall be awarded extra weightage of marks on length and type of service as follows as on **30.09.2023**.

Rural service - 8% per each year upto maximum of 3 years.

Tribal service - 10% per each year upto maximum of 3 years.

- 6.2. An in-service candidate is one who has put in a minimum of three years of regular Service in Rural & Tribal areas.
- 6.3. Those in-service candidates who are having the remaining service of a minimum of eight (8) years as on the date of admission are only eligible to apply for the said seats.

7. Persons with Disability:

- 1. Out of the available seats for admission by the Dr. YSR University of Health Sciences, 5% shall be reserved for the Persons with Disability (PwD) in each categories of OC, SC, ST, BC-A, BC-B, BC-C, BC-D and BC-E as per Government of India guidelines as per the availability of seats.
- 2. The candidates seeking the benefit of reservation under PwD category should enclose a valid disability certificate issued not later than three months (03) prior to submitting his/her application.

3. The Medical Board constituted by the University will scrutinize/verify the disability certificates as per G.O. MS.No.31, Women development, Child welfare & disabled welfare (DW) department, dated.01.12.2009 and candidates claiming reservation under PwD quota for conformation of eligibility and the decision of Medical Board specially constituted for the purpose is final and binding on the candidates.

The candidate seeking the benefit of reservation should present him/herself before a Medical Board to be constituted by Dr.YSR UHS, Vijayawada.

8. RESERVATION IN FAVOUR OF LOCAL CANDIDATES:

Admission to 85% of the seats specified in Regulation 2 above shall be reserved in favour of the local candidates and 15% of seats shall be unreserved as per Presidential Order, 1974.

9. LOCAL AREA:

- 9.1 The part of the State comprising the Districts of Srikakulam, Vizianagaram, Visakhapatnam, East Godavari, West Godavari, Krishna, Guntur and Prakasam shall be regarded as the local area in respect of the Andhra University and the Nagarjuna University area.
- 9.2 The part of the State comprising the Districts of Adilabad, Hyderabad (including the twin cities of Hyderabad and Secunderabad), Rangareddy, Karimnagar, Khammam, Medak, Mahaboobnagar, Nalgonda, Nizamabad and Warangal shall be regarded as the local area in respect of the Osmania University and the Kakatiya University area.
- 9.3 The part of the State comprising the Districts of Anantapur, Kurnool, Chittoor, Kadapa and Nellore shall be regarded as local area in respect of S.V. University area and the Sri Krishnadevaraya University area.

10. LOCAL CANDIDATES:

- 10.1 A candidate for admission to any course of study shall be regarded as local candidate in relation to a local area.
- 10.1.1. If he/she has studied in an educational institution(s) in such local area for a period of not less than four consecutive academic year ending with the academic year in which he/she appeared or as the case may be first appeared in the relevant qualifying examination or
- 10.1.2 Where, during the whole or any part of the four consecutive academic years ending with the academic year in which he/she appeared or, as the case may be first appeared for the relevant qualifying examination. If he/she has not studied in any educational institution. If he/she has resided in that local area for a period of not less than four years immediately preceding the commencement of the relevant qualifying examination in which he/she appeared or as the case may be first appeared.
- 10.2 A candidate for admission to any course of study who is not regarded as a local candidate under sub regulation 8 above in relation to any local area shall:
- 10.2.1. If he / she has studied in an educational institution in the state for a period of not less than seven consecutive academic years ending with the academic year in which he/she appeared or as the case may be first appeared for the relevant qualifying examination be regarded as a local candidate in relation to:

i) Such local area where he/she resided for the maximum period out of the said period of seven years;

۸r

- ii) Where the period of his/her study in two or more local areas are equal, such local area where he / she studied last in such equal periods; or
- 10.2.2. If during the whole or any part of the seven consecutive academic years ending with the academic year in which he/she appeared or, as the case may be, first appeared for the relevant qualifying examination, he/she had not studied in the educational institutions in any local area, but has resided in the state during the whole of said period of seven years, be regarded as a local candidate in relation to:
 - i) Such local area where he/she resided for the maximum period out of the said period of seven years;

or

ii) Where the periods of his/her residence in two or more local areas are equal, such local area where he / she resided last in such equal periods.

EXPLANATIONS: For the Purpose of this regulation.

- i) "Educational Institutions" means a University or any educational institution recognised as such by the State Government, a University or other authority competent in that behalf:
- ii) "Relevant qualifying examination" in relation to admission to any course of study, means the examination, a pass in which the minimum educational qualification for admission to such course of study.
- **NOTE**: The relevant qualifying examination for admission to Doctor of Medicine (Homoeo) being Bachelor of Homoeo Medicine and Surgery examination, the question whether a candidate is a local candidate or not shall be determined with reference to his/her first appearance in the Bachelor of Homoeo Medicine and Surgery examination.
 - a) In reckoning the consecutive academic years during which a candidate has studied any period of interruption of his/her study by a reasons of his/her failure to pass any examination shall be disregarded; and
 - b) Any period of his/her study in a State-wide University or a State-wide educational institution shall be disregarded
 - **iv)** The question whether any candidate for admission to any course of study has resided in any local area shall be determined with reference to the places where the candidate actually resided and not with reference to the residence of his/her parent or guardian.
- 10.3. If a local candidate in respect of a local area is not available to fill up any seat reserved or allotted in favour of local candidate in respect of that local area, such seat shall be filled as if it had not been reserved.
- **11.** The following categories of candidates are eligible to apply for admission to the remaining 15% of unreserved seats.
 - 11.1. All candidates defined under Regulation 10.
 - 11.2. Candidates, who have resided in the State for total period of ten years excluding periods of study outside the State, or either whose parents have

- resided in the State for a total period of ten years excluding periods of employment outside the state.
- 11.3. Candidates whose parents are in the employment of this state or Central Government, Public Sector Corporations, local bodies, Universities and other similar quasi public institutions within the state.
- 11.4. Candidates who are spouses of those in employment of this State or Central Government, Public Sector Corporations, Local bodies, Universities and educational institutions recognized by the Government, a University or other competent authority and similar other quasi government institutions within the State.
- 11.5. Candidates who are employees in the State Government undertakings, public sector corporations, local bodies, Universities and other similar quasi public institutions within the State.
- 11.6. Candidates who are the spouses of the local candidates as per Regulation 10.

Note: Relevant certificates shall be enclosed to the applications in respect of their claim, in respect of residence. The certificates should be from the revenue authorities not below the rank of a Mandal Revenue Officer.

12. APPLICATIONS THROUGH ONLINE:

12.1 The on-line application form will be available on the (Website https://pghomoeo.ysruhs.com) from 11.00 A.M. on 31.10.2023 to 6.00 P.M. on 05.11.2023.

Note: The candidates are advised to take a print out of the Prospectus/Instructions from the website (Website https://pghomoeo.ysruhs.com) and https://drysr.uhsap.in) before proceeding to fill the application form.

12.2 The candidate should fill the online application form available in the Website with the data required-for, through internet. The online application form can be filled through any computer with internet connection (home/internet café/net center). The candidate is advised to fill the online application form after going through the Prospectus by keeping all the Certificates and ready to enter his/her correct data.

13 Procedure of filling online application form and payment of fee through online.:

- a. The fee can be paid through Debit card / Credit card or Net Banking.
- b. The fee paid by the applicants is not refundable under any circumstances.
- c. Read the Notification, Prospectus / Regulations carefully regarding eligibility under local and non-local.

- e. The Registration number which will be sent to the registered mobile after entering the basic details, should be noted for further use. The Registration number should be kept confidential and should not be disclosed to others.
- f. Fill in all the correct details in the online application form and upload all the documents including the certificates which are mandatory.
- g. The following Certificates are required to complete the online application process. The certificates are to be scanned and kept ready to upload. Application fee has to be paid through online.

13.1 **REGISTRATION FEE:**

- a. for OC/BC categories: Rs. 5,900/- (5,000+900/- including GST 18%) (Bank transaction charges extra)

- 13.2 **VERIFICATION FEE:** The candidates who acquired their Under Graduate Degree outside the State of Andhra Pradesh / Telangana got their certificates registered with Council and applying for admission into MD (Homoeo) courses under this University, shall pay a verification fee of Rs. 3,540/-(Rupees Three thousand Five hundred and forty only) (3000/-+540/-including GST 18%) for degree certificates acquired outside of the state in addition to the above Registration fee.
- 13.3 The candidate should sign at the declaration area in the print out of the online application form and submit at the time of joining at the allotted college. The candidates need not submit Printout of Application by post/by hand to the University.

14. VERIFICATION OF CERTIFICATES:

14.1 The eligibility of a candidate will be verified basing on the uploaded copies of scanned certificates/ documents.

The candidates who are claiming reservation under Special Categories i.e. PwD, have to watch the university website for further notifications, if any, for scrutiny of original certificates of respective special category.

Note: The candidature of the applicant will not be considered for admission into MD(Homoeo) courses if not submitted the online application by uploading the scanned copies of required certificates/documents as per regulations.

The eligibility and community verification will be done basing on the uploaded scanned original certificates.

15. METHOD OF SELECTIONS:

- a. Counselings for admission into MD (Homoeo) courses for the academic year 2023- 24 will be conducted based on the State merit list which is to be notified.
- b. The candidates whose names figured in the AIAPGET -2023 merit list and state merit list, are only eligible for counseling and for exercising options for admission into MD (Homoeo) courses.

16. PEOCEDURE OF SELECTIONS:

As per G.O.Ms.No.603, HM &FW(R2) Dept. dt.23.12.2004 as amended in G.O.Ms.No.13, HM&FW(F2) Dept., dt.05.02.2021.

- 16.1. The Vice-Chancellor shall constitute a Selection Committee.
- 16.2 Provisional Selection shall be made by the Selection Committee constituted by the University.
- 16.3 The Selection Committee shall provisionally select the candidates as per these regulations from among the candidates as per merit list from the candidates who exercised web options.
- 16.4 Candidates have to exercise the options in response to this University notification.
- 16.5 The Selection Committee shall have power to review the provisional selection in case of any errors, misrepresentation, fraud or glaring injustice. In all matters relating to selections and admissions, the decision of the selection committee shall be final and binding on the candidates and selections cannot be questioned after admissions are closed.
- 16.6 If a candidate after choosing the subject fails to pay fees or after paying the fees fails to submit the bond, his/her selection stands cancelled automatically.

17. CONDITIONS OF ADMISSION:

17.1 Candidates joining courses shall execute a bond on non judicial stamp paper of value of Rs.100/- in the form specified in Annexure-I to complete the prescribed period of training or in default to pay Rs.59,000/-(Rupees Fifty Nine Thousand only) i.e 50,000+9,000/- including GST@18% to Dr. YSR University of Health Sciences and service candidates shall refund the stipend received upto that date to Government.

17.2 **PAYMENT OF FEES:**

17.2.1 **TUITION FEE:**

The selected candidates have to pay tuition fee and other constituent fee, special fee and caution money deposits at the rates laid down for the purpose from time to time subject to the conditions laid therein at the time of admission. The regulations governing the same will be informed.

17.2.2 UNIVERSITY FEE:

18. ATTENDANCE AND LEAVE:

- 18.1 The post graduate students shall complete eighty percent of attendance in all subjects separately before they appear for final examination.
- 18.2 **Leave:** The Post Graduates are eligible for 30 days leave in the academic year and they can avail a maximum 10 days at a time. If they avail more than 10 days at a time, the stipend shall be deducted proportionately. The balance of leave in a year if any shall not be carried forward to the next academic year.

18.3 **Maternity leave:** Post Graduate students are eligible for maternity leave for the period as specified by the respective Councils/ Government of Andhra Pradesh from time to time. The study period will be extended to the extent of absence to the course.

18.4 SANCTION OF LEAVE OF ABSENCE BEYOND 3 MONTHS AND TERMINATION OF STUDENTSHIP:

19. Break of study and re-admission:

If a student absents continuously for a period of 91 days or more and seeks permission to attend the course, his/her application in prescribed format by paying requisite fee in favour of Registrar, Dr YSR University of Health Sciences payable at Vijayawada shall be forwarded to the Registrar, Dr.YSR University of Health Sciences with the recommendation of the Principal. Regulations for readmission after break of study along with application format and fee payable is available in the university website. The candidates are advised to refer the regulations before submitting the application and paying the fee. If they fulfilled the regulatory conditions, they may submit applications through the Principal of the College by paying the fee.

20. PRIVATE PRACTICE:

No PG student shall do any private practice or consultation practice and shall not accept any part-time employment during his/her Post Graduation.

21. COLLEGE REGULATIONS:

Candidates are required to follow the rules and regulations of the college and should also abide by the regulations of the University and they shall not make any correspondence with higher authorities directly without prior permission of the Professor of the concerned unit and Principal.

22. STIPENDS:

- 22.1 students who are regular in attendance and show good progress every month in their academic pursuits. The total period during which the stipends may be paid to the students shall not exceed thirty six months for the course. No candidate will be eligible to draw the stipend for more than 36 months during the entire PG study period.
- 22.2 Service candidates shall not be paid stipend if they draw leave salary or salary.

23. COMMENCEMENT OF THE COURSE:

The course shall normally commence as per the date mentioned in the provisional allotment order. The duration of the course shall be calculated from this date of commencement of the course and shall be uniform for all the candidates irrespective of their individual dates of admission.

24. CLOSURE OF ADMISSIONS:

- 25.1.Admissions shall be closed as per the date specified in the schedule notified.
- 25.2.Any vacancy as on the day of closure of admissions or that arises after closure of admissions shall not be filled up.

25. DURATION OF COURSE:

The period of training of Doctor of Medicine in Homoeopathy shall be of 3 years duration in the department concerned.

26. MEDIUM OF INSTRUCTION:

English shall be the medium of instruction and examination.

27. POWERS OF THE PRINCIPAL:

Notwithstanding anything contained in these regulations, the Principal, Dr. Gururaju Govt. Homoeopathic Medical College, Gudivada may at any time before completion of the PG course either on his own motion or on the application of any person after due and proper enquiry and after giving the person two weeks time from the date of the receipt of the show cause notice to submit written explanation and or a personal hearing, order the cancellation of admission to the PG course if in his opinion such candidates had furnished false or incorrect information in the application form or in the documents attached, certificates enclosed there to or in the statements made either before the authority in charge of admissions or the Principal or in any other fraudulent manner, obtained admission into such course. Against any such order of the Principal an appeal shall lie to the Dr. YSR University of Health Sciences, A.P. Vijayawada.

28. POWER TO AMEND REGULATIONS AND REVIEW SELECTION OR ADMISSION OF CANDIDATES:

- 28.1 The Dr.YSR University of Health Sciences shall have the power to add or to delete or amend or alter these regulations from time to time
- 28.2 The University may either suomoto or on an application made to them, call for and examine records relating to any selection or admission or cancellation thereof made by the authority incharge of selection or admission for the purpose of satisfying themselves as to the legality or regularity of such selection or admission orders in relation thereto, as they deem fit including cancellation of the selections already published or admissions already made provided that the University may before cancelling such selection or admission give an opportunity to the authority incharge of selection or admission and to the person effected to show cause against such cancellation.

29. FINALITY OF SELECTION:

All selections under these Regulations shall be subject to any general regulations or order that may be made by University from time to time.
