INSTRUCTIONS

- ❖ **Don't share your login id, OTP and password with others**
- ❖ **Since this is mop up round of counselling, if any MDS seat allotted to the candidate according to their choice filling, they should join without fail. If any candidate who is allotted and not joined in this mop up counselling, he/she will not be allowed to participate in Stray Vacancy Round and will also have to pay the penalty.**
- ❖ **For MDS Course Rs.15 lakhs.**
- ❖ **The candidates who are willing to participate in this counselling have to Register.**
- ❖ Candidates participating by ONLINE COUNSELLING for MDS course will have to remit a non-refundable amount of Rs. 1000/- as processing fee through online by

using a Debit Card /Net Banking or Credit Card. The candidates who have already paid processing fee need not pay again.

❖ **Security Deposit for fresh Registration:**

- (i) Choice locking of seats in Government Dental Colleges alone – Rs.30,000/-
- (ii) Choice locking of seats in Government Dental Colleges and Government Quota seats in Self Financing Dental Colleges – Rs. 1,00,000/-.
- (iii) Candidates are instructed to keep their bank transaction limits adequate, so as to pay without any hurdles and to prevent transaction/payment failure.

❖ Only Candidates registered and filled their choices in Mop up round will be eligible for stray vacancy round if they are **Not allotted** in the Mop up Round. Hence candidates who wish to participate in stray vacancy round are instructed to register in mop up round

- ❖ Vacancy position for the courses will be available on official websites.
- ❖ Selection Committee does not take responsibility for any Connectivity error.

Eligibility Criteria

- ❖ The candidates who have applied and are now eligible after lowering of percentile.
- ❖ The candidates who have not been allotted in Round I and Round II Counselling.
- ❖ The candidates who have been allotted, but not joined in Round I & Round II of State Quota and All India Quota are eligible to participate in this counselling.
- ❖ The candidates who have been allotted, but discontinued in stipulated time in Round I of AIQ / State Quota are eligible to participate in this counselling.

Non Eligibility Criteria

- **As per the directions of Hon'ble Supreme Court of India in W.P.(c) 267/2017 DAR-US-SLAM EDUCATIONAL TRUST and Ors. Vs. MEDICAL COUNCIL OF INDIA and Ors. Dated 09-05-2017, the candidates joined in All India Quota Round II counselling are not allowed to vacate the seat. On similar ground the candidates who have joined in Round II of State counselling will not be permitted to vacate/resign/surrender the seat.**
- **The candidates who have taken admission in second round of allotment or carry the seat allotted in first round beyond notified date, which is not upgraded in second round, will not be permitted to vacate the seat.**

- The candidates who fall into these above categories are not eligible to participate in mop up / subsequent round of counselling.
- The candidates who have been allotted in mop up round of All India Quota/Deemed university/DNB (conducted by NBE) are **not eligible to participate in state mop up counselling and Stray Vacancy round.**

❖ **In order to prevent the seat blocking:**

If a candidate is getting an allotment under Government Dental College /Government quota seats in Self financing Dental colleges in mop up counselling, he/she cannot claim a seat in Management mop up counselling. Hence candidates are instructed to choice lock carefully.

Conversion of seats in Mop Up Round

- As per MDS Government prospectus clause 30(e) 2022-2023, if there are no eligible PwD candidates opting for PG Degree/Diploma courses, the same will be allotted to eligible general category candidates.
- As mentioned in MDS Government Prospectus clause 31 (a) Any remaining unfilled seats for want of adequate number of eligible candidates belonging to SCA community shall be filled by candidates belonging to SC community as per merit vice versa (G.O. (Ms.) No. 55, P & A R Dept. dated 08.04.2010). **Hence SC candidates can register and choice lock for SCA seats also.**
- As mentioned in MDS Government Prospectus clause 31(b) Any remaining reserved seats in ST quota for want of adequate number of eligible candidates belonging to ST community shall be allotted to candidates belonging to SC community as per merit (G.O. (Ms.) No. 77 H & FW Dept. dated 24.02.2011).**Hence SC candidates can register and choice lock for ST seats also.**
- As mentioned in MDS Government Prospectus clause 31(c) Any remaining unfilled seats in BCM community for want of adequate number of eligible candidates after exhausting the merit list shall be filled up on merit basis by candidates belonging to BC community without exceeding the quota for BC community as a whole(G.O. (Ms.) No. 30 H & FW Dept. dated 18.01.2012).**Hence BC candidates can register and choice lock for BCM seats also.**
- ❖ Selection of candidates to MDS course shall be made by the ONLINE COUNSELLING on the basis of rank by applying the rule of reservation/200 Point Roster method whichever is applicable.

- ❖ Candidates selected for admission should give a self-declaration form at the time of the reporting to the concerned Dental College that he / she is liable for forfeiture of selection / admission if suppression of facts mis-interpretation is found at any time during or after the admission to the course.
- ❖ Candidates should pay the tuition fee online and then download their provisional allotment order and join the course in the concerned Dental Colleges on or before the date and time stipulated during this phase of ONLINE COUNSELING.
- ❖ The candidates should produce the following original certificates in person at the time of joining in their selected Dental College along with the scanned copy of original certificates to the concerned College.
 - a) NEET MDS-2022-Score Card.
 - b) NEET MDS- 2022 Admit Card.
 - c) Aadhar Card
 - d) MDS Degree Certificate or Provisional Pass Certificate.
 - e) CRRI Completion Certificate.
 - f) Permanent Dental Registration Certificate issued by the Dental Council of India / State Dental Council or Provisional Registration Certificate issued by the Dental Council of India / State Dental Council.
 - g) Community Certificate (if applicable)
 - h) TNPSC/MRB (through competitive written examination) Selection & Posting Order for service candidates.
 - i) Nativity Certificate (if applicable) with supportive documents.
 - j) Recent Regional Medical Board Certificate for Person with Disabilities.
 - k) Eligibility Certificate, if applicable.
 - l) Post Card size color photograph (4"x6") the same photo that has been uploaded in NEET PG-2022.
