All the candidates whose names are in the Final Merit Position of Management Quota notified in the University Website are only eligible to exercise web options on the above schedule dates as per the Seat Matrix displayed in the website http://ntruhs.ap.nic.in

UNIVERSITY FEE: Candidates to whom allotment message is given have to pay Rs. 49,600/- for obtaining allotment letter through payment Gateway by using Online payment method. (Debit Card /Credit Card /Internet Banking).

Candidates who have already paid Rs.49,600/- in Phase-I Counselling are not required to pay the same.

Instructions to Candidates:

1	A candidate who exercised options and joined in an allotted seat in this Phase-II counselling shall not be permitted to withdraw from the seat. In case any candidate withdraws from the allotted seat, the candidate shall be debarred for a period of three years for admission into Post Graduate Dental Degree/Diploma courses at the colleges in the State of Andhra Pradesh besides payment of Rs. 3,54,000/- (Including GST 18%) as per G.O.Ms.No.67, dt.21-04-2017.		
2	Not Reported seats are displayed in the University Website for information of the students to exercise their Web options.

4	Candidates opting for Dental Degree/Diploma courses are informed that, there is no limit of choices (number) for exercising web options. Candidates can exercise any number of options for any number of subjects and colleges if the candidate is really interested to join that particular speciality in a particular college as per eligibility.		
5 6	Candidates are instructed to be careful while exercising options on the Web and take the print out of the saved options. Candidates are advised to exercise options in Courses and colleges in which they are really interested. If they are not interested to join any subject or college then they should not exercise options for the same. Candidate can exercise web options from any place having internet facility. One Time		
	 Password will be sent to the registered mobile number at the time of saving Web options. I) Selected Options can be slided either up or down, added and deleted. II) Web options opted must be saved by the candidate. III) Web options once submitted can not be Edited. IV) Web options saved but not submitted until the cut off date and time will be Auto submitted. 		
7	Candidates are instructed to be careful while exercising options on the Web and take the print out of the saved options. Candidates are advised to exercise options in Courses and colleges in which they are really interested irrespective of the vacancies. If they are not interested to join any subject or college then they should not exercise options for the same.		
	Candidates while giving options should note that the seats vacated by the candidates selected in Phase-I counselling and slided to other college/course during this Phase-II of counseling process will be added & allotted simultaneously during this Phase of counseling itself.		
	The candidates are therefore advised to exercise options for all the seats in all the colleges as per their priority irrespective of vacancies shown in seat matrix. Candidates are advised to give options to the courses for which they are really interested to join, so as to give chance to next meritorious candidates.		
8	The selected candidates can download the provisional allotment order on payment of University Fee of Rs.49,600/- through payment gateway and report to the Principal of the Allotted College on or before the date specified in the allotment order. This University fee is not refundable under any circumstances.		
9	The selected candidates shall produce all the Original certificates, pay the Tuition fee, necessary bonds etc., and complete the process of admission. If the candidate does not fulfil the criteria as per regulations to complete the admission process in the specified dates of admission, their admission will be cancelled automatically.		
10	The verification of original certificates will be conducted at the time of admission in the respective College and in case of any discrepancy, the Provisional allotment will be cancelled and action will be initiated. If the candidate slides to other college (i.e., affiliated colleges of Dr.NTR UHS) during subsequent Phases of counselling, the original certificates and tuition fee will be sent to the slided college by the concerned college where the original certificates are present.		

11	Note:1. As per the Notice No.U-12021/01/2022-MEC, dt.12-07-2022 & 29-10-2022 of DGHS, HM&FW Govt. of India, New Delhi, the joined candidates up to round 2 of AIQ or State Quota shall not be eligible to participate in the further rounds for All India Quota or for State Quota from the academic year 2022-23 onwards.
	Hence, the joined candidates upto round 2 of AIQ or any State Quota are not allowed for exercising web options in this Phase and also further Phases. If it is found at a later stage that such candidates have exercised options, such candidates will not be allotted any seats and necessary action will be initiated as per rules.
	2. a) Candidates who have joined and continuing in the PG (Dental) allotted seat in the State Quota/Competent Authority Quota seats are not permitted to exercise web options in this MQ Phase-II counselling, hence if it is found that the joined candidates have exercised options, such options will not be considered for allotments of this MQ Phase-II/Final.
	b) Candidates who have been allotted any seat in any Phase of counselling are not allowed to participate in the MoP Up Round.
	c) Candidates already joined any seat are also not eligible for MoP Up
12	Candidates who were allotted a seat in Phase-I MQ counselling in any college of AP State, joined and slided to another college in AP in this Phase-II MQ counseling, should submit the tuition fee receipt along with relief letter issued by the earlier college through e-mail (or) In person, for admission at the newly allotted college. The first college where the candidate initially joined in Phase-I will transfer the tuition fee, Original certificates etc., to subsequently allotted college in AP State.

	Delhi OCI/PIO/Foreign Nationals will only be eligible for NRI seats and not for Indian (All India Quota/Central/Deemed paid (Indian) seats for the current academic year. For complete details refer Notice Ref.U-12021/01/2022-MEC, dt.22-09-2022 of DGHS, Govt. of India, New Delhi.
