#### **Notification for inviting applications for stray vacancies in PG Dental Courses in Private un-aided Non-Minority Colleges for the Academic Year 2021-22.**

Application forms are invited afresh for filling up of stray vacancies in PG Dental Courses for the academic year 2021-22 from the candidates who have qualified in NEET MDS – 2021 after lowering cut-off scores for the seats under Competent Authority Quota if any after CQ MoP UP-2 and Management Quota seats for the Academic Year 2021-22. The candidates are hereby informed to submit filled-in application form as per Annexure. The following copies of certificates are to be enclosed to the application:

- a. NEET MDS-2021 admit card and score card
- b. Aadhar Card
- c. Date of Birth Certificate (X class)
- d. BDS Degree/Provisional certificate
- e. Certificate of Internship Completion by 31-07-2021.
- f. Dental Council Registration Certificate.
- g. Permanent Caste certificate in case of BC/SC/ST candidates issued through e-seva / Mee-seva of Government of AP/ TS.

Candidates having the following qualifying cutoff scores and above are eligible to apply for Post Graduate Dental Degree/Diploma courses:

Note: a) The fee structure in Private Unaided Non-Minority Colleges is as per G.O.Ms.No.56, HM&FW (C1) Dept., Dt.29-05.2020 as per the directions of the Hon'ble High Court in W.P.No.10159 of 2020 and batch, dt.09-07-2020, which is read as "to permit the petitioners/students to pay fee fixed by the Regulatory authority by executing bond in the proforma prescribed by the Andhra Pradesh Private Medical and Dental Colleges Managements Association within the specified time as notified by Dr. NTR University of Health Sciences, Vijayawada".

b) As per the directions of Hon'ble High Court in W.P.No.21389 of 2021, dt.01-10-2021 "to pay the stipend being paid by the dental colleges under G.O.Ms.No.75 Health, Medical and Family Welfare (C1) Department, dated 06-05-2017 pending further orders".
