ORDER

- 1. Whereas, a complaint was filed by Mr. Prasad Kulkarni during the year 2019, alleging that you were involved in malpractices and insurance fraud as detected by Private Insurance fraud detection Agency i.e. Bullet Health Care Pvt. Ltd. During fraud detection of insurance claim cases, it was observed that you had multiple attachments with Private Pathology Lab. Whereas these labs are located at places which makes impossible for any individual to attend on daily basis. The names and signature were used as a routine as well as for Insurance claim report.
- 2. Whereas the council has considered the complaint & issued parawise notice, however you had not replied to the said notice. Thereafter, the hearings were held on various dates, after due notices to the parties concerned, for which you didn't turned up and chose to remain absent.
- 3. In view of above, the Committee has decided to frame charge sheet. Accordingly, same was issued by letter Dt- 20/03/2020.
- 4. Since, the matter is placed before the Executive Committee after framing of charges, whereby you again remained absent for the said enquiry. After detailed discussions and deliberations, the Council decided to suspend your medical license. Accordingly, the order date 02/12/2020 issued by the Council, thereby suspending your Registration No. 63614 u/sec 10 (d) of MMC Act, 1965 and refrained you from doing medical practice.
- 5. Thereafter, another enquiry has held on 15/05/2021, for which you again chose to remain absent. In view of your continuous absence and ignorance to the Council's notices, the Council has decided to take stern action against you, hence, order dated 18/09/2021 for six months removal of registration was awarded to you. Thereby your Reg. No. 63614 was removed, as you had not preferred any appeal before MCI/NMC. Hence order of MMC was confirmed.
- 6. However, in 2023 it was pointed out by the complainant that, during the suspension period you were found involved in signing of multiple pathology reports, thereby notice Dt- 18/09/2023 was issued. However, you have not replied to it. Thereby disobeyed the directions given by the Council.

- 7. During further enquiry held on 03/04/2024, the complainant has produced more evidence i.e. Pathology lab reports signed by you during the aforestated removal period.
- 8. Therefore, considering the nature of the complaint, suspension order as well as removal order & considering you have not responded to the communication/notices of the council from 2019, neither you had renewed your Registration since 2012 and you were found practicing in the State of Maharashtra without valid licence. Further not communicated or attended enquiry held by the Council, it shows disrespect to the council. In view of above, your name and your Reg. No. 63614 is hereby removed for the period of 3 (Three) years from the medical register, thereby you have been refrained from doing any kind of medical practice and/or professional duty during the removal period. If found doing so, same may be treated practice by unregistered practitioner and liable for Criminal Action.
- 9. Therefore, the Administrator of the Council, empowered u/sec 31 and MMC Act, hereby passes the order to remove the Registration/Name of RMP Dr. Sireesha Mohan (Reg. No. 63614) for the period of 3 (Three) years from Register maintained u/sec 16 of MMC Act and informing the same to NMC for updating Registration details.
