Mop up Allotment to Ayurveda/Homoeo/Siddha/Unani & Medical Allied courses has been published in the website www.cee.kerala.gov.in. Allotment details such as Name, Roll Number, Allotted Course, Allotted College, Category of Allotment, Fee details etc. are available in the Allotment Memo of the candidate. The print out of the Allotment Memo shall be taken from the Home page of the candidates from 21.04.2022, 4.00 PM.

Candidates who receive an allotment through the Mop up Allotment should remit the fees/balance fee (if applicable) to be paid to the Commissioner for Entrance Examinations as specified in the allotment memo by way of Online Payment or through any of the Head Post Offices in Kerala (List of Post offices is available in the website) from 21.04.2022, 4.00 PM to 25.04.2022, 2.00 PM. Candidates allotted under SC/ST/OEC category and those having benefits as per G.O. (MS) 25/2005/SCSTDD, dated: 20.06.2005 and G.O. (MS) 10/2014/BCDD, dated 23.05.2014, and those candidates from Sree Chitra Home, Juvenile Home, Nirbhaya are eligible for fee concession. However, they will have to pay an amount of Rs. 1000/- as Token Fee to the Commissioner for Entrance Examinations.

Candidates who get Allotment shall have to join the allotted college from **22.04.2022 to 25.04.2022, 2.00 PM.** Candidates are instructed to verify their joining status by logging into the Candidate Portal. Candidates who get an allotment can download the 'Data Sheet' containing the basic details of the candidates by clicking the menu item 'Data Sheet' available in the Home Page of the candidate. The printout of the Data Sheet, Allotment Memo and other required documents mentioned in Prospectus clause 11.7.1 are to be produced before the college authorities at the time of admission. College authorities shall approve and submit the list of admitted candidates through online Admission Management System (OAMS) at 3.00 PM, 25.04.2022.

Subsequent Vacancy Filling Allotment, if any, will be conducted by considering the online options registered by the candidates for this Online Mop up Allotment. The detailed notification in this regard will be published in due course.

**Note:** Mop up Allotment shall be final. Liquidated damages as stipulated in clause 12.2.4(c) (ii) of the KEAM 2021 Prospectus shall be applicable to those candidates who lapse seats after being allotted in Mop up counselling/subsequent allotments or admitted as on 19.04.2022 through any of the prior allotments by Commissioner for Entrance Examinations.
