ALLOTMENT PROCESS				
Step 1	Registration for AACCC-UG Counseling. (Those candidates who participated in Round 1, 2 & 3 need not be registered again)			
Step 2	Payment of Counseling Fee includes non-refundable Registration Fee and Security Money. (No Need to pay by those candidates who have already paid the counseling fee at the time of registration for Round 1, 2 & 3)			
Step 3	Eligible Candidates can submit Choices of Freshly added AIQ-UG seats			
Step 4	Upgradation from Round 1, 2 & 3 is available			
Step 5	Publication of Seat allotment list (Publication of Result)			
Step 6	Physical Reporting to the allotted college.			
ADMISSION RULES				
<p>If a candidate gets allotted/upgraded a seat during the Special Mop-up round, he/she must join the allotted/upgraded seat. Otherwise, the security money of the candidate will be forfeited, and he/she will become ineligible for further AYUSH-UG counseling (Central/State/UT/Central Pool Quota)</p>
