**UPON** hearing the counsel the Court made the following ORDER

There is no doubt about the fact that the petitioner has been a reputed educational institute for more than 20 years. In the

ultimate analysis, after complying with all conditions and requirements, the only requirement that needs to be satisfied is with respect to the Biometric Attendance Machine.

- 2. Mr. Maninder Singh, learned senior counsel appearing for the petitioner, submits that the requirement is now complied with, and this is evidenced by report of Mantra Technify, which states that "Device is now working properly after adapter replacement and data clearing".
- 3. Mr. Maninder Singh has also brought to our notice the order passed by the Rajasthan High Court in S.B.Civil Writ Petition No. 18256 of 2025 [Vyas Dental College and Hospital Vs. Union of India] dated 26.09.2025, wherein it is specifically directed as under :-

"Drawing attention of the Court towards Annexure-12, learned senior counsel submitted that the petitioner - Institution vide order dated 14.07.2025 was informed by DCI that the Executive Committee in its meeting held on 09.07.2025 had observed that the average biometric attendance of.... for last three months in the institution is around 54% which is not acceptable as per rules. petitioner-Institution was thus directed to furnish an undertaking in the prescribed format assuring compliance of biometric attendance, failing which appropriate recommendations would be forwarded to the Government of India for admissions for 2025-26 Academic Year based on the available. The petitioner - Institution was further directed to remit outstanding amount petitioner-Institution Rs.7,37,500/-. The in compliance of the order dated 14.07.2025 furnished an undertaking with the respondent-DCI with regard average biometric attendance, and to transferred outstanding amount of Rs. 7,37,500/-to the Bank Account No. 9068216000059, Canara Bank in the name of Secretary, DCI on 22.07.2025 towards the annual and inspection fees.

7. The Executive Committee of the DCI in its meeting dated 22.07.2025 considered the joint verification inspection report of the petitioner Institution

carried out on 04.04.2025 and 05.04.2025 for restoration of BDS seats from 50 to 100 in the Academic Year 2025-26 and noted that though the petitioner-Institution has furnished an undertaking in the prescribed format with regard to average biometric attendance but the outstanding amount of Rs. 7,37,500/- has not been remitted."

- 4. Having considered the matter in detail, as an interim measure, we direct that the petitioner be permitted to participate in counseling/admission process and also admit the students for BDS Course for the academic year 2025-2026.
- 5. The above interim directions shall be subject to final outcome of the Special Leave Petition.
- 6. We make it clear that this order is passed in the peculiar facts and circumstances of the case and shall not be treated as a precedent.
- List the Special Leave Petition after four weeks.
