RULES & GUIDELINES FOR INTERNSHIP SEAT ALLOTMENT OF FOREIGN MEDICAL GRADUATES

This is to bring to your kind attention towards the guidelines issued by the National Medical Commission (NMC) regarding allotment of internship seats to the foreign medical graduates (FMGs). The NMC has emphasized the importance of adhering to the CRMI Regulations, 2021, and FMGL Regulations, 2021.

In light of this, the Madhya Pradesh Medical Council (MPMC) has issued the following guidelines:

1. Foreign Medical Graduates who had passed Screening Test has to submit online application to Madhya Pradesh Medical Council via https://dme.mponline.gov.in/

The application must be completed in all respects as well as accompanying documents stated in the application form should be uploaded.

- 2. Every candidate has to select all Colleges/ Institutes according to their choice in the choice-filling section. If any candidate has selected a few or limited colleges/ institutes and does not get seat allotment in those colleges/ institutes in accordance with his/ her merit, then in any circumstances he/ she will not be allotted an internship in this session. Therefore, every candidate is hereby specially informed to select all colleges/ institutes according to his/ her choice.
- 3. Allotment process:
 - The seats will be allotted to candidates whose name appears in the merit list published by Madhya Pradesh medical Council.
 - As per the NMC's circular stated in the Public Notice dated 21/09/2022, the allotment starts on "Group A permitted college" then "Group B recognized college".
 - Allotment of seats shall be made on the basis of merit cum choice filled by the candidate and availability of seats.
- 4. Admitted candidates of previous sessions will not be allowed to participate in the current session.
- 5. FMGE-qualified (passed) candidates from previous sessions (June 2023, December 2023, June 2024, and earlier) who have not secured admission in the June 2024 or any prior counseling sessions are eligible to participate in the December 2024 counseling session.
- 6. The Counselling of Internship seat allotment will be conducted only in a single and final round.

For FMG Candidates:

7. Every candidate has to report to the allotted College/ Institutes as per schedule mentioned.

- 8. The selected candidates have to join the clinical clerkship/ internship programme immediately but not later the Prescribed period from the date on which final list of allotment is uploaded on official website of Madhya Pradesh Medical Council and if candidate is not able to join the allotted medical college/institution within the Prescribed period, the seat will be considered vacant.
- Every candidate has to submit all the self-attested documents attached in the application form along
 with the provisional registration receipt to allotted College/ Institutes and get them verified from
 the office of Dean of allotted college.
- 10. Every candidate has to upload notarized affidavit of Undertaking (available on council website: http://www.mpmc.mp.gov.in) on Rs. 50/- stamp paper, in the online application and submit the original to allotted College/ Institutes. (Format 'A')
- 11. As per NMC Rules, Regulations, and Circulars, the candidates who have completed their study through online mode will have to do a 1, 2, or 3-years internship accordingly.
- 12. The selected candidates can download the allotment letter/ receipt after allotment of the internship from their portal login.
- 13. Candidates who are included in the Merit List and have commenced their Internship are eligible to apply for provisional registration with the Madhya Pradesh Medical Council. The registration process can be completed online at https://mpmc.mponline.gov.in/.
- 14. Applicants are advised to apply for Provisional Registration at the earliest and proceed for document verification. This will enable the council to make a timely decision regarding the Internship tenure.

For Madhya Pradesh Medical Council:

- 15. Madhya Pradesh Medical Council will scrutinise all the applications and shall prepare two Merit lists considering NMC Circular dated 09/05/2023 (based on criteria mentioned below) and the same will be published on the website of Madhya Pradesh Medical Council.
- 16. Merit List (ML)- 1: Candidates who are resident of Madhya Pradesh (based on Domicile Certificate)
- 17. Merit List (ML) 2: Candidates who are resident of Other State.
- 18. The merit list will be established according to the NBE score obtained by the candidate in the Screening Test. In the event of multiple candidates achieving the same score, the following criteria will be utilized to determine merit:
 - Date of birth, with preference given to the older candidate.
 - Candidate who is applied on the earlier date.

- 19. The amount of stipend to be paid to the interns is to be decided/fixed by the appropriate authority and is solely at the discretion of the concerned authorities under which the medical college/institute is located. The Madhya Pradesh Medical Council holds no responsibility for this decision or its outcome.
- 20. The Madhya Pradesh Medical Council has the right to reject any application if it doesn't meet the criteria or if the applications received exceed the number of seats available in medical colleges in Madhya Pradesh.

For Allotted/ Concerned Medical Colleges:

- 21. Original documents have to be submitted to the Dean of allotted college/ institute by the candidate. Allotted College/ Institute will check all the original documents and eligibility along with the provisional registration receipt at the time of reporting. The college/ institute can only refuse joining of the candidate in case any discrepancy found in it.
- 22. Allotted College/ Institute will have to collect the original affidavit and needs to verify & collect the self attested photo copies of the following documents from the candidate before joining.
 - Allotted College/ Institute 10th Marksheet
 - 12th Marksheet
 - Eligibility Certificate from NMC
 - Degree of MBBS or Equivalent to MBBS
 - FMGE Certificate/Screening Test Passing Certificate
 - MP State Domicile Certificate
 - Original Affidavit
- 23. After completion of CRMI, the allotted college/ institute will have to provide the internship ongoing certificate and completion certificate to the candidate.
- 24. The allotted college will have their login credentials, with which they need to mark acceptance of the joining of the candidates, and shall submit a report of the joining of the students who have been granted internship allotments in their college or institution to the Registrar, Madhya Pradesh Medical Council, Bhopal, within 10 days from the date of receipt of the posting order online through the portal.
