RULES AND PROCEDURE TO ISSUE THE UNIVERSITY MIGRATION CERTIFICATE TO THE STUDENTS

(Under section 50 (xii) of the MUHS. Act, 1998)

1. Short title, extent and commencement.

(a) This Ordinance may be called as "Rules and Procedure to issue the University Migration Certificate to the students"

(b) It shall be applicable to all the affiliated Colleges and recognised Institutes of the Maharashtra University of Health Sciences.

(c) It shall come into force from the date of its issuance.

2. Definitions.

- (a) "Act" means the "Maharashtra University of Health Sciences Act, 1998".
- (b) "University" means the "Maharashtra University of Health Sciences", established under section 3 of the said Act.
- (c) The definitions prescribed vide section 2 of the "Maharashtra University of Health Sciences Act, 1998" shall be applicable to this Ordinance.
- 3. **Rules and Procedure.** The students are required to follow the under mentioned rules and procedure for obtaining the Migration Certificate: -
 - (a) The students prosecuting study in any of the University departments, affiliated Colleges, conducted or autonomous Colleges or the recognized Institutions, who desire to seek admission in any other Institution or College affiliated to any other statutory University in India or abroad, after completing the course, or in between, shall apply in the prescribed format attached as <u>Appendix 'A'</u> to the University for obtaining the Migration Certificate.
 - (b) The student is required to submit the application with all the required documents duly certified by the Dean or Principal or Director of the affiliated College or recognized Institute where the applicant has last studied. The College shall forward the application to the University along with the supporting documents under a covering letter as per format attached as <u>Appendix 'B'</u>.

- 4. <u>Mandatory Documents.</u> The Migration Certificate shall be issued on the basis of the following documents: -
 - (a) The First College Leaving or Transfer Certificate in original;
 - (b) In case of any unavoidable circumstances, if the student is unable to submit the First College Leaving or Transfer Certificate in original, then the College Leaving or Transfer Certificate, specifically marked with 'ISSUED ONLY FOR MIGRATION CERTIFICATE PURPOSE', in original, shall be accepted. However, it shall be mandatory for the concerned student to submit the undertaking as per the format attached as 'Appendix 'C', along with the letter from the College or the Institution which is affiliated to the other University, wherein he/she proposes to seek the admission or has been admitted;
 - (c) in case the original, the First Transfer or Leaving Certificate is lost, theft, burnt/damaged accidently or due to the natural calamities, the student may submit duplicate Transfer or Leaving Certificate, along with a copy of the complaint/FIR filed by the student with the concern Police station or the certificate from the concern Fire Brigade, as the case may be, and an affidavit to that effect on the non-judicial stamp paper;
 - (d) Self-attested photostat copy of the Original Degree Certificate or Self-attested statement of Marks of final year or Self-attested Provisional Degree Certificate (for the particular year) if issued by the University.
 - (e) Self-attested photostat copy of the University Internship Completion Certificate,
 - (f) in case of the student who has completed his or her Under-Graduate (UG) / Post-Graduate (PG) course from the Government College or the College run by the Local Self-Government and has signed necessary bond for compulsory service with such College, the UG student shall submit an undertaking as per specimen attached as <u>'Appendix 'D'</u> and the PG student shall submit an undertaking as per specimen attached as <u>'Appendix 'E'</u> regarding completion of the bond service;
 - (g) The applicant students seeking Migration Certificate shall render a self-declared certificate regarding furnishing of correct information as per specimen attached as <u>'Appendix 'F'.</u>
 - (h) in case the Transfer or Leaving Certificate issued by the College or the Institution is of the previous academic year and not the current academic year, then the student shall submit a self-declared Gap Certificate for such gap period as per format attached as <u>'Appendix 'G'</u>

Fees Structure: -

5.

- (a) The student shall pay the Migration Certificate fees as notified by the University from time to time by RTGS/NEFT/Online Payment Getaway on University website.
- (b) To issue the Migration Certificate on urgent basis or by hand on same day, the student shall have to pay such additional fees as notified by the University from time to time.
- (c) The Migration Certificate fees once paid shall not be transferable or refundable under any circumstances.

6. Issue of Migration Certificate.

- (a) After receipt of application for issuance of the Migration Certificate from the student, the University shall issue the Migration Certificate to the student by the name, as per the admission eligibility and enrolment registration granted to him or her.
- (b) In case, the admission is cancelled in first year of the course, before granting such enrolment registration, the Migration certificate shall not be issued. The applicant shall be communicated accordingly by the University.
- (c) As far as may be practicable the Migration Certificate shall be issued within seven working days on urgent basis and within 15 working days for regular basis after receipt of complete application from the student along with the prescribed fees notified by the University from time to time.
- (d) In case, where the Migration Certificate is demanded by post, then it shall be sent on the applicant student's correspondence address or concerned College by Speed or Registered post.
- (e) In case the Migration Certificate is required by hand, then the concern student or the authorised person on his/her behalf shall produce his/her identity proof or the authority letter, as the case may be.

7. Issue of Duplicate Migration Certificate.

- (a) Where the Original Migration Certificate is lost, theft, burnt or damaged accidently in transit or due to the natural calamities, a duplicate Migration certificate may be issued on production of a copy of complaint or FIR filed by the student with the concern Police station or the certificate from the concerned Fire Brigade and an affidavit to that effect on the non-judicial stamp paper, along with written application and the fees as notified by the University from time to time.
- (b) The student shall pay the fees for the Duplicate copy of Migration Certificate as notified by the University from time to time by RTGS/NEFT/Online Payment Getaway on University website.

8. Validity of Migration Certificate.

- (a) The Migration Certificate has no any specific duration for its use from the date of its issuance. It can be produced whenever a student is taking further admission in any other educational Institute.
- (b)The Migration Certificate once issued can only be used for securing admission in only one University or Institute.

9. Cancellation of Migration Certificate.

- (a) The Migration Certificate, if returned by the student to the University within a period of six months from the date of issue, then the Migration Certificate shall be cancelled by the University and the Original documents of the student shall be returned. However, no fees shall be refunded.
- (b) The Migration Certificate once issued can only be used for securing admission in one University or Institute, as the case may be, failing which the Migration Certificate shall be cancelled by the University.

10. Miscellaneous.

- (a) Matters which are not specifically covered in the provisions hereinabove and if any query regarding the interpretation of any provision of this Ordinance arises, then it shall be finally decided by the Vice-Chancellor and the decision of the Vice-Chancellor shall be final and binding.
- (b) The previous Ordinance No.05/2010 stands repealed from the date of issuance of this Ordinance. However, the actions taken under the provisions of the said Ordinance are hereby protected.
