The seats will be allotted to Candidates as per Inter-Se-Merit.
- Wherever, there is a tie, Marks obtained by the applicant in the 12th / HSC marks will be considered and shall be given preference in the merit list.
- Further, if still the tie persists, then Marks obtained by the applicant in the 10th / SSC marks will be considered and shall be given preference in the merit list.
- Further, if still the tie persists, then the Candidate(s) with higher age shall be given preference in the merit list)
