Antimicrobial resistance (AMR) has been recognized as a serious and growing threat to public health globally. The World Health Organization (WHO) has identified AMR as one of the top 10 global public health threats facing humanity. Misuse and overuse of antimicrobials are the main drivers in the development of drug-resistant pathogens.

India is among the nations with one of the highest burden of bacterial infections. The crude mortality from infectious diseases in India is very high.

2. Ministry of Health and Family Welfare has developed the National Action Plan which needs to be launched across the country so as to bring about an alignment with the Global Action Plan on AMR with a "One Health" approach.


