# 1. Introduction

The Government of India established the National Board of Examinations in Medical Sciences (NBEMS) in 1975 with the objective of improving the quality of the Medical Education by establishing high and uniform standards of postgraduate examinations in modern medicine on an all India basis and utilizing existing infrastructure for capacity building.

NBEMS at present conducts postgraduate and postdoctoral examinations in approved specialties leading to the award of Diplomate of National Board (DNB) and Doctorate of National Board (DrNB) respectively.

The Examinations conducted by NBEMS provide a common standard and mechanism of evaluation of minimum level of attainment of the knowledge and competencies of medical specialties. Moreover, intra country and international comparisons are facilitated with the availability of common evaluation mechanism.

The notification issued in the Gazette of India for qualifications awarded by National Board of Examinations in Medical Sciences are available under **Annexure - I**.

## 2. Information for Candidates

- 2.1. DrNB – Final is an exit examination leading to the award of DrNB qualification. National Board of Examinations in Medical Sciences conduct DrNB Final Examination biannually every year.
- 2.2. The next session of DrNB Final Theory Examination shall be held in January 2025 as per schedule detailed under Important Dates and Scheme of Examination. This examination shall be conducted only for Super specialties.
- 2.3. A candidate registered with NBEMS as a DrNB trainee and obtaining requisite period of training as prescribed by NBEMS & fulfilling other eligibility criteria as stated in the Information Bulletin may appear for the DrNB final examination.
- 2.4. Candidates should go through this bulletin carefully for eligibility criteria before applying. Queries pertaining to eligibility and other issues will only be entertained if the information requested is not given in the bulletin of information or National Board of Examinations in Medical Sciences website <https://natboard.edu.in>
- 2.5. The list of super specialties in which examination will be conducted in January 2025 can be seen at **Annexure II**
- 2.6. Candidate should ensure that all the information entered during the online submission of application form is correct and factual. Information provided by the candidates in the online application form shall be treated as correct.
- 2.7. NBEMS itself does not edit /modify/alter any information entered by the candidates at the time of online submission of application form under any circumstances. Further, there shall be no edit window after closure of online application window. Therefore, request for change in any information in the application form after

---

successful submission can be made through registered email ID of the applicant at Communication Web Portal of NBEMS before issuance of admit card for the examination. There is no provision of change in any information after issuance of admin cards and/or conduct of examination. Such requests shall not be entertained.

- 2.8. Application for DrNB Final Theory Exam can only be submitted online through National Board of Examinations in Medical Sciences website <https://natboard.edu.in> There is no other methodology for application submission. Application submitted through any other mode shall be summarily rejected. There is no requirement to submit the hard copy print out of the application form and documents uploaded to NBEMS website.
- 2.9. Application form of candidates producing false or fabricated records will not be considered and the candidate may be further debarred from appearing in any future examinations of National Board of Examinations in Medical Sciences.
- 2.10. Candidates are apprised that no mandatory column in the online application form can be left blank. In the event of rejection of the application form, no correspondence/request for re-consideration will be entertained.
- 2.11. Candidates should go through this bulletin carefully for eligibility criteria before applying. Queries pertaining to eligibility and other issues will only be entertained if the information requested is not given in the bulletin of information or NBEMS website. No Queries of the Guardians/Parents/Spouse will be entertained on telephone with regard to the eligibility and disclosure of the results.
- 2.12. Candidate found ineligible at any stage of DrNB Final examination, will not be permitted to appear in the examination. In an unlikely event of any ineligible candidate appearing and/or passing the DrNB examination, the results/candidature of such candidate

shall be cancelled and/or is deemed to be cancelled, even if result has been declared.

- 2.13. Candidature of candidates who are allowed to appear provisionally in the examination shall be cancelled and result, if declared, shall be treated as null and void if they are found at any stage not to fulfil the eligibility criteria prescribed.
- 2.14. NBEMS reserves the right to withdraw permission, if any, granted inadvertently to any candidate who is not eligible to appear in the DrNB Final Examinations even though the admit card/roll number has been issued or name/roll number is displayed on NBEMS website.
- 2.15. Fee shall neither be carried forward to a future exams nor refunded on successful submission of application. Application once submitted can not be withdrawn under any circumstances. No such requests shall be entertained.
- 2.16. Candidates' eligibility is purely provisional & is subject to the fulfilment of eligibility criteria as prescribed by National Board of Examinations in Medical Sciences.
- 2.17. Instructions in the information-bulletin are liable to change based on decisions taken by the NBEMS from time to time.
- 2.18. NBEMS reserves its absolute rights to alter the examination schedule, pattern, policy and guidelines at any time during the continuation or after the completion of DrNB training (3 or 6 years as the case may be). The candidate shall have no right whatsoever for claiming/deriving any right from past or present schedule, policy and guidelines of National Board of Examinations in Medical Sciences.

- 2.19. NBEMS reserves its absolute right to alter, amend, modify or apply any or some of the instructions/ guidelines contained in this information bulletin.
- 2.20. The existing schedule, pattern, policy and guidelines are for ready reference only but in no way, they are or are ought to be treated as representative or acknowledgment of fact that NBEMS is bound to follow the same in future.
- 2.21. In case of any ambiguity in interpretation of any of the instructions/ terms/ rules/ criteria regarding the determination of eligibility/ conduct of examinations/ registration of candidates/ information contained herein, the interpretation of the National Board of Examinations in Medical Sciences shall be final and binding in nature.
- 2.22. Request shall not be entertained for change in date/ center of examination under any circumstances. Candidates are advised not to canvass for such representation.
- 2.23. Copy of application form submitted may be retained by the candidate for future reference.
- 2.24. Admit Cards for DrNB Final Examination shall be available to downloaded at NBEMS website <https://natboard.edu.in> from **13th January 2025 onwards.**
- 2.25. Result for DrNB Final Examinations shall be displayed on the website <https://natboard.edu.in>
- 2.26. Candidates should ensure before applying for DrNB Final Examinations that their MBBS/MD/MS/PG Medical Diploma is recognized by the National Medical Commission (NMC) as per provisions of the NMC Act, 2019. If it is found at any stage that the

Degree/Diploma is not recognized by NMC, NBEMS will have the right to cancel the registration/examination.

2.27.Registration with NBEMS is mandatory for all candidates appearing in DrNB Final Examinations. Candidates appearing in DrNB final examination on the basis of their DM/MCh qualifications are registered exclusively for the respective DrNB Final (Theory & Practical) Examination and shall be required to pay the registration fee again, if they wish to reappear in DrNB Final (Theory & Practical) Examinations of future sessions.

2.28.The applicant candidates should communicate with National Board of Examinations in Medical Sciences regarding matters related to DrNB Final Examinations as per prescribed communication protocols detailed under Chapter on Communication Protocol.

2.29.All the correspondence through post should be addressed to the Executive Director, National Board of Examinations in Medical Sciences, Medical Enclave, Mahatma Gandhi Marg, Ansari Nagar, New Delhi-110029. Candidates are requested to superscribe the envelope with the subject matter of the correspondence for expeditious processing.

**2.30.The jurisdiction for court cases/disputes shall be at New Delhi only.**

- 3.2. Applications forms once submitted cannot be withdrawn. Any claim for refund, adjustment or carrying forward of Application fee will not be entertained after successful submission of application.
- 3.3. **How to pay:** The prescribed exam fee should be remitted through payment gateway provided using a Credit Card or a Debit Card issued by banks in India or other modes as may be made available and have been provided on the web page.
- 3.4. Examination fees in respect of candidates who are absent or declared ineligible due to any reason will be forfeited. Candidates are advised to read the rule position carefully and satisfy the terms and conditions for fulfilment of eligibility criteria before proceeding for payment of fees.
- 3.5. Kindly ensure that the payment made for examination fee is successful and confirmation of the same can be seen in the application form under payment status reflected as "S" (for successful). In case the status is shown as pending, the payment might be stuck with your bank and might be cleared at a later date. The application submission process is not completed till such time the status of payment is reflected as "s" in application form.

---

NBEMS shall not be responsible for rejection of your application due to delay in settlement of the payment by your bank to NBEMS.

- 3.6. It is at the discretion of the applicant to make another payment for completing the application submission process. In an event of receipt of duplicate/multiple examination fees towards the same application ID, NBEMS shall refund the excess fees received for an application retaining the prescribed examination fee, after closure of application window. The time for refund of such excess fee varies from case to case depending upon the complete availability & verification of such multiple transaction details.

## 4. Examination for Super Specialties

### 4.1. For Super Specialties:

4.1.1. DrNB Final is a two-stage examination comprising of theory and practical examination. The list of Specialties in which candidates can undertake DrNB Final examination - January 2025 is mentioned at **Annexure-II**.

4.1.2. An eligible candidate who has qualified the theory examination is permitted to appear in the practical examination. Those who fail to qualify the theory examination are required to reappear in the theory examination.

4.1.3. The practical examination of the session in which the candidate qualifies the theory examination shall be the mandatory first attempt. This shall be counted as 'First Attempt' irrespective of whether the candidate choose to appear or remain absent. A candidate unsuccessful in the first attempt of practical examination or remaining absent in first attempt is permitted to undertake one more attempt of practical examination. This second attempt can be availed in next two consecutive sessions of DrNB Final (Super Specialty) Examinations.

**Example:** Candidates qualifying theory examination of January 2025 shall appear for their first attempt in the practical exams immediately following the theory examination of that session compulsorily and in the event of they not passing this practical examination, the candidate(s) may take second (and last) attempt at the practical exams of next two consecutive sessions of examination as and when conducted.

4.1.4. Absenteeism from Practical Examination after successful submission of application is counted as an attempt. Candidates who would fail to qualify the practical examination in all

---

permissible attempts shall be required to reappear in the theory examination.

## 4.2. Examination (Super Specialties):

### 4.2.1. Theory Examination

- Maximum Marks: 300
- The theory exam comprises of three question papers.
- There are 10 short notes of 10 marks each in the question paper
- The number of short notes and their respective marks weightage may vary in some subjects/some papers.
- Maximum time permitted is 3 hours for each question paper.
- Candidate must score at least 50% of maximum marks to qualify the theory exam i.e. candidate scoring 150 or more marks out of 300 shall be declared 'pass' in theory examination.
- Candidate must score at least 150/300 in the aggregate of 3 papers to qualify the theory examination. Grace marks of up to 2% of maximum marks i.e. 6/300 shall be given only to the candidates falling in the zone of consideration i.e. securing between 144-149 marks out of 300.
- Candidates who have qualified the theory examination are permitted to take up the practical examination.

### 4.2.2. Practical Examination

- Maximum Marks: 300
- Comprises of OSCE and/or Clinical Examination, and Viva.
- Candidate must obtain a minimum of 150/300 marks to qualify for the Practical Examination. There are no grace marks in Practical Examination.
- There are a maximum of two attempts that can be availed by a candidate for Practical Examination.
- First attempt is the practical examination following immediately after the declaration of theory results.

- 
- The second attempt shall be permitted out of the next 2 sessions of DrNB Final Examination.
  - Absentation from Practical Examination after successful submission of application is counted as an attempt. Appearance in first practical examination is compulsory.
  - Requests for Change in center/ date of examination are not entertained, as the same is not permissible. Candidates are required not to canvass with NBEMS for the same.
  - **DrNB Super Specialty trainees whose theses are not accepted by the National Board of Examinations in Medical Sciences by the time of announcement of practical examination centres shall not be allowed to appear in the practical examination.**
  - NBEMS reserves its right to make amendment to the scheme of practical examination with prior intimation to the applicant candidates.

### 4.3. Eligibility (Super Specialty)

#### 4.3.1. DrNB Super Specialty Candidates (Post MD/MS/DNB Broad specialty):

- Candidates who have undergone training as a DrNB trainee at any of the National Board of Examinations in Medical Sciences accredited institute after having registered with NBEMS as a DrNB trainee and are completing their prescribed (as per letter of registration issued by NBEMS) training as a DrNB trainee by **31st August 2025** & on submission of certificate to this effect, can undertake the DrNB Final Examination in the same specialty.
- Submission of Training Completion Certificate indicating details of leave taken during DrNB training for DrNB trainees is an essential pre-requisite. In case the candidate does not submit the training Completion certificate (as per applicable format given in Annexure III & IV) along with the application form, his/her application shall be rejected and fees forfeited.

- 
- Request for extension in cutoff date for completion of training for the purpose of eligibility determination for DrNB final Examination shall not be considered.
  - **Candidates who have completed their DrNB training while applying for DrNB Final Examination** shall be required to submit Final Training Completion Certificate (FTCC) as per format prescribed in Annexure - IV. Such candidates submitting Provisional Training Completion Certificate (PTCC) shall not be allowed to appear in the examination.
  - **Candidates whose DrNB training is ongoing while applying for DrNB Final Examination** shall be required to submit **Provisional Training Completion Certificate (PTCC)** as per format in Annexure-III. The PTCC must confirm that the candidate would be able to complete his/her training by the prescribed cut-off, after taking into consideration all leave taken vis-a-vis the maximum permissible leave as per NBEMS leave rules and the required period of extension, if any. Such candidates are required to submit **Final Training Completion Certificate (FTCC)** as per format in Annexure-IV **immediately on completion of their training**. Such candidates shall be provisionally allowed to appear for DrNB Final Examination subject to completion of their DrNB training by the prescribed cut-off date.
  - Candidates who submit their **Provisional TCC with correct leave details** projecting their training completion on/before the prescribed cut-off date for the examination, happen to avail more leave after applying for the examination due to some unforeseen reasons which might take their training beyond the prescribed cut-off date, shall NOT be declared INELIGIBLE for the examination.
    - If such a candidate qualifies the theory and practical examination, his/her Provisional Pass Certificate shall only be issued on completion of his/her DrNB training and submission of Final TCC to this effect.

- 
- If such a candidate qualifies theory examination but fails to qualify the practical examination, his/her candidature for theory examination shall remain valid and he/she shall be allowed to appear in the next remaining attempt(s) of practical examination, provided that he/she completes his/her DrNB training before the next attempt of practical examination.
  - However, candidates who at any stage are found to have misrepresented/failed to disclose the complete details of leave taken by them, in their **Provisional TCC**, shall be declared **INELIGIBLE** on failing to complete their training on/before the prescribed cut-off date for the examination. Candidature of such candidates for DrNB Final Examination shall stand cancelled and result, if any declared, shall be treated as null and void. It is the responsibility of candidate to furnish approval of NBEMS for leave availed by them wherever it was required to have been obtained from NBEMS.
  - In terms of the NBEMS notice dated 26th November 2019 (published on NBEMS website <https://natboard.edu.in>), appearance in minimum required numbers of Formative Assessment Tests (FATs) during the DrNB training shall be mandatory towards eligibility for appearing in DrNB Final Examinations. This compulsory participation in FATs shall apply to candidates who have joined their training in or after July 2019 admission session.

#### **4.3.2.DM/MCh Qualified Candidates:**

- Candidates who have passed the final examination, **on or before 31st October 2024**, leading to the award of a Doctoral Degree (DM/MCh), from an Indian University, which is duly recognized as per provisions of the National Medical Commission (NMC) Act, 2019 can apply for the DrNB Final examination in the same Super Specialty.
- Submission of proof of having qualified final examination for DM/MCh degree on or before **31st October 2024** is an essential



---

prerequisite. In case the candidate does not submit the requisite proof of qualifying final examination for DM/MCh degree by the prescribed cut-off date, his/ her candidature shall be cancelled & fees forfeited.

#### 4.4. Examination for Direct 6 Years Courses

- Candidates enrolled for DrNB Direct 6 year courses in Paediatric Surgery, Plastic Surgery, Neurosurgery and Cardiothoracic & Vascular Surgery are required to take Part – I & Part – II (Final) Examination.

After completing 2 years of DrNB training

**Part I Theory Exam (Paper I & II)**

**Part I Practical: A**

Clinical examination comprising of 4 short cases in the concerned specialty

**Part I Practical: B**

Clinical examination on OSCE pattern (General Surgery) and shall be common for all candidates in Paediatric Surgery, Plastic Surgery, Neurosurgery and Cardiothoracic Surgery

After qualifying Part I (Theory & Practical A + B), on being able to complete 5 years of DrNB training by the prescribed cut-off date and thesis submission to NBEMS for assessment\*

**DrNB Final Exam (Part II) Theory**

After qualifying Part II (Theory), on being able to complete 5 years of DrNB training by prescribed cut-off date and thesis acceptance by NBEMS\*

**DrNB Final Exam (Part II) Practical**

After qualifying Part II (Theory & Practical) & completing 6 years of DrNB training\*

**Provisional Pass Certificate/ Degree Certificate**

#### 4.4.1.Part I Examination for Direct 6 Years Courses

- Candidates enrolled for Direct 6-year courses (Paediatric Surgery, Plastic Surgery, Cardio Thoracic & Vascular Surgery and Neurosurgery) can take Part–I Examination on completion of their 2 years of DrNB training by the prescribed cut-off date subject to fulfilment of eligibility criteria. The cut-off date for completion of 2 years DrNB (Part I) training for the purpose of eligibility for DrNB Part I Examination January 2025 is **31st May 2025**.
- DrNB Part – I (Theory) Examination for candidates of Direct 6 year courses in Paediatric Surgery, Plastic Surgery, Neurosurgery and Cardiothoracic & Vascular Surgery comprises of two question papers.
- There are 10 short notes of 10 marks each in the question paper
- Maximum time permitted is 3 hours for each paper
- Candidate must score at least 50% of maximum marks to qualify the theory exam i.e. candidate scoring 100 or more marks out of 200 shall be declared 'pass' in theory examination.
- Candidate must score at least 100/200 in the aggregate of 2 papers to qualify the theory examination. Grace marks of up to 2% of maximum marks i.e. 4/200 shall be given only to the candidates

falling in the zone of consideration i.e. securing between 96-99 marks out of 200.

- Candidates who have successfully qualified the Part–I theory examination shall be required to appear in Part – I practical examination.
- The practical examination of the session in which the candidate qualifies the theory examination shall be the mandatory first attempt. A candidate unsuccessful in the first attempt of practical examination is permitted to undertake two more attempt(s) of practical examinations. These two attempts shall be any two practical examinations conducted in next three consecutive sessions of DrNB Final Examinations.

**Example:** Candidates qualifying theory examination of January 2025 shall appear for their first attempt in the practical exams immediately following the theory examination of that session compulsorily and in the event of they not passing this practical examination, the candidate(s) may take any two attempts at the practical exams of next three consecutive sessions of examination as and when conducted.

- NBEMS reserves its right to make amendment to the scheme of practical examination with prior intimation to the applicant candidates.

#### **4.4.2. Part II Examination (Final) for Direct 6 Years Courses**

- Candidates who joined Direct 6 years DrNB course in Plastic surgery, Pediatric Surgery, Cardiothoracic & Vascular surgery or Neurosurgery and have **successfully qualified Part-I examination** as direct 6 years candidates can take Part-II (Final) Examination on completion of 5 years of DrNB training by the prescribed cut-off date, subject to fulfilment of eligibility criteria.
- The cut-off date for completion of 5 years DrNB training for the purpose of eligibility for DrNB Final (Part II) Examination January 2025 is **31st May 2025**.
- Part-II (Final) Examination is common for candidates of 3 years and direct 6 years DrNB courses in the respective super specialties. However, Direct 6 years candidates appearing in DrNB final examination shall be exempted from appearing in question Paper-I. They will be required to attempt question paper II & III only. DrNB Super specialty Candidates (3year Courses) and MCh candidates will have to attempt all the three question papers. For details of Examination scheme for Part – II (Final) Examination, kindly refer to Section 5.1.

#### **4.5. Thesis Submission to NBEMS**

- As per NBEMS norms, writing a thesis is essential for all DrNB candidates towards partial fulfilment of eligibility for award of DrNB degree certificate.
- In terms of the NBEMS notice dated 07.11.2024, the last date for submission of thesis by DrNB trainees who are eligible to appear in the DrNB Final Theory Examination - January 2025 has been

---

notified as **30.11.2024**. DrNB trainees who have failed to submit their thesis to National Board of Examinations in Medical Sciences for assessment by **30.11.2024** are not eligible to apply for DrNB Final Theory Examination - January 2025.

- Candidates who have failed to qualify the Final theory examination in earlier sessions are not eligible to apply for any further final theory examinations till such time their theses are accepted by NBEMS.
- The status of thesis submission/acceptance, as may be applicable, shall be verified the time of submission of online application for DrNB Final Theory Examination.

### 5.1. DrNB Final (Super Specialty)

- The date, time and venue of practical examination shall be intimated to all candidates who have qualified theory examinations through their Online Exit Examination Portal (OEEP) account.
- NBEMS reserves its rights to allot a practical center anywhere in the country; the candidates shall make their own arrangement for travel/boarding etc. Change in centre of the practical examination is not permitted under any circumstances. Candidates are advised not to make any representations / not to canvass in this regard.

### 5.2. Admit Card:

- The admit card of the candidate for theory examination shall be available for download at NBEMS website <https://natboard.edu.in> from **13th January 2025 onwards**. Candidates are required to take print out of their admit card from the website, paste their photograph at the designated place and appear at exam centre along with one of the following original and valid / non-expired ID proof:

  - ❖ Driving License
  - ❖ Voter ID
  - ❖ Passport
  - ❖ Aadhaar Card (with Photograph)

### 5.3. Declaration of DrNB Final Examination Result:

- DrNB final is a qualifying examination.
- Results of DrNB final examinations (theory & practical) are declared as PASS/FAIL. In case, the applicant candidate is provisionally eligible on date of declaration of result his/her result shall be withheld & shall be declared only upon status being eligible, on receipt of required documents by the prescribed cut-off date.
- Results can be seen on NBEMS website <https://natboard.edu.in>
- **Marksheet:** The marks obtained in Final Theory and Practical Examinations can be seen at NBEMS website by all appeared candidates through candidate login. Combined marksheet of Theory and Practical Examinations shall be issued to all qualified candidates along with their Provisional Pass Certificates.
- **Digital copies/photocopies of theory answer scripts:** Candidate who would fail to qualify the DrNB Final Theory Examination can seek weblinks to access the digital copies of their answer scripts by paying Rs. 100/- (plus GST@18%) per question paper. Request for providing the same can be made through Communication Web Portal of NBEMS, *within 30 calendar days of declaration of theory result of concerned specialty*. The prescribed fee can be paid online through NBEMS website
- Candidates who would fail to qualify the Practical Examination can obtain detailed marksheet of practical examination on submission of a request through Communication Web Portal of NBEMS and on payment of a fee of Rs. 1000/- *within 30 calendar days of declaration of theory result of concerned specialty*. The prescribed fee can be paid online through NBEMS website.

- 
- **Re-evaluation:** There shall be a provision for re-evaluation of unassessed answer(s) only, in a rare event of an answer(s) being wrongly marked as NOT ATTEMPTED by the assessor. Request for re-evaluation of an unassessed answer(s) can be made through Communication Web Portal of NBEMS *within 45 calendar days of the declaration of theory result of the concerned specialty*. An administrative fee of Rs. 500/- per paper shall be charged for the same which can be paid online through NBEMS website.
  - Requests for re-evaluation of an unassessed answer(s) made after 45 calendar days of the declaration of theory result shall not be entertained. There shall be no re-evaluation of already assessed answers.
  - **Provisional Pass Certificate (PPC):** Candidates successful in the practical examination are issued a Provisional Certificate of Passing DrNB. Provisional Pass Certificates issued to qualified candidates shall be valid till the DrNB degree certificates are conferred upon them in the convocation of National Board of Examinations in Medical Sciences for all purposes, including but not limited to, employment, registration with state medical councils, higher education etc.
  - No separate certificate for passing theory examination will be issued.
  - Under normal circumstances the certificates of passing (PPC) are issued to the candidates within four weeks of declaration of results, however, due to unforeseen circumstances, this period may vary.
  - **Duplicate provisional pass certificate:** For issuing a duplicate provisional pass certificate, submit a request letter stating reasons to issue a duplicate certificate, copy of NCR lodged with police authorities clearly mentioning the loss/non-receipt of certificate, affidavit in support of application (attested by public notary/oath commissioner/judicial magistrate), fee of Rs. 1000/- + GST@18% for document upto preceding 3 years and Rs. 2000/- + GST@18% for



---

documents more than 3 years old. The fee can be paid online through NBEMS website.

- **Academic Transcripts:** Academic transcript of a candidate is released on receipt of a request directly from the concerned authority/ employer/ educational institution, subject to the availability of complete educational records with NEBMS related to DrNB training.
- Candidates are required to furnish copy of PPC issued by NBEMS, the Final Training Completion Certificate issued by the training institution, Thesis Acceptance Certificate and the letter of registration issued by NBEMS for issuance of transcript. The required documents can be submitted by candidates through Communication Web Portal of NBEMS to process their transcripts.
- The transcripts are either provided directly to the concerned authority/ employer/ educational institutions or provided to the candidate in a duly sealed envelope to be handed over to concerned authority/ employer/ educational institutions. No fee is charged for issuance of academic transcripts except for the postal charges (for sending the transcript outside India), if required. Academic transcripts are not released on request of candidates.
- **Attempt Certificate:** NBEMS issues attempt certificates to qualified candidates on receipt of a request from Communication Web Portal with supportive documents. Candidates are required to furnish copy of PPC issued by NBEMS, the Final Training Completion Certificate issued by the training institution and the letter of registration issued by NBEMS to them along with the document confirming where the said attempt certificate is required to be furnished. No fee is charged for issuance of attempt certificate.
- Candidates are advised not to canvass or approach NBEMS for handing over any of the credentials by hand. All these credentials are dispatched to the correspondence address provided by the

---

candidates in their application form/ in communications submitted through CWP from registered email ID.

- **Verification of Credentials:** NBEMS verifies the credentials (PPC/ Degree Certificate etc) issued to qualified candidates on receipt of a request from the concerned authority/ employer/ educational institutions. For any such verification, the candidate concerned is required to pay a verification fee to NBEMS of Rs. 2000/- (plus GST@18%) through online portal for fee payment and a receipt so generated needs to be shared with NBEMS through its Communication Web Portal. The outcome of verification shall be communicated by NBEMS to the authority/ employer/ educational institution concerned directly. Candidates are advised not to canvass for any such third party verifications of their credentials.

#### 5.4. Award of DrNB Degree certificates

- Candidates who have qualified both DrNB Final Theory & Practical Examinations, and whose theses have been accepted by National Board of Examinations in Medical Sciences, shall be conferred with DrNB degree in the specialty concerned on enrolment for the convocation.
- National Board of Examinations in Medical Sciences shall be conferring DrNB degree subject to fulfilment of eligibility criteria at the Convocation Ceremony. Details for the same are announced separately at NBEMS website <https://natboard.edu.in>

## 7. Instructions to Fill Online DrNB Final Application Form

- 7.1. Candidates shall be required to go to NBEMS website <https://natboard.edu.in> for submission of DrNB Final Examination application to National Board of Examinations in Medical Sciences.
- 7.2. After successful registration and submission of application, candidates can login to their *OEEP* account to check the status of the online application submitted for DrNB Final Examinations, any deficiency communicated to them to download the admit cards. *OEEP* can be accessed under Trainees Login >> Exit Examinations. Candidates can login to *OEEP* using the mobile number registered while filling up the online application.
- 7.3. Application for DrNB Final Theory Exam can only be submitted online through National Board of Examinations in Medical Sciences website <https://natboard.edu.in> There is no other methodology for application submission. Application submitted through any other mode shall be summarily rejected.
- 7.4. There are two stages in application process which require login through two different web pages:
- 7.4.1. *Apply for DrNB Final Examinations*: The online application form for DrNB Final Examinations can only be accessed under the quick link Examinations (top bar on website) >> Exit Examination >> DrNB Final Examinations >> Application Link. To create a user and to submit the application for January 2025, click on this link. After registration of user and getting a User ID, again click on this link and login to complete & submit the application form.

7.4.1.1. Following steps shall be required to be completed in sequence for application submission to NBEMS:

- A. **Register a User - *Online***
- B. **Complete Application form, Examination City Selection and Upload Prescribed Documents - *Online***
- C. **Pay Examination Fee - *Online***

7.4.1.2. The applicant candidate shall register a user for submission of application. The username and password shall be shared on registered mail ID. On successful registration, the applicant shall be required to complete the DrNB Final Examinations application form, pay the prescribed examination fee and upload the prescribed documents online. Candidates shall be able to preview the application form for any corrections required before final submission.

7.4.1.3. The applicant candidate may save and print the application form submitted online for future reference. There is no requirement to submit the hard copy print out of the application form and documents uploaded to NBEMS.

**7.4.2. *Candidate Login after Application Submission:*** This login would allow tracking the status of application, deficiency issued if any and access to practical examination details once the candidate qualifies the theory examination. This login shall be active only for those who have successfully submitted an online application. It may take few days after application submission for this login to be active. This web page can be accessed under Trainees Login tile on home page >> Exit Examinations >> OEEP.

7.4.2.1. The *Online Exit Examinations Portal* shall be the window of communication between NBEMS and the candidate. DrNB

Final Examinations related information shall be accessible to the candidate at this portal.

## A. Register a User - Online

- 7.5. **New User Registration:** All candidates desirous of applying for DrNB Final Examinations shall be required to create a user through the Application link under the tab DrNB Final Examination on NBEMS website. If password is lost, it can be retrieved by clicking “*Forgot Your Password*”.
- 7.6. After opening the NBEMS website <https://natboard.edu.in>, click on quick link Examination (available in top bar) to access the *Exit Examinations >> DNB/DrNB Exit Examination*. To apply for DrNB Final Examination January 2025, Click at “*Application Link*”. You will be diverted to a Registration/login page.
- 7.7. If the applicant candidate is a first time user at this portal, click “*Register New User?*”
- 7.8. **Candidates who have already registered a user to apply for DrNB Final Examination in previous sessions are strongly advised not to re-register a new user.**
- **Username/User ID:** Candidates who would register a “New User” will get their system generated username/User ID and password at the email ID provided on completion of profile creation. Application ID is generated after successful submission of an application. Application ID is not the User ID for login purpose.
  - **Name:** Name in your examination application should match with the **name in the Letter of Registration issued by NBEMS or Name mentioned in DM/MCh degree certificate, as the case may be.**
    - In an event your name has changed subsequent to getting registered with NBEMS/ issuance of DM/MCh degree

- Name once registered for the DrNB Final Examination can not be edited in the applications to be submitted. Request for change of name after submission of application shall not be considered.

- **Email ID:** Email ID chosen by the applicant candidate shall be verified through a system generated OTP for user creation. Same email ID can not be used for registration of any other user concurrently. Please note that all email correspondence with the applicant candidate shall be done at this email ID only. Correspondence received from any other email ID of the candidate shall not be entertained.
- **Mobile No:** Please provide the desired mobile number for receiving all Exit Examinations related communications. Please note that all telephonic correspondence with the applicant candidate shall be done at this mobile number only. You can always modify the existing profile by logging in using your user ID and password.

After entering the registration number, click on the link **“Click here to see thesis status” to fetch your thesis status.** Candidates who fulfill the thesis related requirement prescribed in the bulletin shall alone be allowed to complete the application form. For any query related to thesis status/status not being updated in NBEMS database, please contact thesis section of NBEMS through the communication web portal of NBEMS.

- 8.9. By registering for and /or appearing in DrNB Final Examination - January 2025, the candidate explicitly agrees to the above Non Disclosure Agreement and general terms of use for DrNB Final Examinations as contained in this Information Bulletin and DrNB Final Examination - January 2025 webpage.

Any candidate found guilty of having adopted anyone or more of the above Unfair means/misconduct is liable to be penalized with a penalty by the Ethics Committee, which may vary from cancellation of the examination/ expulsion up to next 14 attempts or 7 yrs and/or cancellation of candidature as may be decided by Examinations Ethics Committee after considering each case.

8.48. The above list is purely indicative. If any act of omission or commission attributed to the candidate/intent by the candidate to vitiate the sanctity of the examination in decision of NBEMS shall be taken up as unfair means.

# 10. Leave Rules for NBEMS Trainees

In supersession of leave rules for NBEMS trainees published earlier by NBEMS, the following rules shall be applicable with effect from 22.11.2024 on all NBEMS trainees:

## 1. Purpose:

The purpose of NBEMS Leave Rules is to establish guidelines and procedures for managing leave for trainees registered with NBEMS (National Board of Examinations in Medical Sciences) to undergo PG medical training at NBEMS accredited institutions.

## 2. Eligibility:

Every programme of the NBEMS requires a mandatory period of training which must be completed in order to be eligible to take the Exit Examination. NBEMS trainees must take utmost care to complete their training well within the cut-off date in order to be eligible to take the Exit Examination.

## 3. Leave Entitlement:

During the period of training, candidates are entitled to avail leave only in the following terms:

- a) NBEMS trainees are entitled to a maximum of 30 days of leave per year of training, which is the '*eligible leave*' for each NBEMS trainee.
- b) In addition, a candidate is entitled to a weekly / duty off during his / her training.
- c) However, when a candidate is on leave, the weekly / duty off mentioned in sub clause (b) above will be included in the leave taken by the candidate. For eg: If a candidate has taken leave for 30 days, the weekly / duty off during these 30 days will be

---

included as a part of the leave taken by the candidate. The candidate will not be entitled to deduct the weekly / duty offs during the said period and count them either towards training or towards leave in addition to the 30 days.

- d) **Maternity/Paternity Leave:** Maternity leave shall be granted to female trainees in accordance with Central or State Government policies applicable to the training institute. The Expected Date of Delivery (EDD)/ Date of Delivery (DoD) should fall within the duration of maternity leave applied for. Further, in whichever States 6 months of maternity leave is permissible as per policies applicable there, it can be availed during 2 months prior to EDD to 6 months after DoD. Paternity leave for maximum 2 weeks can be availed by male trainees.
- e) There is no provision of extension of maternity leave beyond permissible period or grant of Child Care Leave (CCL) in the NBEMS training programme.
- f) Trainees must note that the grant of Maternity / Paternity leave or leave on any other account does not mean that their training shall not be extended on account of their absence during the period they are on leave. Candidates are entitled to the benefit only of '*eligible leave*' i.e. **30 days per year** for the purposes of their training and any other leave availed by them on any ground whatsoever shall lead to the extension of training. Candidates must also note that if as a consequence of extension, their training extends beyond the cut-off date prescribed in the respective Information Bulletin for the final examination, he/ she shall not be eligible to appear in the said final examination.
- g) No study leave whatsoever is permissible to the NBEMS trainees. The eligible leave of 30 days a year could be used for any purposes as may be required. However, the trainees are not permitted to take up any employment or enroll for any other academic course during the leave period.

---

#### 4. Leave Application Procedure:

- a) Eligible leave of 30 days per year shall be granted by the training institution at their level. Any leave over and above the '*eligible leave*' of 30 days per year shall be forwarded through the training institution with its recommendations to NBEMS for consideration. Any request of leave over and above the eligible leave of 30 days shall be submitted to NBEMS by way of an **NBEMS Leave Application Form** well in advance to obtain NBEMS approval before proceeding on leave. Leave requests must be supported with relevant documents as per guidelines detailed in the NBEMS Leave Application Form. The leave application form, duly endorsed by the training institution, *shall have to be submitted by the trainee to NBEMS*, only through NBEMS communication web portal before proceeding on leave.
- b) Requests for post-facto approval of leave shall not be entertained and the trainee shall be considered on an unauthorized absence for such period.

#### 5. Extension of Training:

- a) As explained in Rule 3 above, any leave availed by an NBEMS trainee other than the eligible leave (30 days per year) shall lead to extension of NBEMS training. This extension shall be equal to the number of days of excess leave availed by the trainees.
- b) The training period as prescribed in the letter of registration issued by NBEMS in terms of number of calendar days/month/years must be completed for successful completion of NBEMS training. Any extension, if so required to be undertaken due to excess leave availed in a year, can only be done by working for the number of days equal to the excess leave availed during the training programme.



- 
- c) The extension of training period cannot be compensated by way of working extra hours on working days or by working on holidays or in any manner other than prescribed herein above.
  - d) Eligible leave of one year shall not be carried forward to the next year or clubbed with the eligible leave of next year to calculate the total period of extension required to be undertaken. The leave remaining unutilized in a year shall lapse on expiry of the year. In *exceptional circumstances*, NBEMS may allow balance leave of one year to be credited against the leave availed in next year(s) of training, on a case-to-case basis, to arrive at the period of extension required to be undertaken.

#### **6. Considerations During Leave Period:**

- a) Days for attending NBEMS Final Theory & Practical Examinations and Formative Assessment Tests will be considered towards period of training and not as leave.
- b) The trainees are paid stipend for the entire duration of training including their eligible leave as per NBEMS stipend guidelines. However, they shall not be paid stipend for a period more than the duration of the training programme i.e. 36 months (for a 3-year programme) or 24 months (for the 2 year Programme) or 72 months (for the 6 year programme), if in case their training gets extended due to excess leave availed by them.

#### **7. Compliance and Enforcement:**

- a) Trainees are required to comply strictly with NBEMS leave rules and institutional policies.
- b) Failure to comply may result in disciplinary action, including cancellation of candidature.
- c) NBEMS trainee must be careful while applying for leave. They must take note that if the total leave availed by them during the training programme is more than a year, it shall lead to the

---

cancellation of the candidature of the NBEMS trainee and shall disentitle him/her from pursuing the NBEMS programme. Candidates must therefore ensure that the leave taken by them must under no circumstances exceed a year.

- d) Any absence from the training that is not in accordance with the present Rules shall amount to Unauthorized Absence and such absence from NBEMS training for more than 7 days *may* lead to cancellation of registration and discontinuation of the NBEMS training.
- e) If on account of the leave taken by the NBEMS trainee, his/her training have been extended beyond the cut-off date prescribed in the respective Information Bulletin for the final examination, he/she shall not be eligible to appear in the said final examination. NBEMS trainees must therefore keep this in mind while taking leave from the training programme.
- f) The eligibility for DNB/ DrNB/ FNB/ NBEMS Diploma Final Examination shall be determined strictly in accordance with the criteria prescribed in the respective information bulletins.

These rules shall be applicable with immediate effect on all ongoing NBEMS trainees as well.

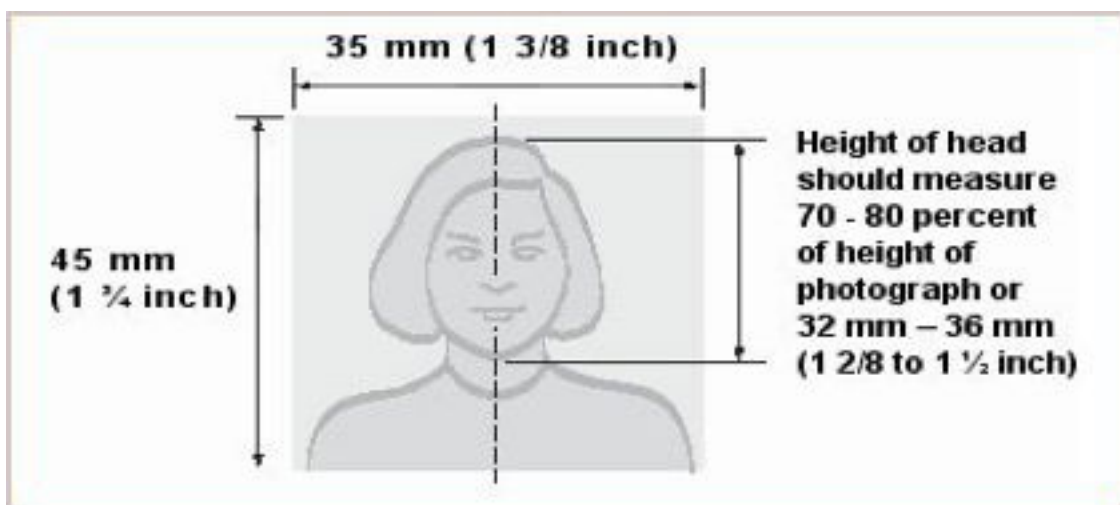
## Image Upload Instructions

**Note: Kindly go through the guidelines carefully. Images uploaded in the application form which are not in accordance with the guidelines or failure to rectify the images shall invite rejection of application.**

Before applying online, a candidate will be required to have a scanned (digital) image of his/her photograph, signature and thumb impression as per the specifications given below. Your online application will not be registered unless you upload your photograph, signature and thumb impression as specified.

### **A. PHOTOGRAPH**

**Processes for photo upload:**



The candidate shall be required to upload **TWO** photographs:

1. A **REAL TIME PHOTOGRAPH** taken by the webcam/in-built camera of the computer system while filling the online application form:
  - a. Confirm that the system used to fill the form has an in-built camera/webcam.
  - b. Be properly dressed in a formal attire.
  - c. Stand/sit against a **white background** (Avoid distracting backgrounds)

- d. There should be bright light falling on your face but not on the webcam.
  - e. No objects should be behind you while capturing the photograph through web cam). The image **must not include other objects or additional people**. Ensure that you are only one person in picture.
  - f. The image must contain the full face, ears, neck, and shoulders of the entrant in frontal view with a neutral, non-smiling expression and with eyes open and directed at the camera.
  - g. The image must not contain any parts of the body below the entrant's shoulders.
  - h. Click on "Capture Photo" button in the application form.

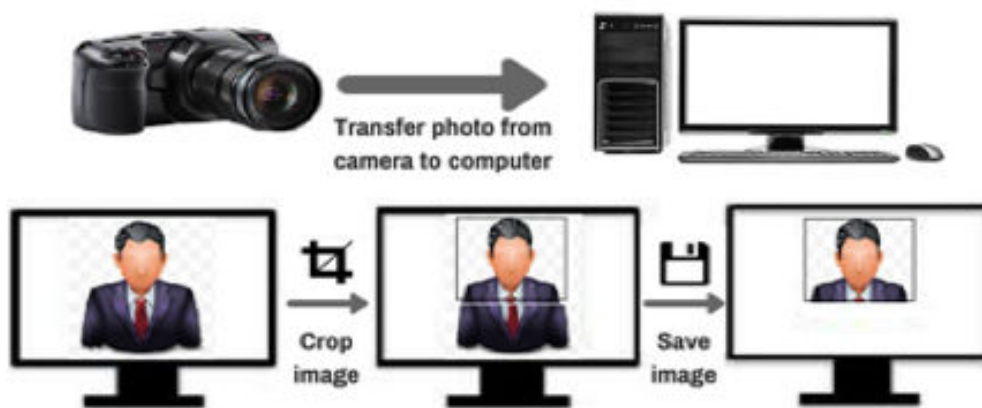

- a. Preference to be given to upload a photograph taken in a photo-studio in last 3 months to avoid any likely error in photograph. If you decide to take the photograph at home, please follow the instructions mentioned below.
- b. Be properly dressed in a formal attire.
- c. Click colour photograph in **bright light** using any high resolution digital device (preferably with > 5-megapixel resolution). Avoid using flash as it tends to create a shadow on the white background. Images which are taken in with improper light shall be rejected.
- d. Avoid selfie; ask someone else to take the picture for you. They might also help to direct you a bit, like telling you to straight your head or tuck your hair behind your ears. Selfies shall be rejected.
- e. Do not wear spectacles (to avoid reflection in the glass), cap, goggles, stethoscope around neck, makeup, ornaments while getting the photo shot.

- g. No object should be in the background. The image must not include other objects or additional people. Ensure that you are only one person in picture. Images having any object in the background shall be rejected.

  - i. The image must not contain any parts of the body below the entrant's shoulders. Images having parts of body below the shoulder shall be rejected.

- c. Your face is clearly visible.

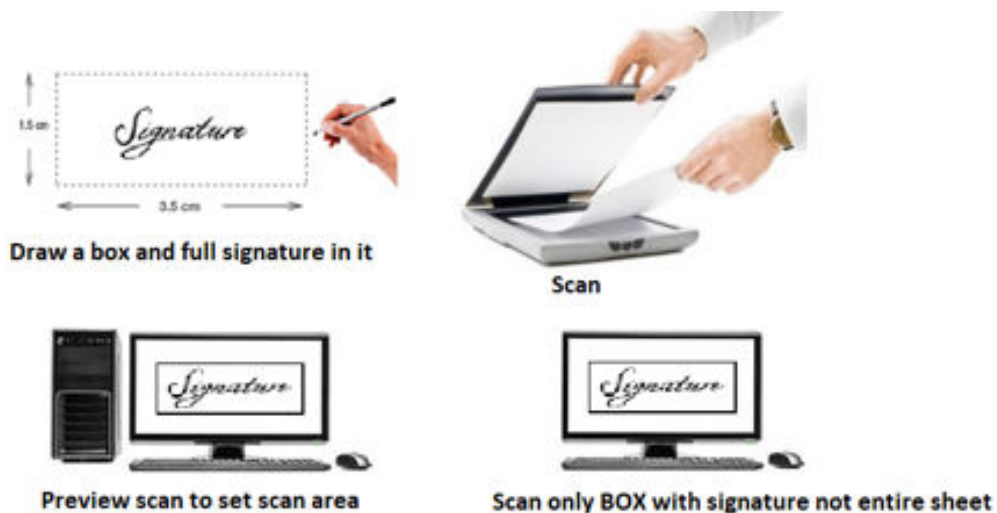

### Editing digital image of the signature:

- If required, use **auto-correct feature** of image editing software so that the signature is clear against a white background.
- Crop** the image such that borders of box are reached.
