1. Introduction

The Government of India established the National Board of Examinations in Medical Sciences (NBEMS) in 1975 with the objective of improving the quality of the Medical Education by establishing high and uniform standards of postgraduate examinations in modern medicine on an all India basis and utilizing existing infrastructure for capacity building.

NBEMS at present conducts postgraduate and postdoctoral examinations in approved specialties leading to the award of Diplomate of National Board (DNB) and Doctorate of National Board (DrNB) respectively. NBEMS has started diploma courses in approved disciplines from 2021 admission session.

The Examinations conducted by NBEMS provide a common standard and mechanism of evaluation of minimum level of attainment of the knowledge and competencies of medical specialties. Moreover, intra country and international comparisons are facilitated with the availability of common evaluation mechanism.

The notification issued in the Gazette of India for qualifications awarded by National Board of Examinations in Medical Sciences are available under **Annexure - I** to this bulletin.

2. Information for Candidates

- 2.1. NBEMS Diploma Final is an exit examination leading to the award of NBEMS Diploma qualification in respective discipline. National Board of Examinations in Medical Sciences will conduct NBEMS Diploma Final Examination biannually in June and December every year.
- 2.2. The next session of NBEMS Diploma Final Theory Examination shall be held in December 2024 as per schedule detailed under Important Dates and Scheme of Examination.
- 2.3. A candidate registered with NBEMS as a NBEMS Diploma trainee and obtaining requisite period of training as prescribed by NBEMS & fulfilling other eligibility criteria as stated in the Information Bulletin may appear for the NBEMS Diploma final examination.
- 2.4. Candidates should go through this bulletin carefully for eligibility criteria before applying. Queries pertaining to eligibility and other issues will only be entertained if the information requested is not given in the bulletin of information or National Board of Examinations in Medical Sciences website <https://natboard.edu.in>
- 2.5. The list of specialties in which examination will be conducted can be seen at **Annexure II**
- 2.6. Candidates are deemed to have read, agreed and accepted the Information Bulletin and the terms and conditions in the Information Bulletin for NBEMS Diploma Final Examination - December 2024 on completing the online submission of application form.
- 2.7. Candidate should ensure that all the information entered during the online submission of application form is correct and factual.

Information provided by the candidates in the online application form shall be treated as correct.

- 2.8. Candidate should ensure that all the information entered during the online submission of application form is correct and factual. Information provided by the candidates in the online application form shall be treated as correct. The option of editing certain information entered in the application form shall be available to the candidates during the edit window. **NBEMS will not entertain, under any circumstances, any request for change in the information provided by the candidates after closure of the edit window.** Please refer Chapter on Instructions to fill Application Form for details regarding Edit Window.
- 2.9. **NBEMS itself does not edit /modify/alter any information entered by the candidates at the time of online submission of application form under any circumstances.** There is no provision of accessing the application form to make any changes in the information provided in the application form after closure of edit window. Such requests to make any changes shall not be entertained. Candidates, however, shall be able to rectify the deficiencies in their application (if so communicated by NBEMS) regarding images and documents uploaded, by the prescribed cut-off dates.
- 2.10. Please refer Chapter on *Instructions to Fill NBEMS Diploma Final Examination - December 2024 Application Form*. Candidates are advised to review their applications submitted and rectify the deficiencies, if found any, within the window as detailed below. Candidates may note that deficiency in the application form pertaining to images uploaded may be communicated to them by NBEMS, however, **it shall be the sole responsibility of the applicant to ensure that the application submitted is complete in all aspects as per the information bulletin.** If any deficiency in the application which was not communicated by NBEMS to the applicant before conduct of the examination, is noted at any later

stage, this would not create any equity in favour of the candidate and confer any rights on to the candidates for grant of eligibility for the examination.

2.10.1.Edit Window: Candidates who have successfully submitted their payment for the application during Application Submission window shall only be allowed to edit their applications during **7th November 2024 to 10th November 2024**. No new application can be registered or payment can be made during edit window. However, the balance fee required, if any, in case of change in candidate category and/or PwD status can be paid during the edit window. **Any information/document can be changed/corrected during the edit window except for Name, Test City, Nationality, Mobile Number and Email ID.** Information can be edited any number of times before the closure of the window. The last submitted information will be saved in records.

2.10.2.Final Edit Window: Deficiency related to images uploaded (photograph, Signature, Thumb Impression) shall be intimated to the concerned candidates and same can be corrected during the **Final edit window** i.e. **18th November 2024 to 20th November 2024**. A list of such applicants who would fail to rectify their images in the application form shall be published on NBEMS website to enable them to rectify the images as per image upload guidelines. Applications of such candidates who would fail to rectify their images even during this FINAL edit window shall be rejected. No further opportunity shall be given to make corrections. Candidates are advised to submit the images in their application as per prescribed image upload guidelines. **Failure to submit images as per guidelines and/or failure to rectify the images shall invite rejection of the application.**

2.11. Application for NBEMS Diploma Final Theory Exam can only be submitted online through National Board of Examinations in Medical Sciences website <https://natboard.edu.in> There is no

other methodology for application submission. Application submitted through any other mode shall be summarily rejected. There is no requirement to submit the hard copy print out of the application form and documents uploaded to NBEMS website.

2.12.A candidate can submit the application form only once. If a candidate is found to have submitted more than one application form for NBEMS Diploma Final Examination December 2024, NBEMS may issue admit card to the application bearing higher order Application number (application ID) and cancel other application(s) forfeiting the fee for them. In an event any unfair practice is detected by NBEMS at any stage of examination/ admission process, NBEMS may cancel the candidature of such candidates and debar them from appearing in any examinations conducted by NBEMS as per provisions of the Unfair Means Guidelines.

2.13.Applications of candidates producing false or fabricated information/records will not be considered and such candidates will be further debarred from appearing in the future examinations of NBEMS. Action as deemed appropriate by NBEMS will be taken if false or fabricated records/ information is submitted or any unfair means are used.

2.14.Candidates who fail to submit duly completed applications with requisite documents and/or fail to rectify the deficiencies in their applications by the last date prescribed for rectification shall be declared ineligible. **Admit Card shall not be issued to candidates who are declared ineligible before conduct of examination.** In such cases, the entire fees will be forfeited.

2.15.Candidates are advised to ensure that the information provided is factual and supported with documents. Columns marked (*) in the application form are mandatory and can not be left blank. In the event of rejection of the application form, no correspondence/ request for re-consideration will be entertained.

- 2.16. Candidates should go through this bulletin carefully for eligibility criteria before applying. Queries pertaining to eligibility and other issues will only be entertained if the information requested is not given in the bulletin of information or NBEMS website. No Queries of the Guardians/Parents/Spouse will be entertained on telephone with regard to the eligibility and disclosure of the results.
- 2.17. Candidate found ineligible for NBEMS Diploma Final examination, will not be permitted to appear in the examination. In an unlikely event of any ineligible candidate appearing and/or passing the NBEMS Diploma examination, the results/candidature of such candidate shall be cancelled and/or is deemed to be cancelled, even if result has been declared/ Pass Certificate has been issued.
- 2.18. Candidature of candidates who are allowed to appear provisionally in the examination shall be cancelled and result, if declared, shall be treated as null and void if they fail to submit the required documents towards fulfilling the eligibility criteria prescribed.
- 2.19. NBEMS reserves the right to withdraw permission, if any, granted inadvertently to any candidate who is not eligible to appear in the NBEMS Diploma Final Examinations even though the admit card/roll number has been issued on NBEMS website.
- 2.20. Fee shall neither be carried forward to a future exams nor refunded under any circumstances. Application once submitted can not be withdrawn.
- 2.21. Candidates' eligibility is purely provisional & is subject to the fulfilment of eligibility criteria as prescribed by National Board of Examinations in Medical Sciences.

- 2.22. Instructions in the information-bulletin are liable to change based on decisions taken by the NBEMS from time to time.
- 2.23. NBEMS reserves its absolute rights to alter the examination schedule, pattern, policy and guidelines at any time during the continuation or after the completion of NBEMS Diploma training (2 years). The candidate shall have no right whatsoever for claiming/ deriving any right from past or present schedule, policy and guidelines of National Board of Examinations in Medical Sciences.
- 2.24. The existing schedule, pattern, policy and guidelines are for ready reference only but in no way, they are or are ought to be treated as representative or acknowledgment of fact that NBEMS is bound to follow the same in future.
- 2.25. In case of any ambiguity in interpretation of any of the instructions/ terms/ rules/ criteria regarding the determination of eligibility/ conduct of examinations/ registration of candidates/ information contained herein, the interpretation of the National Board of Examinations in Medical Sciences shall be final and binding in nature. There is no equity or any rights that are /or deemed to be arising in favour of candidate. Candidates are required to refer to the latest bulletin or corrigendum that may be issued to incorporate these changes. Refer NBEMS website <https://natboard.edu.in> for latest updates or corrigendum.
- 2.26. Request shall not be entertained for change in date/center of examination under any circumstances. Candidates are advised not to canvass for such representation.
- 2.27. Copy of application form submitted may be retained by the candidate for future reference.

- 2.28. Admit Cards for NBEMS Diploma Final Examination shall be available to be downloaded at NBEMS website <https://natboard.edu.in> from **10th December 2024 onwards**.
- 2.29. Result for NBEMS Diploma Final Examinations shall be displayed on the website <https://natboard.edu.in>
- 2.30. Candidates should ensure before applying for NBEMS Diploma Final Examinations that their MBBS qualification is recognized by the National Medical Commission (NMC) as per provisions of the NMC Act, 2019. If it is found at any stage that the MBBS qualification is not recognized by the NMC, the NBEMS will have the right to cancel registration for the course/candidature for the examination.
- 2.31. Registration with NBEMS is mandatory for all candidates desirous of appearing in NBEMS Diploma Final Examinations.
- 2.32. NBEMS Diploma Final Examination - December 2024 shall be conducted by NBEMS at various exam centres engaged for the purpose. Candidates are advised to familiarise themselves with the route and location of the exam centre well in advance to avoid any last minute delay in arrival to the exam centre. Please refer Chapter on details of Test Day Procedures.
- 2.33. The examination test centre staff on duty is authorized to verify the identity of candidates and may take steps to verify and record the identity of candidates. Candidates are required to extend requisite cooperation.
- 2.34. Possession/Use of mobile phones/Electronic devices is strictly prohibited in the premises of NBEMS test Centres. Candidates shall be liable for penal action for Possession/ Use of Mobile phones/ Electronic devices. Resorting to use of any unfair practice in NBEMS Diploma Final Examination December 2024 shall be

dealt with as per the Unfair Mean Guidelines of NBEMS. Such candidates shall be imposed academic and/or criminal punishments as may be applicable. Please go through guidelines detailed in Chapter on use of unfair means in the examination.

2.35. The applicant candidates should communicate with National Board of Examinations in Medical Sciences regarding matters related to NBEMS Diploma Final Examinations as per prescribed communication protocols detailed under Chapter on Communication Protocol.

2.36. Candidates are encouraged to communicate for NBEMS Diploma Final Examination - December 2024 through “Helpdesk” tab which can be accessed after the applicant login to its application account. The correspondence through post should be addressed to the Executive Director, National Board of Examinations in Medical Sciences, Medical Enclave, Mahatma Gandhi Marg, Ansari Nagar, New Delhi-110029. Candidates are requested to superscribe the envelope with the subject matter of the correspondence for expeditious processing.

2.37. The jurisdiction for court cases/disputes shall be at New Delhi only.

3. Fee Structure

- 3.2. Applications forms once submitted cannot be withdrawn. Fee shall neither be carried forward to a future date nor refunded under any circumstances. Any claim for refund, adjustment or carrying forward of Application fee will not be entertained after successful submission of application.
- 3.3. **How to pay:** The prescribed exam fee should be remitted through payment gateway provided using a Credit Card or a Debit Card issued by banks in India or other modes as may be made available and have been provided on the web page. Fee can not be deposited through any mode other than the payment gateway available while submitting online application form submission.
- 3.4. Examination fees in respect of candidates who are absent or declared ineligible due to any reason will be forfeited. Candidates are advised to read the rule position carefully and satisfy the terms and conditions for fulfilment of eligibility criteria before proceeding for payment of fees.
- 3.5. Kindly ensure that the payment made for examination fee is successful and confirmation of the same can be seen in the application form under payment status reflected as "S" (for successful). In case the status is shown as pending, the payment might be stuck with your bank and might be cleared at a later date. The application submission process in not completed till such time the status of payment is reflected as "s" in application form.

NBEMS shall not be responsible for rejection of your application due to delay in settlement of the payment by your bank to NBEMS.

- 3.6. It is at the discretion of the applicant to make another payment for completing the application submission process. In an event of receipt of duplicate/multiple examination fees towards the same application ID, NBEMS shall refund the excess fees received for an application retaining the prescribed examination fee, after closure of application window.

4. Examination for NBEMS Diploma Courses

4.1. Outline of Examination:

4.1.1. NBEMS Diploma Final is a two-stage examination comprising of theory and practical examination.

4.1.2. An eligible candidate who has qualified the theory examination is permitted to appear in the practical examination. Those who fail to qualify the theory examination are required to reappear in the theory examination.

4.1.3. The practical examination of the session in which the candidate qualifies the theory examination shall be the mandatory first attempt. This shall be counted as 'First Attempt' irrespective of whether the candidate choose to appear or remain absent. A candidate unsuccessful in the first attempt of practical examination or remaining absent in first attempt is permitted to undertake two more attempt(s) of practical examinations. These two attempts shall be any two practical examinations conducted in next three consecutive sessions of NBEMS Diploma Final Examinations.

Example: Candidates qualifying theory examination of December 2024 shall appear for their first attempt in the practical exams immediately following the theory examination of that session compulsorily and in the event of they not passing this practical examination, the candidate(s) may take any two attempts at the practical exams of next three consecutive sessions of examination as and when conducted.

4.1.4. Absenteeism from Practical Examination after successful submission of application is counted as an attempt. Candidates who would fail to qualify the practical examination in all permissible attempts shall be required to reappear in the theory examination.

4.1.5. The list of Specialties in which candidates can undertake NBEMS Diploma Final examination are mentioned at **Annexure-II**.

4.2. Scheme of Examination:

4.2.1. Theory Examination

- The theory examination comprises of three papers, maximum marks 100 each.
- There are 10 short notes of 10 marks each, in each of the papers.
- The number of short notes and their respective marks weightage may vary in some subjects/some papers.
- Maximum time permitted is 3 hours.
- Candidate must score at least 150/300 in the aggregate of 3 papers to qualify the theory examination. Grace marks of up to 2% of maximum marks i.e. 6/300 shall be given only to the candidates falling in the zone of consideration i.e. securing between 144-149 marks out of 300.
- Only those candidates who have qualified the theory examination are permitted to take the practical examination.

4.2.2. Practical Examination

- Maximum Marks: 300
- Comprises of OSCE and/or Clinical Examination, and Viva.
- Candidate must obtain a minimum of 150/300 marks to qualify for the Practical Examination.

-
- There is no provision for grace marks in Practical examination.
 - There are a maximum of three attempts that can be availed by a candidate for Practical Examination.
 - First attempt is the practical examination following immediately after the declaration of theory results in the same session.
 - Second and Third attempt in practical examination shall be permitted out of the next three sessions of NBEMS Diploma Final Examination; after payment of full examination fees as may be prescribed by NBEMS.
 - Absenteeism from Practical Examination after successful submission of application is counted as an attempt. First Practical Examination is counted mandatorily as an attempt irrespective of whether the candidate appear in it or choose to remain absent.
 - Requests for Change in center/date of examination are not entertained, as the same is not permissible. Candidates are required not to canvass with NBEMS for above.
 - NBEMS reserves its right to make amendment to the scheme of practical examination with prior intimation to the applicant candidates.

4.3. Eligibility

- Candidates who have undergone training as a NBEMS Diploma trainee at any of the National Board of Examinations in Medical Sciences accredited institute after having registered with NBEMS as a NBEMS Diploma trainee and are completing their prescribed (as per letter of registration issued by NBEMS) training as a NBEMS Diploma trainee by **30th June 2025** & on submission of certificate to this effect, can undertake the NBEMS Diploma Final Examination in the same specialty.
- Submission of Training Completion Certificate indicating details of leave taken during Diploma training for NBEMS Diploma trainees is an essential pre-requisite. In case the candidate does not

submit the training Completion certificate (as per applicable format given in Annexure III & IV) along with the application form, his/her application shall be rejected and fees forfeited.

- Request for extension in cutoff date for completion of training for the purpose of eligibility determination for NBEMS Diploma final Examination shall not be considered.
- **Candidates who have completed their NBEMS Diploma training while applying for NBEMS Diploma Final Examination** shall be required to submit Final Training Completion Certificate (FTCC) as per format prescribed in Annexure - IV.
- **Candidates whose NBEMS Diploma training is ongoing while applying for NBEMS Diploma Final Examination** shall be required to submit **Provisional Training Completion Certificate (PTCC)** as per format in Annexure-III. The PTCC must confirm that the candidate would be able to complete his/her training by the prescribed cut-off, after taking into consideration all leave taken vis-a-vis the maximum permissible leave as per NBEMS leave rules and the required period of extension, if any. Such candidates are required to submit **Final Training Completion Certificate (FTCC)** as per format in Annexure-IV **immediately on completion of their training**. Such candidates shall be provisionally allowed to appear for NBEMS Diploma Final Examination subject to completion of their NBEMS Diploma training by the prescribed cut-off date.
- Candidates who submit their **Provisional TCC with correct leave details** projecting their training completion on/before the prescribed cut-off date for the examination, happen to avail more leave after applying for the examination due to some unforeseen reasons which might take their training beyond the prescribed cut-off date, shall NOT be declared INELIGIBLE for the examination.

-
- If such a candidate qualifies the theory and practical examination, his/her Provisional Pass Certificate shall only be issued on completion of his/her NBEMS Diploma training and submission of Final TCC to this effect.
 - If such a candidate qualifies theory examination but fails to qualify the practical examination, his/her candidature for theory examination shall remain valid and he/she shall be allowed to appear in the next remaining attempt(s) of practical examination, provided that he/she completes his/her NBEMS Diploma training before the next attempt of practical examination.
 - However, candidates who at any stage are found to have misrepresented/failed to disclose the complete details of leave taken by them, in their **Provisional TCC**, shall be declared **INELIGIBLE** on failing to complete their training on/before the prescribed cut-off date for the examination. Candidature of such candidates for NBEMS Diploma Final Examination shall stand cancelled and result, if any declared, shall be treated as null and void.
 - As per NBEMS norms, appearance in at least ONE Formative Assessment Test (FAT)/Internal Assessment conducted by the Hospital or FAT conducted by NBEMS during the NBEMS Diploma training shall be mandatory towards eligibility for appearing in NBEMS Diploma Final Examinations.

5.2. NBEMS Diploma Final Practical Examinations:

- The date, time and venue of practical examination shall be intimated to all candidates (who have qualified theory examinations) through their Online Exit Examination Portal (OEEP) account. A list of candidates who are allotted practical examination centres is also published on NBEMS website under the quick link: *Practical Exam Centre*
- NBEMS reserves its rights to allot a practical center anywhere in the country; the candidates shall make their own arrangement for travel/boarding etc. Change in centre of the practical examination is not permitted under any circumstances. Candidates are advised not to make any representations / not to canvass in this regard.

5.3. Admit Card:

- The admit card of the candidate for theory examination shall be available for download at NBEMS website <https://natboard.edu.in> from **10th December 2024 onwards**. Candidates are required to take print out of their admit card from the website, paste their photograph at the designated place and appear at exam centre along with one of the following original and valid / non-expired ID proof:

 - ❖ Driving License
 - ❖ Voter ID

 - ❖ Aadhaar Card (with Photograph)

5.4. Declaration of NBEMS Diploma Final Examination Result:

- NBEMS Diploma final is a qualifying examination.
- Results of NBEMS Diploma final examinations (theory & practical) are declared as PASS/FAIL. In case, the applicant candidate is provisionally eligible on date of declaration of result his/her result shall be withheld & shall be declared only upon status being eligible, on receipt of required documents by the prescribed cut-off date.
- Results can be seen on NBEMS website <https://natboard.edu.in>
- **Marksheet:** The marks obtained in Final Theory and Practical Examinations can be seen at NBEMS website by all appeared candidates through candidate login. Combined marksheet of Theory and Practical Examinations shall be issued to all qualified candidates along with their Provisional Pass Certificates.
- **Digital copies/photocopies of theory answer scripts:** Candidate who would fail to qualify the NBEMS Diploma Final Theory Examination can seek web-links to access the digital copies of their answer scripts by paying Rs. 100/- (plus GST@18%) per question paper. Request for providing the same can be made through Communication Web Portal of NBEMS, within 30 calendar days of declaration of theory result of concerned. The prescribed fee can be paid online through NBEMS website
- Candidates who would fail to qualify the Practical Examination can obtain detailed marksheet of practical examination on submission of a request through Communication Web Portal of NBEMS and on payment of a fee of Rs. 1000/- within 30 calendar days of declaration of practical result of concerned specialty. The prescribed fee can be paid online through NBEMS website.

-
- **Re-evaluation:** There shall be a provision for re-evaluation of unassessed answer(s) only, in a rare event of an answer(s) being wrongly marked as NOT ATTEMPTED by the assessor. Request for re-evaluation of an unassessed answer(s) can be made through Communication Web Portal of NBEMS *within 45 calendar days of the declaration of theory result of the concerned specialty*. An administrative fee of Rs. 500/- per paper shall be charged for the same which can be paid online through NBEMS website.
 - Requests for re-evaluation of an unassessed answer(s) made after 45 calendar days of the declaration of theory result shall not be entertained. There shall be no re-evaluation of already assessed answers.
 - **Provisional Pass Certificate (PPC):** Candidates successful in the practical examination are issued a Provisional Certificate of Passing NBEMS Diploma. Provisional Pass Certificates issued to qualified candidates shall be valid till the NBEMS Final Diploma certificates are conferred upon them in the convocation of National Board of Examinations in Medical Sciences for all purposes, including but not limited to, employment, registration with state medical councils, higher education etc.
 - The PPC issued by NBEMS are bilingual with signed document being issued in the Hindi Language and its English translation is printed overleaf. An authenticate PPC issued on NBEMS letter head shall bear the signatures of issuing authority and a dispatch number. PPC issued to qualified candidates of NBEMS Diploma Final Examinations shall also bear an embossed stamp of NBEMS.
 - No separate certificate for passing theory examination will be issued.
 - Under normal circumstances the certificates of passing (PPC) are issued to the candidates within four weeks of declaration of results, however, due to unforeseen circumstances, this period may vary.

-
- **Duplicate provisional pass certificate:** For issuing a duplicate provisional pass certificate, submit a request letter stating reasons to issue a duplicate certificate, copy of NCR lodged with police authorities clearly mentioning the loss/non-receipt of certificate, affidavit in support of application (attested by public notary/oath commissioner/judicial magistrate), fee of Rs. 1000/- + GST@18% for document upto preceding 3 years and Rs. 2000/- + GST@18% for documents more than 3 years old. The fee can be paid online through NBEMS website.
 - **Academic Transcripts:** Academic transcript of a candidate is released on receipt of a request directly from the concerned authority/ employer/ educational institution, subject to the availability of complete educational records with NEBMS related to NBEMS Diploma training.
 - Candidates are required to furnish copy of PPC issued by NBEMS, the Final Training Completion Certificate issued by the training institution and the letter of registration issued by NBEMS for issuance of transcript. The required documents can be submitted by candidates through Communication Web Portal of NBEMS to process their transcripts.
 - The transcripts are either provided directly to the concerned authority/ employer/ educational institutions or provided to the candidate in a duly sealed envelope to be handed over to concerned authority/ employer/ educational institutions. No fee is charged for issuance of academic transcripts. Academic transcripts are not released on request of candidates.
 - **Attempt Certificate:** NBEMS issues attempt certificates to qualified candidates on receipt of a request from Communication Web Portal with supportive documents. Candidates are required to furnish copy of PPC issued by NBEMS, the Final Training Completion Certificate issued by the training institution and the letter of registration issued

by NBEMS to them along with the document confirming where the said attempt certificate is required to be furnished. No fee is charged for issuance of attempt certificate.

- Candidates are advised not to canvass or approach NBEMS for handing over any of the credentials by hand. All these credentials are dispatched to the correspondence address provided by the candidates in their application form/ in communications submitted through CWP from registered email ID.
- **Verification of Credentials:** NBEMS verifies the credentials (PPC/ Final Certificate etc) issued to qualified candidates on receipt of a request from the concerned authority/ employer/ educational institutions. For any such verification, the candidate concerned is required to pay a verification fee to NBEMS of Rs. 2000/- (plus GST@18%) through online portal for fee payment and a receipt so generated needs to be shared with NBEMS through its Communication Web Portal. The outcome of verification shall be communicated by NBEMS to the authority/ employer/ educational institution concerned directly. Candidates are advised not to canvass for any such third party verifications of their credentials.

5.5. Award of NBEMS Final Diploma Certificates

- Candidates who have qualified both NBEMS Diploma Final Theory & Practical Examinations shall be conferred with NBEMS Final Diploma certificate in the specialty concerned on enrolment for the convocation.

- 7.2. After successful registration and submission of application, candidates can login to their *OEEP* account to check the status of the online application submitted for NBEMS Diploma Final Examinations, any deficiency communicated to them to download the admit cards. *OEEP* can be accessed under Trainees Login >> Exit Examinations. Candidates can login to *OEEP* using the mobile number registered while filling up the online application.
- 7.3. Application for NBEMS Diploma Final Theory Exam can only be submitted online through National Board of Examinations in Medical Sciences website <https://natboard.edu.in> There is no other methodology for application submission. Application submitted through any other mode shall be summarily rejected.
- 7.4. There are two stages in application process which require login through two different web pages:

7.4.1.2. The applicant candidate shall register a user for submission of application. The username and password shall be shared on registered mail ID. A. Register a User - *Online*

If password is lost, it can be retrieved by clicking "*Forgot Your Password*".

- 7.7. If the applicant candidate is a first time user at this portal, click "*Register New User?*"
- **Username/User ID:** Candidates who would register a "New User" will get their system generated username/User ID and password at the email ID provided on completion of profile creation. Application ID is generated after successful submission of an application. Application ID is not the User ID for login purpose.
 - **Name:** Name in your examination application should match with the **name in the Letter of Registration issued by NBEMS:**
 - In an event your name has changed subsequent to getting registered with NBEMS, you can apply in your changed name with documents in supports of changed name such as Gazette notification of change in name, supporting affidavit, Govt issued ID proof in changed name etc. NBEMS may require

C. Pay Examination Fee

7.12.**Payment of Fee:** The candidate shall be required to make requisite payment of prescribed examination fee online.

7.13.After successful payment of required fee, the process of submission of the application of the candidate shall be completed. The status of payment must be reflected as “Payment Success” else the candidate may be required to complete the payment again for successful submission of application.

7.14.**Acknowledgement of Online Application Submission:** An acknowledgement email shall be sent for receipt of online NBEMS Diploma Final Examinations Application at NBEMS. The acknowledgement shall bear an **Application Form ID**. Please preserve this form ID for future correspondence with National Board of Examinations in Medical Sciences regarding application.

D. Quick Links on Online Portal:

7.16. **Mobile OTP based login:** The candidate shall be able to login to *Online Exit Examinations Portal* using the OTP sent at their registered mobile number.

7.17. **Status of Application:** The applications submitted by the candidates can be tracked through *Online Exit Examinations Portal* (OEEP) for status of application processing. Updated processing status of application submitted shall be reflected on the portal.

7.18. Candidates who are issued admit card by NBEMS shall be able to download the admit card/other communications through *Online Exit Examinations Portal*. Admit card can also be downloaded from the Application link used for submission of application.

10.4. Under normal circumstances leave of one year should not be carried forward to the next year. However, in exceptional cases such as prolonged illness, the leave across the NBEMS Diploma training program may be clubbed together with prior approval of NBEMS.

10.5. Unauthorized absence from NBEMS Diploma training for more than 7 days may lead to cancellation of registration and discontinuation of the NBEMS Diploma training and rejoining shall not be permitted.

10.6. Any Leave availed by the candidate other than the eligible leave (30 days per year) shall lead to extension of Diploma training. The training institute has to forward such requests to NBEMS along with the leave records of the candidate since his/her joining and supporting documents (if any) through the Head of the Institute

with their recommendation/comments. NBEMS shall consider such requests on merit provided the seat is not carried over and compromise with training of existing trainees in the Department.

10.7. Any extension of NBEMS Diploma training beyond the scheduled completion date of training is permissible only under extra-ordinary circumstances with prior approval of NBEMS. Such extension is neither automatic nor shall be granted as a matter of routine.

10.8. NBEMS Diploma trainees are required to complete their training by a prescribed cutoff date (as per information bulletin of Exit exam) for being eligible to NBEMS Diploma Final examination.

10.9. The eligibility for NBEMS Diploma Final Examination shall be determined strictly in accordance with the criteria prescribed in the respective information bulletin.

10.10. Updates, if any, in the NBEMS leave rules may be referred to at NBEMS website

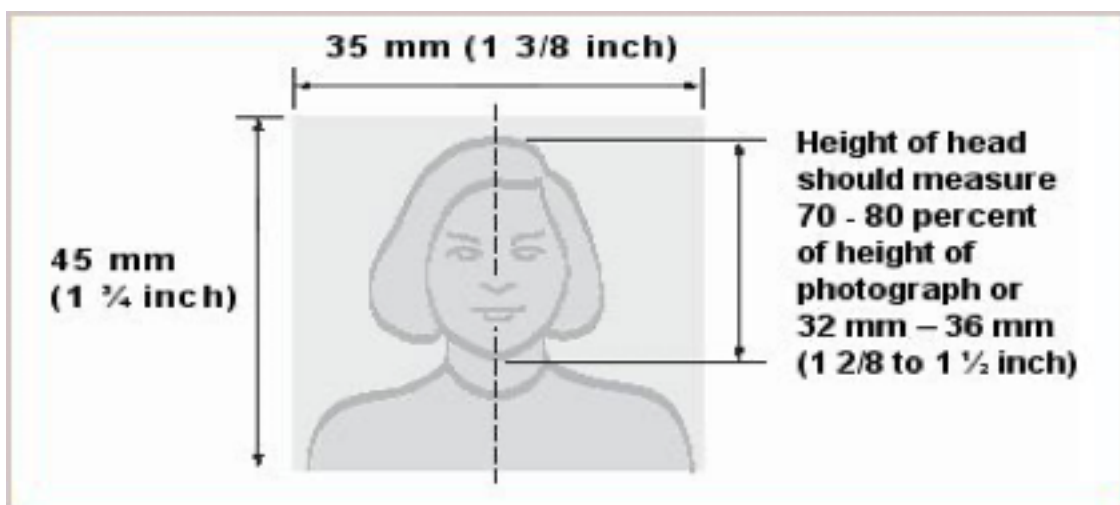
