Out of these seats 5% of Seats are reserved for PWD candidates on horizontal reservation as per Government Rules which will be earmarked after Registration gets completed.


Likewise, 2% reservation for WESM Candidates is also applicable as per Government of Tripura Reservation rules which also earmarked after Registration gets completed.



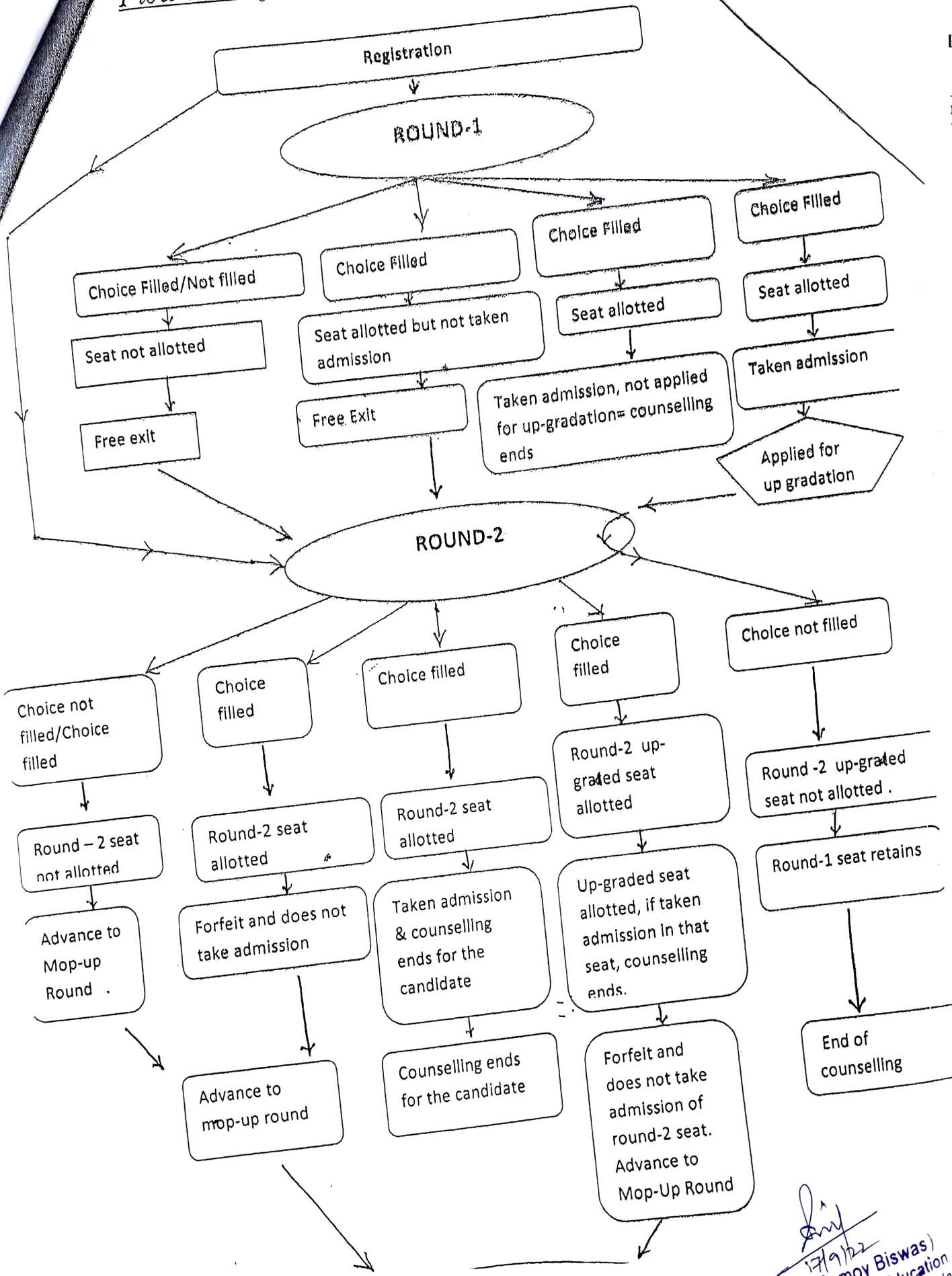

GENERAL INSTRUCTIONS AND PROCEDURAL DIRECTIVES

1. All the applicants shall strictly follow the instruction given in the Information Bulletin while applying for different Post Graduate Degree/Diploma Courses. Incomplete application shall be rejected.
2. Last date of submission of application/registration/choice filling/getting nominations from Directorate of Medical Education, Govt. of Tripura and admission to allotted Institution shall be as per Scheduled date and time.
3. Submission of incorrect or false statements/documents or suppression of material/information in the Application Form will be considered as sufficient ground for cancellation of the candidature or the admission of candidates to a Post Graduate Medical Course whenever detected, i.e. during the process of admission or even at any state thereafter.
4. The candidate allotted a seat in the Online allotment of Counselling shall have to attend at the office of the Director of Medical Education for Online verification of eligibility & others which will be examined by AGMC verification Team and following successful verification, Nomination from Director of Medical Education will be issued against that candidate as per scheduled date. The In-service candidate shall have to submit appropriate certificates in online submission of documents and original certificates during physical verification which will be held in the admitting Institutions during his/her admission against an allotted and nominated seat. All the original relevant documents will be physically verified finally by admitting Institutions & following successful verification of all original documents in respect of eligibility of a candidate & satisfying all admission formalities he/she shall be considered for admission.
5. Candidates selected for admission through common Counselling shall be nominated by the Directorate of Medical Education, Govt. of Tripura for reporting to the Principal of the allotted College.
6. The nominated candidate by the DME shall report to the Principal of the allotted Colleges within the specified time.
7. If a candidate does not report to the Principal of the allotted Colleges for admission in the PG Courses within the stipulated date his/her claim for the said PG Course shall stand cancelled against the PG seat.
8. Candidate who has not completed his/her one year Rotatory Internship Training after the MBBS Course on or before 30th May, 2022 is not eligible to apply.
9. No personal communication will be made with the candidates.
10. Admission of the selected In service candidate shall be in accordance to the relevant Government order (release report).
11. PG Degree Seat Matrix will be displayed at the time of Counselling.
12. Notification regarding Counselling of PG Courses for admission to the Medical College in the State of Tripura or outside of Tripura with Seat Matrix, shall be published in the website of Director of Medical Education, Govt. of Tripura (www.dme.tripura.gov.in) inviting application in the prescribed Format on or before a stipulated time as mentioned by the Common Counselling Committee authority. Steps of Counselling & amount of Security deposit for the 2nd round of Counselling would be furnished in the website of Director of Medical Education, Govt. of Tripura.
13. Fees for admission in the PG Course shall be available in the website of concerned College which shall be paid by the nominated candidate to the College authority during the time of admission.
14. Aspirant Candidates are instructed to visit Directorate of Medical Education website (www.dme.tripura.gov.in) regularly for any modification of any content/addition/delete of any Clause /content and further Educational Notification issued time to time.
