Pocket-14, Sector-8, Phase-I, Dwarka, New Delhi-110 077, do

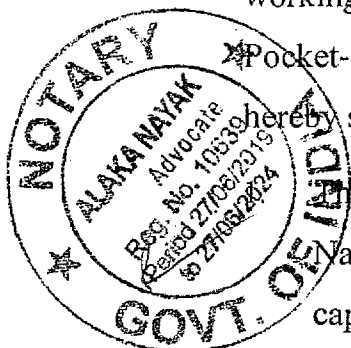
hereby solemnly declare as under:-

National Medical Commission and as such in my official
capacity I am acquainted with the facts and circumstances of
the present case and thus competent and authorized to swear
and depose this reply affidavit to the writ petition.

- It is submitted that the present additional affidavit is being filed in compliance of order dated 22.07.2022 as passed by this Hon'ble Court. The relevant portion of the order dated 22.07.2022 as passed by this Hon'ble Court is reproduced as under :-

“.....

1. Ms. Monica Arora, learned Standing Counsel appearing for the Union of India submits that certain directions were issued to the National



Medical Commission by decision dated 03.01.2022 and as per her instructions the National Medical Commission has agreed to abide by the same.

2. Mr. Singhdev, learned counsel appearing for National Medical Commission prays for time to place on record the decision of the National Medical Commission, vis-a-vis, the regulation under challenge in these proceedings.

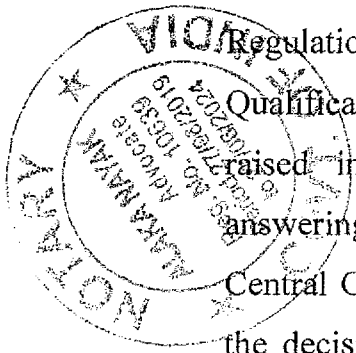
3. National Medical Council shall file an affidavit indicating its stand in terms of the directions issued by the Central Government by its decision dated 03.01.2022 as also the stand qua the regulation under challenge.

4. In view of the above, renotify on 01.09.2022. 5. Interim orders in W.P. (C) No. 10633/2020 & W.P. (C) No. 9115/2020 shall continue till the next date of hearing.

3. It is respectfully submitted that in so far as, the challenge to the Minimum Requirements for Annual MBBS Admissions Regulations, 2020 and / or the Teachers Eligibility Qualifications in Medical Institutions Regulations, 2022 as raised in the present writ petition is concerned, the answering respondent after due consultation with the Central Govt. in various meetings, has decided to abide by the decision of the Central Government as communicated vide order dated 03.01.2022. The Central Govt. vide its order dated 03.01.2022, has decided that the answering respondent may continue to adopt the old pattern of permissible percentage of non-medical teachers for the time being subject to the outcome of the various writ petitions pending adjudication before this Hon'ble Court.

4. It is further humbly submitted that the answering respondent in respect of the challenge to the Minimum Requirements for Annual MBBS Admissions Regulations, 2020 and / or the Teachers Eligibility Qualifications in Medical



Institutions Regulations, 2022 shall follow the stand of the Central Govt. and also adopt the arguments of the Central Govt. in this regard.

5. It is respectfully submitted that the aforesaid facts and circumstances have been set out for the kind consideration of this Hon'ble Court. The answering respondent prays accordingly.

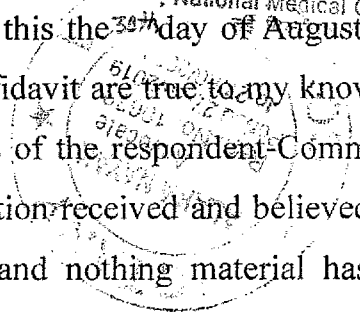
