In view of Hon'ble Supreme Court order in W. P. No. 824 of 2024, dated 20/12/2024. It has now been decided to open the portal to fill up online details of 1st year MBBS course admitted students for the academic year 2024-25. The portal for submitting the required details will be open until **28/02/2025**. NMC Portal was earlier opened up to 10/12/2024 for seeking the admission details carried out by medical colleges.
