PUBLIC NOTICE

Subject: Pending applications with initiators (applicants only)- regarding

It is notified about the recent scrutiny process of applications received for eligibility certificates (**Annexure-I** for issuance of eligibility certificate have been pending with the applicants). EMRB, NMC has diligently reviewed the applications submitted by various applicants. After careful evaluation, we have identified some deficiencies in above mentioned in applications at **Annexure-I**.

2. In this connection, attention is invited to section 13(4B) Indian Medical Council Act, 1956, it is stated that:-

“(4B) A person who is a citizen of India shall not, after such date as may be specified by the Central Government under sub-section (3), be eligible to get admission to obtain medical qualification granted by any medical institution in any foreign country without obtaining an eligibility certificate issued to him by the Council and in case any such person obtains such qualification without obtaining such eligibility certificate, he shall not be eligible to appear in the screening test referred to in sub-section (4A): Provided that an Indian citizen who has acquired the medical qualification from foreign medical institution or has obtained admission in foreign medical institution before the commencement of the Indian Medical Council (Amendment) Act, 2001 shall not be required to obtain eligibility certificate under this sub-section but, if he is qualified for admission to any medical course for recognized medical qualification in any medical institution in India, he shall be required to qualify only the screening test prescribed”

3. The requirement of taking an Eligibility Certificate before proceeding abroad has been dispensed w.e.f the declaration of result of NEET-UG 2019 vide public notice dated 05.04.2019 (copy enclosed for ready reference) and accordingly after 05 June 2019, qualifying NEET-UG Exam has been made mandatory and shall be deemed to be treated as an Eligibility Certificate for Indian/OCI citizen intending to take admission in MBBS or equivalent Medical Course in any Foreign Medical Institution.

4. It is observed that applicants whose name is mentioned in **Annexure-I** have proceeded abroad without obtaining an Eligibility Certificate. Therefore, it has been decided by the Board to give 10 days time to all such applicants (**Annexure-I**) to submit their applications in the eligibility portal of NMC. In case, the applicants whose name is mentioned in Annexure-I do not fulfill the deficiency or do not submit the applications within 10 days from the date of publication of this notice the applications will be summarily rejected.

**Board of Governors in Supersession of
Medical Council of India

PUBLIC NOTICE

This is to inform all concerned that the Medical Council of India (MCI) with the prior approval of the Government of India, Ministry of Health & Family Welfare, New Delhi had made Amendments in the "Screening Test Regulations, 2002" and "Eligibility Requirement for Taking Admission in an Undergraduate Medical Course in a Foreign Medical Institution Regulation, 2002" vide Notifications dated 1st March, 2018, for the requirement of National Eligibility cum Entrance Test (NEET) in respect of the Indian Citizen/Overseas Citizen of India who are desirous for taking admission in MBBS or its equivalent medical course in a medical University/College/Institute outside the country on or after May, 2018.

Subsequently, as per Public Notice dated 14th September, 2018 issued by the Medical Council of India and Order dated 27/09/2018 passed by the Hon'ble High Court of Delhi at New Delhi in WP(C)No.8091/2018 and connected matters, Indian Citizens/OCI who had not registered/appeared/qualified NEET 2018, were allowed to take admission in MBBS or equivalent medical course in a medical University outside the country in the academic year 2018-19.

In reference to the Notification dated 1st March, 2018 and Public Notices issued by the Medical Council of India from time to time, representations from various sources were received seeking clarification regarding qualifying NEET at the time of admission in Doctor of Medicine course at Philippines, last date of admission in MBBS or equivalent medical course without qualifying NEET 2018 etc.

Accordingly, the matter was considered by the Board of Governors (BoG) and it is clarified as under:-

- i) The candidates who have qualified NEET from 2019 onwards and leave the country for pursuing pre-medical/language course will not be required to qualify NEET again at the time of their actual admission in MBBS or equivalent medical course in subsequent year(s) after completion of pre-medical/language course.
- ii) Candidates who qualify NEET once, his/her NEET score shall be valid for a period of three (3) years from the date of declaration of result. Such candidates shall be entitled to pursue MBBS or

equivalent medical course including pre-medical/language course, if any, followed by MBBS or equivalent medical course.

- iii) Indian Citizens/OCI who have not qualified NEET-2018 and/or registered in NEET-2018 and intending to take admission in MBBS or equivalent medical course in foreign medical institutions are exempted until the declaration of NEET-2019 result which is scheduled to be declared on 5th June, 2019. However, such candidates have to obtain an eligibility certificate from the Medical Council of India u/s 13(4B) of the IMC Act, 1956.
- iv) Indian Citizens/OCI intending to take admission in MBBS or equivalent medical course in foreign medical institutions after declaration of NEET 2019 results can proceed abroad for acquiring primary medical qualification only on qualifying NEET.
