Removal of names of Dr. Muzaffar Ahmad (Registration No. 14680/ 2017), Dr. Adeel Ahmad Rather, (Registration No. 15892/ 2019) and Dr. Muzamil Shakeel, (Registration No. 15130/ 2018) from IMR/NMR.

Whereas an FIR No. 162/2025 at P/S Nowgam, Srinagar, U/s 13, 16, 17, 18-B, 19, 20, 23, 39, 40 UAPA Section 61(2), 147, 148, 152, 351(2) BNS, 4/5 Explosive Substance Act 7/25/27 Arms Act, dated 19.10.2025 has been registered.

And whereas Dr. Muzaffar Ahmad (Registration No. 14680/ 2017), Dr. Adeel Ahmad Rather, (Registration No. 15892/ 2019) and Dr. Muzamil Shakeel, (Registration No. 15130/ 2018) registered with the Jammu & Kashmir Medical Council have been found to be involved in the above referenced case on the basis of evidence collected by the investigating agencies.

And whereas, such association or conduct is prima facie inconsistent with the standards of ethical propriety, integrity and public trust expected of members of the medical profession and attracts the provisions of Clause 1.1.1 and 1.1.2 of Chapter 1 of the Indian Medical Council (Professional Conduct, Etiquette and Ethics) Regulations, 2002.

And whereas, in exercise of the powers conferred under V(2) of Terms of Reference of S.O. 362 dated 2010.2021, the Jammu & Kashmir Medical Council have ordered cancellation of registration of Dr. Muzaffar Ahmad (Registration No. 14680/ 2017), Dr. Adeel Ahmad Rather, (Registration No. 15892/ 2019) and Dr. Muzamil Shakeel, (Registration No. 15130/ 2018) with directions that their names be removed from the Register of Medical Practitioners maintained by the Council with immediate effect. Consequent upon such removal, the said practitioner shall cease to be entitled to practice medicine or to hold any appointment as a medical practitioner till further orders.

Now, therefore, in view of the Notifications dated 13.11.2025 regarding cancellation of registration of above mentioned doctors issued by the Jammu & Kashmir Medical Council, their names be removed from the IMR/NMR with immediate effect.

Whereas an FIR No. 162/2025 at P/S Nowgam, Srinagar, U/s 13, 16, 17, 18-B, 19, 20, 23, 39, 40 UAPA Section 61(2), 147, 148, 152, 351(2) BNS, 4/5 Explosive Substance Act 7/25/27 Arms Act, dated 19.10.2025 has been registered.

And whereas Dr. Shaheen Saeed (Registration No. 45961/ 2022) registered with the Uttar Pradesh Medical Council has been found to be involved in the referenced case on the basis of evidence collected by the investigating agencies.

And whereas, such association or conduct is prima facie inconsistent with the standards of ethical propriety, integrity and public trust expected of members of the medical profession and attracts the provisions of Clause 1.1.1 and 1.1.2 of Chapter 1 of the Indian Medical Council (Professional Conduct, Etiquette and Ethics) Regulations, 2002.

Now, therefore, name of Dr. Shaheen Saeed (Registration No. 45961/ 2022) be removed from the IMR/NMR with immediate effect.
