In continuation to the previous notice dated 28.03.2023, the allotment of eligible candidates for admission to 10 additional PG (Hom.) seats in NHRIMH, will be published at the institute's website (<https://nhrimh.ac.in>) on 31.03.2023.

**Further, the short listed candidates will be invited physically for document verification and admission proceedings on 03.04.2023.**

Furthermore, eligible short listed candidates are requested to produce all the **ORIGINAL DOCUMENTS** mentioned in Q. No. 24 of Information Bulletin, Counseling Scheme & FAQs available on AACCC-PG portal for successful completion of document verification and admission process.

In this regard, it is pertinent to mention that if any candidate **fails to produce the original relevant documents at the time of the physical reporting on 03.04.2023 at the NHRIMH, Kottayam, Kerala, the seat allotted to the candidate will liable to be cancelled and candidate cannot claim for that seat.**

### **NOTE**

- Candidates without original certificates/documents shall not be allowed to take admission on Spot Round.
- Candidates who have submitted their original documents with any other Institute /College /University and come for admission with a certificate/undertaking stating that "original certificates are deposited with the Institute/College/University" shall not be allowed to take admission.
