INSTRUCTIONS TO CANDIDATES

Procedure of Personal Counseling Round for NEET-PG-CPS 2021

- All the desirous candidates who are eligible as per the rules should attend the
 personal Counseling round IN PERSON (PROXY WILL NOT BE PERMITTED) according
 to the above schedule. The candidates are instructed to report to the counseling
 centre half an hour before the above mentioned schedule. If any candidate reaches
 late to the counseling centre, he will be considered eligible for the seats available at
 that time only.
- 2. As per rule no 8.2 of NEET-PG-CPS 2021 Information Brochure, the candidates should bring all the original documents and one set of self-attested Xerox copies of the same for verification at the Personal Counseling Centre.
- 3. The list of "ELIGIBLE" candidates for the Personal Counseling round will be published on the website on 08/07/2022 as per schedule. Those candidates who are registered for NEET PG-CPS 2021 and having "Not Admitted" status as on 06/07/2022 upto 6:00 p.m. will be eligible for personal counseling Round.
- 4. All those candidates joined during CAP 1st round / 2nd round and Mop up round in Govt. / Corporation / Govt. aided / Private unaided / Minority Medical Institutes and having "Admitted" status as on 06/07/2022 upto 6:00 p.m. are "NOT ELIGIBLE" to participate in Personal Counseling Round.
- 5. For admission by personal counseling, preference forms submitted previously by all the registered eligible candidates will not be considered and same shall be treated to have been cancelled. In other words, this final personal counseling round shall not be conducted on the basis of choices given in preference forms submitted by the candidate previously.
- 6. The personal counseling will be held strictly in order of merit i.e. CPS SML number. Each candidate will be offered all seats that are vacant and are available for allotment at the time of his/her turn of counseling.
- 7. In this round, allotment shall be made on the basis of choice made on the spot by the candidate at the time of personal counseling appearance.
- 8. Allotment of seat once made in this personal counseling round, shall not be changed and / or cancelled at any count whatsoever. Therefore, while giving the choice on spot at the time of this personal counseling round, the candidates must consider the available seats thoroughly and opt for a seat which they must join once allotted.

- 9. During personal counseling round process, the allotted candidate list and seats remained vacant at the end of the each day's process will be displayed on the website of DMER i.e. www.med-edu.in.
- 10. The rule of inter-se will be strictly followed if any reserve category seat remains unfilled. Please refer Annexure "D" Page No. 31 to 33 of NEET-PG-CPS 2021 Information brochure.
- 11. A candidate if allotted any seat in personal counseling round, he/she will not be considered for Inter-se round if any.
- 12. Once a seat is allotted during Personal Counseling round, the candidate should report to the allotted institute to join and complete the all necessary formalities by submitting all his/her original documents along with payment of requisite fees in the form of Demand Draft within the prescribed time limit.
- 13. It is the sole responsibility of the candidate to submit all his original documents and requisite fees to the allotted institute within the prescribed time limit.
- 14. The admission process will be completed before Cut-off date prescribed for CPS course that is declared by The Competent Authority. The cut-off date for admission to NEET-PG-CPS 2021 course is 6:00 p.m. on 21/07/2022 (Last date of joining at the allotted Institute). After cut-off date no admission will be done by any Authority.
- 15. If any candidate resigns the from the seat allotted through NEET-PG-CPS 2021 admission process after the cut-off date i.e. 21/07/2022 as per Rule No. 14 of Information Brochure, there will be no refund of fees and such candidates will have to pay entire course fee as penalty.
