The Directorate General of Health Services medical Counselling Committee, Govt. of India (Office of MCC) New Delhi has reduced the qualifying percentile for admission to NEET PG 2023 and NEET MDS 2023 as per above referred letter.

In this regard, it is informed that candidates who have become eligible after reduction of percentile can register and participate in CAP Round-3 of counselling. The revised qualifying criteria for NEET PGM 2023 and NEET MDS 2023 will be as follows.

Note : For ensuring faithful obedience of time schedule and also keeping in view the limited time available for conducting counselling, all participating institutes/ colleges are directed to treat all Saturdays/ Sundays and Gazetted Holidays as working days.

NOTE :

- 1) Candidate will be allowed to fill preferences of Government/ Corporation/ Government Aided / Unaided Private and Minority Institutions depending upon the deposit amount the candidate has paid during registration.
- 2) Candidates interested in participating CAP Round - III must fill online preference form. The preferences filled during CAP Round - I & II will be NULL & VOID.
- 3) **As per MCC information brochure candidates JOINED in All India Round 3 shall not be eligible for State counselling CAP Round 3. Candidates should take note of the same.**
- 4) **Candidates allotted a seat through State counselling Round 3 will have to JOIN the allotted seat and they will not be eligible for any subsequent round(s).**
- 5) **Similarly, data of Joined candidates of CAP Round 3 will be shared with MCC for further process and such candidates will not be eligible for any subsequent round(s) of any counselling.**
- 6) The Filling of Status Retention form is choice of the candidate. However, Status retention form once filled cannot be taken back. Hence, candidates should be careful while filling the status retention form.
- 7) Fee payment through Cheque is allowed on Sunday & Bank Holidays. However, they have to be replaced with DD immediately on the next working day.
- 8) Candidates cancelling admission after 30/09/2023 will not be eligible to participate in any subsequent round(s) of State Counselling.
- 9) The prescribed date to cancel admission without penalty as per Information Brochure will be published in due course.
