## NOTICE

Kind Attention to all candidates participating in AACCC PG-Counseling for the A.Y 2022-23.

As per the direction in the Court order dated 21.03.2023 of the Hon'ble High Court of Kerala in the W.P. (C) No. 4966 of 2023, 10 AIQ (Homoeopathy) -PG seats (Psychiatry- 05 seats and Practice of Medicine- 05 seats) added to the existing PG Programs of National Homoeopathy Research Institute in Mental Health(NHRIMH), Kottayam, Kerala.

AACCC- PG counseling for the A.Y. 2022-23 was completed on 23.03.2023, in view of which the Ministry of Ayush has decided to direct NHRIMH, Kerala, to conduct counseling for admission to additional 10 AIQ (Homoeopathy) PG seats at institute level.

Eligibility criteria for registration on the AACCC-PG portal for admission to 10 additional seats

1. New registration is available only for those candidates who have not been admitted to any Homoeopathy PG seats through AACCC /State-UT -PG counseling for the A.Y. 2022-23. Further, candidates are requested to select 'Central Universities/National Institutions' as 'Counseling type' while registering on the AACCC-PG Portal.
2. Candidates registered during Round-1, Round $2 \& 3^{\text {rd }} /$ Mop-up Round of counseling on the AACCC-PG Portal and have not been allotted any (Homoeopathy) -PG seats through any Rounds of AACCC-PG counseling and not selected counseling type Central Universities/National Institutions during registration for AACCC-PG counseling are requested to avail the facility of 'Registration Unlocking' on the AACCC-PG portal on 27.03.2023 (as per schedule) and select Counseling Type as 'Central Universities/National Institutions', then only they are eligible to participate.

Criteria for participating in the counseling for admission to additional 10 AIQ
(Homoeopathy) -PG seats, at the institute level.

1. Candidates registered during Round-1, Round $2 \& 3^{\text {rd }} /$ Mop-up Round of counseling on the AACCC-PG Portal and have not been allotted any (Homoeopathy) -PG seats through 04 Rounds of AACCC-PG counseling, are eligible to participate.
2. Candidates who freshly registered on the AACCC-PG portal on 27.04.2023 are eligible.
3. Candidates who secured any (Homoeopathy) -PG seats through State/UT counseling for the A.Y 2022-23 are ineligible to participate.

Writ petition (civil) praying inter alia that in the circumstances stated in the affidavit filed along with the WP(C) the High Court be pleased to direct the respondent No. 5 to grant conditional approval to all the 25 seats of PG Course (as mentioned in Exhibit P2) at the 4th respondent Institute, pending disposal of the Writ Petition (Civil).

This petition again coming on for admission upon perusing the petition and the affidavit filed in support of WP(C) and this Court's order dated 27/02/2023 and upon hearing the arguments of M/S.LIJI.J.VADAKEDOM, TOM E. JACOB, REXY ELIZABETH THOMAS \& ATHUL V. VADAKKEDOM, Advocates for the petitioner, SRI.S.MANU, DEPUTY SOLICITOR GENERAL OF INDIA for R1, SRI.P.SREEKUMAR, STANDING COUNSEL for R5 and of SRI.K.S.PRENJITH KUMAR,CENTRAL GOVERNMENT COUNSEL for R4 \& Addl.R6 ,the Court passed the following:

## ORDER

The $5^{\text {th }}$ respondent University refused to grant affiliation to 10 out of 25 seats in the $4^{\text {th }}$ respondent College for the reason that, the College did not have regular and qualified teaching staff as mandated under the Central Council Regulations.
2. The additional $6^{\text {th }}$ respondent - the Central Council for Research in Homoeopathy, has filed an affidavit dated 09-03-2023 with regard to the above. The relevant portion of the affidavit reads thus :

> "... The CCRH undertakes that all possible efforts will be made to ensure that the appointment of regular teaching staff is materialized in the National Homeopathy Research Institute in
Mental Health,
Sachivothamapuram, Kottayam
by the end of the year 2023."
3. The learned Standing counsel for the University submits that, in the light of the undertaking as above and also in view of the fact that as of now the existing temporary faculty is sufficient to meet the immediate requirements, the University is willing to grant affiliation to the remaining 10 seats.
4. Taking note of the facts as above it is ordered that the needful shall be done by the University forthwith.
5. On orders of affiliation being issued by the University, the $1^{\text {st }}$ and $2^{\text {nd }}$ respondents shall take note of the fact that, out of the 25 seats in the College, allotment to 15 seats is already over and that the remaining 10 seats would practically amount to additional seats.
